- 1 (D) (1) THE PROHIBITIONS ESTABLISHED UNDER SUBSECTION (A) OF 2 THIS SECTION APPLY FROM THE DATE OF ISSUANCE OF THE FIRST INVITATION FOR 3 BIDS OR REQUEST FOR PROPOSALS FOR WHICH THE SPECIFICATIONS WERE 4 INITIALLY DRAFTED UNTIL THE LATER OF:
  - (I) 2 YEARS FROM THE DATE OF ISSUANCE; OR

  7 IN RESPONSE TO THE ISSUANCE OF THE INVITATION FOR BIDS OR REQUEST FOR
