A BILL

To provide for enhanced penalties for certain offenses relating to controlled substances containing fentanyl, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Help Ensure Lives
- 5 are Protected Act of 2019" or the "HELP Act of 2019".

- 11 able amount of heroin also contains a detectable amount
- 12 of N-phenyl-N-[1-(2-phenylethyl)-4-piperidinyl]
- 13 propanamide or any analogue of N-phenyl-N-[1-(2-
- 14 phenylethyl)-4-piperidinyl] propanamide, and if death or
- 15 serious bodily injury results from the use of such sub-
- 16 stance, such person shall be sentenced to life imprison-
- 17 ment or death.
- 18 "(9) In the case of a violation of subsection (a) in-
- 19 volving a mixture or substance in an amount of 100 grams
- 20 or more, if the mixture or substance containing a detect-
