3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Critical Habitat Im-

5 provement Act".

1	SEC. 2. REQUIREMENTS FOR CRITICAL HABITAT DESIGNA-
2	TION.
3	(a) Definition of Critical Habitat.—Section
4	3(5) of the Endangered Species Act of 1973 (16 U.S.C.
5	1532(5)) is amended—
6	(1) by amending subparagraph (A) to read as
7	follows:
8	"(A) The term 'critical habitat' for a
9	threatened species or endangered species
10	means—
11	"(i) the specific areas of habitat with-
12	in the geographical area occupied by the
13	species, at the time such species is listed in
14	accordance with the provisions of section 4
15	of this Act, that the Secretary determines
16	have physical or biological features that—
17	"(I) are essential to the conserva-
18	tion of such species; and
19	"(II) may require special man-
20	agement consideration or protection;
21	or
22	"(ii) the specific areas of habitat out-
23	side the geographical area occupied by the
24	species, at the time such species is listed in
25	accordance with the provisions of section 4

1	of this Act, that the Secretary deter-
2	mines—
3	"(I) are essential for the contin-
4	ued survival of such species;
5	"(II) are able to sustain occu-
6	pancy by such species at the time of
7	the determination described in this
8	clause; and
9	"(III) have physical or biological
10	features that—
11	"(aa) are essential to the
12	conservation of such species; and
13	"(bb) may require special
14	management consideration or
15	protection."; and
16	(2) by adding at the end the following:
17	"(D) Identification of features.—In mak-
18	ing a critical habitat designation under section
19	4(a)(3)(A)(i), the Secretary shall identify with speci-
20	ficity the constituent elements of any physical or bio-
21	logical features that form the basis for such designa-
22	tion.".
23	(b) Priority for Designating Critical Habi-
24	TAT.—Section 4(a)(3) is amended at the end by adding

"(C) PRIORITY FOR DESIGNATING CRIT ICAL HABITAT.—The Secretary may not des ignate habitat outside the geographical area oc cupied by the species as critical habitat unless
such designation is necessary to ensure the con tinued survival of such species.".
