Correctional Officers' Retirement System - Membership

3 FOR the purpose of altering the membership of the Correctional Officers' Retirement 4 System to include certain individuals serving in certain positions in the Department 5 of Juvenile Services; providing for the calculation of a certain benefit from the 6 Correctional Officers' Retirement System for individuals serving in certain positions 7 on or before a certain date; requiring the State Retirement Agency, on or before a 8 certain date, to notify certain individuals affected by this Act of their right to transfer 9 service credit to the Correctional Officers' Retirement System; providing for the application of this Act; requiring a certain transfer and combination of certain 10 11 service credit for certain individuals; requiring the Board of Trustees for the State 12 Retirement and Pension System to calculate a certain disability benefit for certain 13 individuals and to grant a certain benefit under certain circumstances; and generally 14 relating to membership in the Correctional Officers' Retirement System.

- 7 If an individual described under subsection (a) of this section is granted an (c) 8 ordinary disability benefit under Title 29, Subtitle 1 of the State Personnel and Pensions 9 Article, the Board of Trustees for the State Retirement and Pension System shall calculate the ordinary disability benefit under §§ 29-106 and 29-108 of the State Personnel and 10 Pensions Article and grant the greater benefit to the individual.
