- 17 (B) THIS SECTION APPLIES TO A CONTROLLED WATER SKI AREA LOCATED 18 IN MAYNADIER CREEK.
- 19 (C) (1) A PERSON MAY OPERATE OR GIVE PERMISSION TO OPERATE A
- 20 VESSEL FOR THE PURPOSE OF TOWING A WATER SKIER IN A SKI SLALOM COURSE
- 21 LOCATED IN A CONTROLLED WATER SKI AREA ON MONDAYS, TUESDAYS,
- 22 WEDNESDAYS, THURSDAYS, AND FRIDAYS BETWEEN 6:00 A.M. AND 8:30 P.M.
- 23 (2) A PERSON MAY NOT OPERATE OR GIVE PERMISSION TO OPERATE
- 24 A VESSEL FOR THE PURPOSE OF TOWING A WATER SKIER IN A SKI SLALOM COURSE
- 25 LOCATED IN A CONTROLLED WATER SKI AREA ON:
- 26 (1) SATURDAYS, SUNDAYS, AND STATE HOLIDAYS; AND
- 27 **(2)** Mondays, Tuesdays, Wednesdays, and Thursdays before 28 Noon and After 8:30 p.m.
- SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect 30 October 1, 2017.
