4 FOR the purpose of prohibiting certain owners of a cemetery from selling or transferring 5 the cemetery without the approval of the Director of the Office of Cemetery 6 Oversight; exempting a certain cemetery owner from the requirement to obtain an 7 approval from the Director; authorizing a governmental unit to acquire an 8 abandoned cemetery under certain circumstances; establishing certain requirements 9 for the sale, transfer, or government acquisition of a cemetery; and generally relating 10 to the sale, transfer, or acquisition of cemeteries.
