USE OF HARBOR MAINTENANCE TRUST FUND TO 2 SUPPORT NAVIGATION. 3 Section 210 of the Water Resources Development Act 4 of 1986 (33 U.S.C. 2238) is amended— 5 (1) in the section heading, by striking "AU-6 THORIZATION OF APPROPRIATIONS" and insert-7 ing "FUNDING FOR NAVIGATION"; and 8 (2) by adding at the end the following: 9 "(g) Adjustments to Discretionary Spending LIMITS.—Amounts made available from the Harbor Main-10 tenance Trust Fund under this section or section 9505 11 of the Internal Revenue Code of 1986 shall be made avail-12 able in accordance with section 251(b)(2)(G) of the Bal-13 14 anced Budget and Emergency Deficit Control Act of 1985.". 15 16 SEC. 3. 14	is amended by adding at the end the following:

17	"(i) IN GENERAL.—If a bill or joint
18	resolution making appropriations for a fis-
19	cal year is enacted that specifies an
20	amount for harbor maintenance activities,
21	then the adjustments for that fiscal year

24	but may not exceed the total amount with-
25	in the Harbor Maintenance Trust Fund

- under subsection (a) of section 9505 of the 1 2 Internal Revenue Code of 1986 on the last 3 day of the fiscal year that is two years prior to that fiscal year. 4 "(ii) LIMITATION.—The adjustment 5 under clause (i) with respect to an amount 6 7 made available for harbor maintenance aconly 8 tivities may be made if such 9 amount-"(I) is derived solely from funds 10 in such Trust Fund; and 11 "(II) is made available for ex-12 13 penditures described under subsection 14 (c) of such section 9505.".
