"(vi) The device utilizes technology 16 17 that prevents the running of software on 18 the device that does not meet the require-19 ments of clause (v). "(vii) The device utilizes technology 20 21 that enables election officials, cybersecurity 22 researchers, and voters to verify that the 23 software running on the device—

"(I) was built from a specific,
untampered version of the code that is
