3 **Grievances, and ~~Entrance Fees~~ Unit Reoccupancy**

4 FOR the purpose of ~~altering the membership of governing bodies of continuing care~~
5 ~~retirement communities by increasing the number of subscribers under certain~~
6 ~~circumstances~~ requiring a provider to post the provider's most recent disclosure
7 statement on the provider's website; altering the number of times ~~select committees~~
8 of certain providers are required to ~~meet with~~ hold a meeting open to all of the
9 provider's subscribers each year; requiring an authorized officer of a provider to
10 provide a summary of certain grievance information at certain meetings; authorizing
11 a subscriber member of a governing body to report on certain nonconfidential
12 information; requiring the Department of Aging to collect certain information about
13 certain internal grievances; ~~altering the processes for the termination of a continuing~~
14 ~~care agreement under certain circumstances; altering the process for refunding~~
15 ~~certain entrance fees under certain circumstances; requiring a provider to submit~~
16 certain reports to a subscriber or a subscriber's beneficiary if the subscriber's unit
17 has not been reoccupied within certain periods of time; and generally relating to
18 continuing care retirement communities.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 16 That the Laws of Maryland read as follows:

2 ~~(b) (3) A capital improvement or replacement that does not meet the standard~~
3 ~~of [§ 10-401(w)] § 10-401(x) of this subtitle is not subject to review by the Department~~

6 (a) (1) A provider shall give without cost a disclosure statement for each
7 facility for which the provider holds a preliminary, initial, or renewal certificate of
8 registration:

9 (i) to a prospective subscriber before the earlier of payment of any
10 part of the entrance fee or execution of a continuing care agreement; and

11 (ii) annually to any subscriber who requests a disclosure statement.

12 (2) A provider shall submit its initial disclosure statement to the
13 Department for review at least 45 days before giving the statement to any prospective
14 subscriber.

15 (b) (1) A provider shall revise the disclosure statement annually and file it
16 with the Department within 120 days after the end of the provider's fiscal year.

17 (2) The Department shall review the disclosure statement solely to ensure
18 compliance with § 10-425 of this subtitle.

19 (c) (1) An amended disclosure statement is subject to each requirement of this
20 subtitle.

21 (2) A provider shall file an amended disclosure statement with the
22 Department when it is delivered to a subscriber or prospective subscriber.

23 **(D) A PROVIDER SHALL POST THE MOST RECENT DISCLOSURE STATEMENT**
24 **ON THE PROVIDER'S WEBSITE.**

26 (a) At least [once a year] QUARTERLY, each provider shall hold a meeting open
27 to all of the provider's subscribers.

28 (b) At the [meeting] MEETINGS, an authorized officer of the provider shall:

29 (1) summarize the provider's operations, significant changes from the
30 previous year, and goals and objectives for the next year; and

31 (2) answer subscribers' questions.

1 (C) AT THE LAST QUARTERLY MEETING OF THE YEAR, AN AUTHORIZED
 2 OFFICER OF THE PROVIDER SHALL PROVIDE AN AGGREGATED, DEIDENTIFIED
 3 SUMMARY OF INTERNAL GRIEVANCES SUBMITTED UNDER § 10-428 OF THIS
 4 SUBTITLE.

6 (a) (1) If a provider has a governing body, at least ~~one~~ **TWO** of the provider's
 7 subscribers shall be ~~a~~ full and regular ~~member~~ **MEMBERS** of the governing body.

8 (2) If the provider owns or operates ~~more than three~~ **MULTIPLE** facilities
 9 in the State, the governing body shall include at least one of the provider's subscribers ~~for~~
 10 every three facilities ~~from each facility~~ in the State.

11 (3) ~~Subject to paragraph (4) of this subsection, a~~ **A** member of the
 12 governing body who is selected to meet the requirements of this subsection shall be a
 13 subscriber at a facility in the State and be ~~selected according to the same general written~~
 14 standards and criteria used to select other members of the governing body ~~by~~ **ELECTED BY**
 15 ~~THE RESIDENT ASSOCIATION OF THE FACILITY.~~

16 (4) ~~The governing body shall confer with the resident association at each~~

18 **(5) (I) A SUBSCRIBER MEMBER OF A GOVERNING BODY MAY**
 19 **REPORT ON NONCONFIDENTIAL DELIBERATIONS, ACTIONS, AND POLICIES OF THE**
 20 **GOVERNING BODY TO THE RESIDENT ASSOCIATION.**

21 **(II) THE GOVERNING BODY SHALL DETERMINE WHETHER A**
 22 **MATTER IS CONFIDENTIAL.**

23 ~~(5) THE GOVERNING BODY OF EACH OF THE PROVIDER'S FACILITIES~~
 24 ~~SHALL DIRECT AN OFFICER OF THE PROVIDER TO MEET AT LEAST QUARTERLY TO~~
 25 ~~REVIEW AND DISCUSS THE CURRENT FINANCIAL STATEMENTS OF THE PROVIDER~~
 26 ~~WITH THE RESIDENT ASSOCIATION OR A COMMITTEE DESIGNATED BY THE RESIDENT~~

28 **(6)** The Secretary may waive the requirements of this subsection for a
 29 provider in the process of decertifying as a provider, if the Secretary determines that there
 30 are no subscribers willing and able to serve on the governing body.

31 (b) (1) If a provider does not have a governing body, the provider shall appoint
 32 a select committee of its officers or partners to meet at least **[twice a year] QUARTERLY**
 33 with the resident association at each of its facilities to address concerns of the subscribers

1 and to ensure that the opinions of subscribers are relayed to all officers or partners of the
2 provider.

3 (2) If a facility does not have a resident association, the committee shall
4 meet with a reasonable number of representatives, not required to exceed fifteen, that the
5 subscribers elect.

6 (c) As determined by the provider's governing body, the provider shall make
7 available to subscribers either the nonconfidential portions of the minutes of each meeting
8 of the governing body or a summary of the nonconfidential portions of the minutes, within
9 1 month of approval of the minutes.

11 (a) A provider shall establish an internal grievance procedure to address a
12 subscriber's grievance.

13 (b) The internal grievance procedure shall at least:

14 (1) allow a subscriber or group of subscribers collectively to submit a
15 written grievance to the provider;

16 (2) require the provider to send a written acknowledgment to the
17 subscriber or group of subscribers within 5 days after receipt of the written grievance;

18 (3) require the provider to assign personnel to investigate the grievance;

19 (4) give a subscriber or group of subscribers who file a written grievance
20 the right to meet with management of the provider within 30 days after receipt of the
21 written grievance to present the grievance; and

22 (5) require the provider to respond in writing within 45 days after receipt
23 of the written grievance regarding the investigation and resolution of the grievance.

24 (c) (1) Within 30 days after the conclusion of an internal grievance procedure
25 established under this section, a subscriber, group of subscribers, or provider may seek
26 mediation through one of the Community Mediation Centers in the State or another
27 mediation provider.

28 (2) If a provider, subscriber, or group of subscribers seeks mediation under
29 paragraph (1) of this subsection, the mediation shall be nonbinding.

30 (D) (1) ~~AT LEAST TWICE EACH YEAR~~ ON AN ANNUAL BASIS, THE
31 DEPARTMENT SHALL COLLECT FROM EACH PROVIDER INFORMATION ABOUT
32 INTERNAL GRIEVANCES FILED FOR EACH OF THE PROVIDER'S FACILITIES,
33 INCLUDING:

- 1 **(I) THE NUMBER OF INTERNAL GRIEVANCES FILED;**
- 2 **(II) ~~THE SUBJECT MATTER OF EACH GRIEVANCE FILED~~**
 3 **AGGREGATED, DEIDENTIFIED SUMMARY OF INTERNAL GRIEVANCES;**
- 4 **(III) WHETHER A GRIEVANCE WENT TO MEDIATION AND THE**
 5 **OUTCOME OF THE MEDIATION; AND**
- 6 **(IV) THE FINAL DISPOSITION OF EACH FILED GRIEVANCE.**

7 **(2) ON OR BEFORE DECEMBER 1 EACH YEAR, THE DEPARTMENT**
 8 **SHALL REPORT TO THE SENATE FINANCE COMMITTEE AND THE HOUSE HEALTH**
 9 **AND GOVERNMENT OPERATIONS COMMITTEE, IN ACCORDANCE WITH § 2-1257 OF**
 10 **THE STATE GOVERNMENT ARTICLE, ON THE DATA RECEIVED FROM EACH**

13 (a) A continuing care agreement shall allow a subscriber to terminate the
 14 agreement by giving a written termination notice to the provider.

15 **¶(b)** If a continuing care agreement is terminated by the subscriber's election or
 16 death within the first 90 days of occupancy, the provider shall pay any contractual entrance
 17 fee refund within 30 days after the earlier to occur of:

18 (1) the recontracting of the subscriber's unit by:

- 19 (i) another subscriber for whom an entrance fee has been paid; or
- 20 (ii) another party who is not a subscriber; or

21 (2) the later to occur of:

22 (i) the 90th day after the date the written termination notice is
 23 given or the date of death; or

24 (ii) the day the independent living units at the facility have operated
 25 at 95% of capacity for the previous 6 months.

26 (c) If a continuing care agreement is terminated by the subscriber's election or
 27 death after the first 90 days of occupancy, the provider shall pay any contractual entrance
 28 fee refund within 60 days after the subscriber's death or the effective date of termination,
 29 if on the date of death or at any time between the date the written termination notice is
 30 given and the effective date of termination:

1 (1) the subscriber resides in a unit at a higher level of care than the level
2 of care in which the subscriber resided on initially entering the facility; and

3 (2) the last unit in which the subscriber resided at the initial level of care
4 on entering the facility has been occupied by or reserved for another subscriber who has
5 paid an entrance fee.†

~~(E) NOTWITHSTANDING OTHER PROVISIONS OF LAW, A PROVIDER SHALL PAY THE BALANCE OF ANY CONTRACTUAL ENTRANCE FEE REFUND WITHIN 60 DAYS OF THE TERMINATION DATE IF ON THE TERMINATION DATE A SUBSCRIBER RESIDED IN A UNIT AT A HIGHER LEVEL OF CARE THAN THE LEVEL OF CARE IN WHICH THE SUBSCRIBER RESIDED WHEN THE SUBSCRIBER INITIALLY RESIDED AT THE FACILITY.~~

~~[(d)] (F)~~ This section does not prohibit a provider from requiring that a subscriber's unit be vacated before any contractual entrance fee refund is paid as a result of the subscriber's election to terminate a continuing care agreement.

~~(G) (E) EVERY 6 MONTHS, A PROVIDER SHALL SUBMIT TO THE DEPARTMENT A REPORT THAT INCLUDES, FOR THE PRIOR 6 MONTHS:~~

~~(1) THE NUMBER OF SATISFIED ENTRANCE FEE REFUNDS;~~

~~(2) THE DOLLAR AMOUNT OF EACH SATISFIED ENTRANCE FEE REFUND;~~

~~(3) THE OUTSTANDING SEQUENTIAL LIST OF ENTRANCE FEE REFUNDS, INCLUDING DOLLAR AMOUNTS DUE;~~

~~(4) THE CURRENT PERCENTAGE OF UNITS AT A FACILITY THAT ARE OCCUPIED; AND~~

~~(5) THE AVERAGE LENGTH OF TIME THE PROVIDER TAKES TO CONTRACT OR RECONTRACT UNITS~~

(1) IF AN ENTRANCE FEE REFUND IS CONDITIONED ON THE REOCCUPYING OF A SUBSCRIBER'S UNIT AND THE UNIT HAS NOT BEEN REOCCUPIED WITHIN 9 MONTHS OF THE SUBSCRIBER'S DEATH OR THE DATE OF THE CONTRACT TERMINATION, A PROVIDER SHALL SUBMIT A WRITTEN REPORT TO THE SUBSCRIBER OR THE SUBSCRIBER'S BENEFICIARY STATING:

1 **(I) THAT THE UNIT HAS NOT BEEN REOCCUPIED; AND**

2 **(II) THE EFFORTS THE PROVIDER HAS MADE TO REOCCUPY THE**
3 **UNIT.**

4 **(2) AFTER THE PROVIDER SUBMITTED THE REPORT REQUIRED**
5 **UNDER PARAGRAPH (1) OF THIS SUBSECTION, THE PROVIDER SHALL SUBMIT AN**
6 **UPDATED WRITTEN REPORT TO THE SUBSCRIBER OR THE SUBSCRIBER'S**
7 **BENEFICIARY EVERY 6 MONTHS UNTIL THE SUBSCRIBER'S UNIT HAS BEEN**
8 **REOCCUPIED.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall be construed to
10 apply only prospectively and may not be applied or interpreted to have any effect on or
11 application to any cause of action arising before the effective date of this Act.

12 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
13 October 1, 2024.
