BY repealing and reenacting, with amendments, Article - Election Law Section 10–202(a) and 10–205 Annotated Code of Maryland (2010 Replacement Volume and 2016 Supplement) BY repealing and reenacting, with amendments, Article – Labor and Employment Section 3–210(c) Annotated Code of Maryland (2016 Replacement Volume) BY repealing and reenacting, without amendments,
