## A BILL

To establish the Cahokia Mounds Mississippian Culture National Historical Park in Collinsville, Illinois, Monroe, Madison, and St. Clair Counties, Illinois, and St. Louis City County, Missouri, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Cahokia Mounds Mis-
- 5 sissippian Culture National Historical Park Act".

| 18 | (1) In general.—Subject to paragraph (2), in           |
| 19 | order to preserve and interpret for the benefit of     |
| 20 | present and future generations the historical, cul-    |
| 21 | tural, and natural resources associated with the life  |
| 22 | of the Mississippian Culture, there is established, as |
| 23 | a unit of the National Park System, the Cahokia        |
| 24 | Mounds Mississippian Culture National Historical       |

- and St. Clair Counties, Illinois, and St. Louis City
  County, Missouri.
- 3 (2) Determination by Secretary.—The his-4 torical park shall not be established until the date on 5 which the Secretary determines that a sufficient 6 quantity of land, or interests in land, has been ac-7 quired to constitute a manageable unit.
- 8 (3) NOTICE.—Not later than 30 days after the 9 date on which the Secretary acquires the land under 10 subparagraph (B), the Secretary shall publish in the 11 Federal Register notice of the establishment of the 12 historical park.
- 13 (4) AVAILABILITY OF MAP.—The map shall be 14 on file and available for public inspection in the ap-15 propriate offices of the National Park Service.
- (c) BOUNDARY.—The boundary of the historical parkshall be the boundary as depicted on the map.
- 18 (d) Land Acquisition.—The Secretary may acquire
- 19 land and interests in land within the boundary of the his-
- 20 torical park by donation, purchase from a willing seller
- 21 with donated or appropriated funds, or exchange, except
- 22 that land owned by the States or their political subdivi-
- 23 sions may be acquired only by donation.
