AN ACT

- To prohibit commercial exports of certain nonlethal crowd control items and defense articles and services to the Hong Kong Police, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the "Placing Restrictions
3 on Teargas Exports and Crowd Control Technology to
4 Hong Kong Act" or the "PROTECT Hong Kong Act".
5 SEC. 2. FINDINGS.

6 Congress finds the following:

7 (1) The United Nations High Commissioner for 8 Human Rights, along with human rights organizations, has called for an investigation of the use of 9 crowd control tactics used in Hong Kong which fall 10 11 short of international standards, including the 12 United Nations Code of Conduct for Law Enforce-13 ment Officials and the Basic Principles on the Use of Force and Firearms for Law Enforcement Offi-14 15 cials.

16 (2) United States companies have reportedly
17 provided the Hong Kong Police Force with muni18 tions and non-lethal crowd control equipment that
19 were reportedly used by the police.

20 (3) Hong Kong citizens and the international
21 community have called for changes to the Hong
22 Kong Police's crowd control tactics and these re23 quests have gone unheeded by the Hong Kong Spe24 cial Administrative Region Government.

25 SEC. 3. STATEMENT OF POLICY.

26 It is the policy of the United States—

6	quirements of section 502B(a) of the Foreign Assist-

9	detection instruments and equipment to deter the
10	development of a consistent pattern of human rights
11	abuses, distance the United States from such
12	abuses, and avoid contributing to civil disorder in a
13	country or region, in accordance with section
14	742.7(b) of part 774 of subtitle B of title 15, Code
15	of Federal Regulations.

1 (b) WAIVER.—The prohibition under subsection (a) 2 shall not apply to the issuance of a license with respect 3 to which the President submits to the appropriate congres-4 sional committees, not fewer than 30 days before the date 5 of such issuance, a written certification that the exports to be covered by such license are important to the national 6 7 interests and foreign policy goals of the United States, in-8 cluding a description of the manner in which such exports 9 will promote such interests and goals.

10 (c) TERMINATION.—The prohibition under sub11 section (a) shall terminate on the date on which the Presi12 dent certifies to the appropriate congressional committees
13 that—

14 (1) the Hong Kong Police have not engaged in 15 gross violations of human rights during the 1-year 16 period ending on the date of such certification; and 17 (2) there has been an independent examination 18 of human rights concerns related to the crowd con-19 trol tactics of the Hong Kong Police and the Gov-20 ernment of the Hong Kong Special Administrative 21 Region has adequately addressed those concerns.

1SEC. 5. REPORT ON COVERED DEFENSE ARTICLES AND2SERVICES AND COVERED MUNITIONS ITEMS3EXPORTED TO THE HONG KONG POLICE.

4 (a) IN GENERAL.—Not later than 90 days after the 5 date of the enactment of this Act, the Secretary of State and the Secretary of Commerce, in consultation with the 6 7 heads of other relevant Federal departments and agencies, 8 shall jointly submit to the appropriate congressional com-9 mittees a report that lists and provides a description of all covered defense articles and services and covered muni-10 11 tions items exported to the Hong Kong Police during the 12 5-year period ending on such date of enactment.

13 (b) FORM.—The report required by subsection (a)
14 shall be submitted in unclassified form but may include
15 a classified annex.

16 SEC. 6. DEFINITIONS.

18 (1) APPROPRIATE CONGRESSIONAL COMMIT19 TEES.—The term "appropriate congressional com20 mittees" means—

- 21 (A) the Committee on Foreign Affairs of
 22 the House of Representatives;
- 23 (B) the Committee on Foreign Relations of24 the Senate; and
- 25 (C) the Committee on Banking, Housing,26 and Urban Affairs of the Senate.

1	(2) Covered defense articles and serv-
2	ICES.—The term "covered defense articles and serv-
3	ices" means defense articles and defense services
4	designated by the President under section $38(a)(1)$
5	of the Arms Export Control Act (22 U.S.C.
6	2778(a)(1)).
7	(3) Covered munitions items.—The term
8	"covered munitions items" means—
9	(A) items controlled under section 742.7 of
10	part 742 of subtitle B of title 15, Code of Fed-
11	eral Regulations (relating to crime control and
12	detection instruments and equipment and re-
13	lated technology and software); and
14	(B) items listed under the "600 series" of
15	the Commerce Control List contained in Sup-
16	plement No. 1 to part 774 of subtitle B of title
17	15, Code of Federal Regulations.
18	(4) Hong Kong.—The term "Hong Kong" has
19	the meaning given such term in section 3 of the
20	United States-Hong Kong Policy Act of 1992 (22
21	U.S.C. 5702).
22	(5) Hong Kong Police.—The term "Hong
23	Kong Police'' means—
24	(A) the Hong Kong Police Force; and
25	(B) the Hong Kong Auxiliary Police Force.

1 SEC. 7. DETERMINATION OF BUDGETARY EFFECTS.

2 The budgetary effects of this Act, for the purpose of 3 complying with the Statutory Pay-As-You-Go Act of 2010, 4 shall be determined by reference to the latest statement titled "Budgetary Effects of PAYGO Legislation" for this 5 Act, submitted for printing in the Congressional Record 6 7 by the Chairman of the House Budget Committee, pro-8 vided that such statement has been submitted prior to the vote on passage. 9
