1 EACH HOSPITAL SHALL ENSURE THE AVAILABILITY OF STAFF TO (D) 2 IDENTIFY APPROPRIATE AND AVAILABLE SERVICES FOR PATIENTS IN THE HOSPITAL 3 WHO ARE IN NEED OF MENTAL HEALTH OR SUBSTANCE USE DISORDER SERVICES 4 AND TO ASSIST THE PATIENT IN ACCESSING THE SERVICES. SECTION 2.
