3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Chuck Osier Burial5 Benefits Act".

1	SEC. 2. DEPARTMENT OF VETERANS AFFAIRS PROVISION
2	OF URNS FOR REMAINS OF CERTAIN VET-
3	ERANS WHOSE CREMATED REMAINS ARE NOT

5	Section 2306 of title 38, United States Code, is

7	(1) by redesignating subsections (h) and (i) as

"(3) A deceased individual described in this para-3 graph is an individual— 4 "(A) who served in the Armed Forces on or 5 6 after April 6, 1917; "(B) who is eligible for a headstone or marker 7 furnished under subsection (d) (or would be so eligi-8 9 ble but for the date of the death of the individual); 10 and "(C) whose remains were cremated and not in-11 terred in a national cemetery, a State veterans' cem-12 etery, a tribal cemetery, or a private cemetery.". 13
