A BILL

To require annual reports on allied contributions to the common defense, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Allied Burden Sharing
- 5 Report Act of 2019".
- 6 SEC. 2. FINDING; SENSE OF CONGRESS.
- 7 (a) FINDING.—Congress finds that section 1003 of
- 8 the Department of Defense Authorization Act, 1985 (Pub-
- 9 lic Law 98–525; 63 Stat. 2241)—

| 10 | (b) Sense of Congress.—It is the sense of Con- |
| 11 | gress that— |
| 12 | (1) the threats facing the United States— |
| 13 | (A) extend beyond the global war on ter- |
| 14 | ror; and |
| 15 | (B) include near-peer threats; and |
| 16 | (2) the President should seek from each coun- |
| 17 | try described in section 3(b) acceptance of inter- |
| 18 | national security responsibilities and agreements to |
| 19 | make contributions to the common defense in ac- |
| 20 | cordance with the collective defense agreements or |
| 21 | treaties to which such country is a party. |
| 22 | SEC. 3. REPORTS ON ALLIED CONTRIBUTIONS TO THE |
| 23 | COMMON DEFENSE. |
| 24 | (a) In General.—Not later than March 1 each year, |
| 25 | the Secretary, in coordination with the heads of other Fed- |

- 1 eral agencies, as the Secretary determines to be necessary,
- 2 shall submit to the appropriate committees of Congress
- 3 a report containing a description of—
- 4 (1) the annual defense spending by each coun-
- 5 try described in subsection (b), including available
- data on nominal budget figures and defense spend-
- 7 ing as a percentage of the gross domestic products
- 8 of each such country for the fiscal year immediately
- 9 preceding the fiscal year in which the report is sub-
- mitted:
- 11 (2) the activities of each such country to con-
- tribute to military or stability operations in which
- the Armed Forces of the United States are a partici-
- pant or may be called upon in accordance with a co-
- operative defense agreement to which the United
- 16 States is a party;
- 17 (3) any limitations placed by any such country
- on the use of such contributions; and
- 19 (4) any actions undertaken by the United
- 20 States or by other countries to minimize such limita-
- 21 tions.
- 22 (b) Countries Described.—The countries de-
- 23 scribed in this subsection are the following:
- 24 (1) Each member state of the North Atlantic
- 25 Treaty Organization.
