Alcoholic Beverages - Sale or Delivery for Off-Premises Consumption

3 FOR the purpose of altering the scope of a certain provision prohibiting the retail delivery 4 to a purchaser of alcoholic beverages under certain circumstances; providing that 5 certain authorization for the holders of certain licenses to sell alcoholic beverages for 6 off-premises consumption in a certain manner applies only in a jurisdiction in which 7 the local licensing board has adopted certain regulations; authorizing the holders of 8 certain licenses that authorize the sale of alcoholic beverages at a restaurant, bar, or 9 tavern to sell certain alcoholic beverages for off-premises consumption or delivery under certain circumstances; prohibiting a local licensing board from charging a 10 11 certain license holder an additional fee under certain circumstances; authorizing a 12 local licensing board to limit the quantity of alcoholic beverages sold or delivered to an individual in a single transaction; and generally relating to the sale of alcoholic 13 14 beverages at restaurants, bars, and taverns.
