## A BILL ENTITLED

1 AN ACT concerning

2 **Education – Specialized Intervention Services – Reports**

3 FOR the purpose of requiring certain county boards of education to report certain  
4 information relating to the provision of specialized intervention services to the State  
5 Department of Education and the General Assembly on or before a certain date each  
6 year; requiring certain county boards and the Department to publish annually  
7 certain information on certain Web sites; defining a certain term; and generally  
8 relating to the reporting of specialized intervention services.

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
15 That the Laws of Maryland read as follows:

16 **Article – Education**

17 **5–111.1.**

18 **(A) IN THIS SECTION, “SPECIALIZED INTERVENTION SERVICES” MEANS**  
19 **SERVICES PROVIDED TO STUDENTS IN KINDERGARTEN THROUGH GRADE 12 WHO:**

20 **(1) ARE NOT CURRENTLY IDENTIFIED AS NEEDING SPECIAL**  
21 **EDUCATION OR RELATED SERVICES UNDER TITLE 8, SUBTITLE 4 OF THIS ARTICLE;**

1           **(2) NEED ADDITIONAL ACADEMIC AND BEHAVIORAL SUPPORTS TO**  
2 **SUCCEED IN A CORE CURRICULUM AND DIFFERENTIATED INSTRUCTION GENERAL**  
3 **EDUCATION ENVIRONMENT; AND**

4           **(3) RECEIVE ADDITIONAL ACADEMIC AND BEHAVIORAL SUPPORT IN**  
5 **SMALL GROUPS OR INDIVIDUAL SETTINGS AT LEAST 3 TIMES EACH WEEK FOR AT**  
6 **LEAST 90 MINUTES EACH WEEK FOR A PERIOD OF AT LEAST 10 WEEKS DURING A**  
7 **SCHOOL YEAR.**

8           **(B) BEGINNING WITH THE 2018–2019 SCHOOL YEAR, ON OR BEFORE**  
9 **DECEMBER 1 EACH YEAR, EACH COUNTY BOARD SHALL SUBMIT TO THE**  
10 **DEPARTMENT AND, SUBJECT TO § 2–1246 OF THE STATE GOVERNMENT ARTICLE,**  
11 **THE GENERAL ASSEMBLY A REPORT FOR THE PRIOR SCHOOL YEAR ON:**

12           **(1) THE NUMBER OF STUDENTS WHO RECEIVED SPECIALIZED**  
13 **INTERVENTION SERVICES;**

14           **(2) THE GRADES IN WHICH SPECIALIZED INTERVENTION SERVICES**  
15 **WERE PROVIDED; AND**

16           **(3) THE ANNUAL BUDGET, INCLUDING ALL FEDERAL, STATE, AND**  
17 **LOCAL FUNDS, FOR SPECIALIZED INTERVENTION SERVICES, INCLUDING**  
18 **SCREENINGS, EVALUATIONS, MATERIALS, PROFESSIONAL DEVELOPMENT, AND**  
19 **STAFFING.**

20           **(C) A COUNTY BOARD SHALL PUBLISH ANNUALLY ON THE COUNTY BOARD’S**  
21 **WEB SITE THE INFORMATION SUBMITTED UNDER SUBSECTION (B) OF THIS SECTION.**

22           **(D) THE DEPARTMENT SHALL PUBLISH ANNUALLY ON THE DEPARTMENT’S**  
23 **WEB SITE THE INFORMATION RECEIVED UNDER SUBSECTION (B) OF THIS SECTION.**

24           **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**  
25 **October 1, 2017.**
