13 14	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

17 18	(a) (1) The Department may implement a Supplemental Nutrition Assistance Program in accordance with the federal Supplemental Nutrition Assistance Program.
19	(2) The Supplemental Nutrition Assistance Program shall include:
20 21	(i) a Restaurant Meals Program in accordance with \S 5–505 of this subtitle; and
22 23	(ii) a Heat and Eat Program in accordance with § 5–506 of this subtitle.

The State shall bear the nonfederal portion of the administrative costs of the 1 (b) 2 Supplemental Nutrition Assistance Program for each county. 3 Each local department shall administer the Supplemental Nutrition (c) 4 Assistance Program: 5 under the supervision and control of the Department; and (1) 6 (2)in accordance with the regulations of the Department and federal law. 7 **(1)** If a household includes an individual who is at least 62 years old and (d) 8 receives a federally funded benefit in an amount less than \$40 per month under the 9 Supplemental Nutrition Assistance Program, the State shall provide a supplement to 10 increase the total benefit to \$40 per month. 11 **(2)** THE STATE SHALL PROVIDE A BENEFIT OF AT LEAST \$40 PER MONTH UNDER THE SUPPLEMENTAL NUTRITION ASSISTANCE PROGRAM TO A 12 HOUSEHOLD THAT INCLUDES AN INDIVIDUAL WHO: 13 14 **(I)** IS AT LEAST 65 YEARS OLD; AND 15 (II)HAS A GROSS ANNUAL HOUSEHOLD INCOME THAT DOES NOT 16 **EXCEED \$50,000.**
