 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Medgar and Myrlie
- 5 Evers Home National Monument Act".
- 6 SEC. 2. DEFINITIONS.
- 7 In this Act:

COLLEGE.—The term "College" means 1 (1)2 Tougaloo College, a private educational institution 3 located in Tougaloo, Mississippi. 4 (2) HISTORIC DISTRICT.—The term "Historic 5 District" means the Medgar Evers Historic District, 6 as included on the National Register of Historic 7 Places, and as generally depicted on the Map. 8 (3) MAP.—The term "Map" means the map en-9 titled "Medgar and Myrlie Evers Home National 10 Monument", numbered 515/142561, and dated Sep-11 tember 2018. MONUMENT.—The 12 "Monument" (4)term 13 means the Medgar and Myrlie Evers Home National 14 Monument established by section 3. 15 (5) SECRETARY.—The term "Secretary" means 16 the Secretary of the Interior, acting through the Di-17 rector of the National Park Service. 18 SEC. 3. ESTABLISHMENT OF MEDGAR AND MYRLIE EVERS 19 HOME NATIONAL MONUMENT. 20 (a) ESTABLISHMENT.— 21 (1) IN GENERAL.—Subject to paragraph (2), 22 there is established the Medgar and Myrlie Evers 23 Home National Monument in the State of Mis-24 sissippi as a unit of the National Park System to

preserve, protect, and interpret for the benefit of

1	present and future generations resources associated
2	with the pivotal roles of Medgar and Myrlie Evers
3	in the American Civil Rights Movement.
4	(2) DETERMINATION BY THE SECRETARY.—
5	The Monument shall not be established until the
6	date on which the Secretary determines that a suffi-
7	cient quantity of land or interests in land has been
8	acquired to constitute a manageable park unit.
9	(b) BOUNDARIES.—The boundaries of the Monument
10	shall be the boundaries generally depicted on the Map.
11	(c) AVAILABILITY OF MAP.—The Map shall be on file
12	and available for public inspection in the appropriate of-
13	fices of the National Park Service.
14	(d) Acquisition Authority.—The Secretary may
15	only acquire any land or interest in land located within
16	the boundary of the Monument by—
17	(1) donation;
18	(2) purchase from a willing seller with donated
19	or appropriated funds; or
20	(3) exchange.
21	(e) Administration.—
22	(1) IN GENERAL.—The Secretary shall admin-
23	ister the Monument in accordance with—
24	(A) this Act; and

1	(B) the laws generally applicable to units
2	of the National Park System, including—
3	(i) section 100101(a), chapter 1003,
4	and sections 100751(a), 100752, 100753,
5	and 102101 of title 54, United States
6	Code; and
7	(ii) chapter 3201 of title 54, United
8	States Code.
9	(2) Management plan.—
10	(A) IN GENERAL.—Not later than 3 years
11	after the date on which funds are first made
12	available to the Secretary for this purpose, the
13	Secretary shall prepare a general management
14	plan for the Monument in accordance with sec-
15	tion 100502 of title 54, United States Code.
16	(B) SUBMISSION.—On completion of the
17	general management plan under subparagraph
18	(A), the Secretary shall submit it to the Com-
19	mittee on Natural Resources of the House of
20	Representatives and the Committee on Energy
21	and Natural Resources of the Senate.
22	(f) Agreements.—
23	(1) MONUMENT.—The Secretary—
24	(A) shall seek to enter into an agreement
25	with the College to provide interpretive and

educational services relating to the Monument; and

3 (B) may enter into agreements with the
4 College and other entities for the purposes of
5 carrying out this Act.

6 (2) HISTORIC DISTRICT.—The Secretary may 7 enter into agreements with the owner of a nationally 8 significant property within the Historic District, to 9 identify, mark, interpret, and provide technical as-10 sistance with respect to the preservation and inter-11 pretation of the property.

12 (g) NO BUFFER ZONES.—

(1) IN GENERAL.—Nothing in this Act, the establishment of the Monument, or the management of
the Monument creates a buffer zone outside of the
Monument.

17 (2) ACTIVITY OR USE OUTSIDE MONUMENT.—
18 The fact that an activity or use can be seen, heard,
19 or detected from within the Monument shall not pre20 clude the conduct of the activity or use outside of
21 the Monument.
