To require the Secretary of Health and Human Services to award additional funding through the Sanitation Facilities Construction Program of the Indian Health Service, and for other purposes.

**3** SECTION 1. INDIAN HEALTH SERVICE SANITATION FACILI-

- TIES CONSTRUCTION PROGRAM FUNDING.
- 5 (a) FINDINGS.—Congress finds that—
- 6 (1) the COVID-19 crisis has highlighted the 7 lack of infrastructure and sanitation available in Na-
- 8 tive communities;

21	(2) Secretary.—The term "Secretary" means
22	the Secretary of Health and Human Services, acting

24	(c) Additional Funding for Sanitation Facili-

1 (1) IN GENERAL.—The Secretary shall award 2 additional funding under the Sanitation Facilities 3 Construction Program for the planning, design, con-4 struction, modernization, improvement, and renova-5 tion of water, sewer, and solid waste sanitation fa-6 cilities that are funded, in whole or part, by the In-7 dian Health Service through, or provided for in, a 8 contract or compact with the Indian Health Service 9 under the Indian Self-Determination and Education Assistance Act (25 U.S.C. 5301 et seq.). 10

(2) PRIORITY FOR FUNDING.—In awarding
funding to sanitation facilities under paragraph (1),
the Secretary shall prioritize sanitation facilities
with the highest deficiency level, as established in
the report.

16 (d) AUTHORIZATION OF APPROPRIATIONS.—

17 (1) IN GENERAL.—There is authorized to be
18 appropriated to the Secretary to carry out this sec19 tion \$1,335,000,000 for the period of fiscal years
20 2020 through 2024.

(2) REQUIREMENT.—Amounts made available
under paragraph (1) shall be in addition to any
amounts made available to carry out the purposes

- 1 described in subsection (c)(1) under any other provi-
- 2 sion of law.
