A BILL ENTITLED

1 AN ACT concerning

2 **Courts – Improperly Summoning a Police Officer – Civil Liability**

3 FOR the purpose of authorizing a person to bring a civil action for damages against another
4 person who knowingly causes a police officer to arrive at a location to contact the
5 person with a certain intent; specifying the types of damages that may be recovered
6 under this Act; providing that this Act does not limit certain legal remedies; and
7 generally relating to civil liability for improperly summoning a police officer.

10 Section 3–2201 through 3–2203 to be under the new subtitle “Subtitle 22. Liability
11 for Improperly Summoning a Police Officer”

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
15 That the Laws of Maryland read as follows:

16 **Article – Courts and Judicial Proceedings**

17 **SUBTITLE 22. LIABILITY FOR IMPROPERLY SUMMONING A POLICE OFFICER.**

18 **3–2201.**

19 **A PERSON MAY BRING A CIVIL ACTION FOR DAMAGES AGAINST ANOTHER**
20 **PERSON WHO KNOWINGLY CAUSES A POLICE OFFICER TO ARRIVE AT A LOCATION TO**
21 **CONTACT THE PERSON WITH THE INTENT TO:**

22 **(1) INFRINGE ON THE PERSON’S RIGHTS UNDER THE MARYLAND**
23 **CONSTITUTION OR THE UNITED STATES CONSTITUTION;**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



(2) UNLAWFULLY DISCRIMINATE AGAINST THE PERSON;

(3) CAUSE THE PERSON TO:

(I) FEEL HARASSED, HUMILIATED, OR EMBARRASSED; OR

**(II) BE EXPELLED FROM A PLACE IN WHICH THE PERSON IS
LAWFULLY LOCATED; OR**

(4) DAMAGE THE PERSON'S:

(I) REPUTATION OR STANDING WITHIN THE COMMUNITY; OR

**(II) FINANCIAL, ECONOMIC, CONSUMER, OR BUSINESS
PROSPECTS OR INTERESTS.**

**A PERSON ENTITLED TO BRING A CIVIL ACTION UNDER THIS SUBTITLE MAY
RECOVER:**

(1) THE GREATER OF:

**(I) ECONOMIC AND NONECONOMIC DAMAGES, INCLUDING
DAMAGES FOR EMOTIONAL DISTRESS; OR**

**(II) STATUTORY DAMAGES OF \$10,000 AGAINST EACH
DEFENDANT FOUND LIABLE UNDER THIS SECTION; AND**

(2) PUNITIVE DAMAGES.

3-2203.

**THIS SUBTITLE DOES NOT LIMIT ANY OTHER LEGAL REMEDY TO WHICH A
PLAINTIFF IS ENTITLED.**

**SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
October 1, 2020.**
