Real Property - New Home Sales - Information on Energy-Efficient Options

- FOR the purpose of requiring a home builder registrant to provide a purchaser with certain information on energy-efficient options available for a new home under certain circumstances; requiring a contract for the initial sale of a new home to contain a certain acknowledgment that the purchaser was informed about certain energy-efficient options; and generally relating to new home sales and energy-efficient alternatives for the home.

- 19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
- 20 That the Laws of Maryland read as follows:

- 23 (A) (1) THIS SUBSECTION APPLIES ONLY TO A DEVELOPMENT THAT 24 CONTAINS 11 OR MORE NEW HOMES TO BE BUILT BY THE SAME REGISTRANT.



- 1 (2) PRIOR TO THE EXECUTION OF ANY CONTRACT FOR THE INITIAL
 2 SALE OF A NEW HOME, A REGISTRANT SHALL PROVIDE THE PURCHASER WITH
 3 WRITTEN INFORMATION ABOUT ANY ENERGY-EFFICIENT OPTIONS AVAILABLE FOR
 4 THE HOME BEFORE THE HOME IS COMPLETED.
- 5 **(B)** A registrant shall include in any contract for the initial sale of a new home the 6 information required under § 14–117(a)(3), [and] (i), AND (M) of the Real Property Article, 7 if applicable.

- 10 (M) (1) THIS SUBSECTION APPLIES ONLY TO A DEVELOPMENT THAT 11 CONTAINS 11 OR MORE NEW HOMES TO BE BUILT BY THE SAME HOME BUILDER.
- 12 (2) A CONTRACT FOR THE INITIAL SALE OF A NEW HOME, AS DEFINED
 13 IN THE MARYLAND HOME BUILDER REGISTRATION ACT, SHALL CONTAIN AN
 14 ACKNOWLEDGMENT THAT THE PURCHASER WAS ADVISED BY THE BUILDER OF ANY
 15 ENERGY-EFFICIENT OPTIONS AVAILABLE FOR THE HOME BEFORE THE HOME WAS
