## A BILL

To require the Secretary of the Treasury to mint coins  
in commemoration of the United States Coast Guard.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “United States Coast  
5       Guard Commemorative Coin Act of 2017”.

6       **SEC. 2. FINDINGS.**

7       The Congress finds that—

8               (1) the United States Coast Guard was founded  
9       on August 4, 1790, as the Revenue Cutter Service

1 under the United States Department of the Treas-  
2 ury;

3 (2) Congress created the Coast Guard on Janu-  
4 ary 28, 1915, by merging the Revenue Cutter Serv-  
5 ice and the United States Lifesaving Service, which  
6 was moved to the Department of Transportation in  
7 1967, and on February 25, 2003, became part of  
8 the Department of Homeland Security;

9 (3) although the smallest of the uniformed serv-  
10 ices, today the United States Coast Guard conducts  
11 a wide variety of missions to protect the public, the  
12 environment, and the United States economic and  
13 security interests in any maritime region, including  
14 international waters and coasts, ports, and inland  
15 waterways in the United States;

16 (4) every day, the United States Coast Guard  
17 plays a broad and important role in homeland secu-  
18 rity, law enforcement, search and rescue, marine en-  
19 vironmental pollution response, and the maintenance  
20 of river, intracoastal, and offshore aids to naviga-  
21 tion;

22 (5) the United States Coast Guard is the oldest  
23 seagoing military service in the United States, stay-  
24 ing true to their motto, “Semper Paratus” or “Al-  
25 ways Ready”, for 225 years;

1           (6) the United States Coast Guard is supported  
2           by over 50,000 active duty, reserve, and civilian per-  
3           sonnel, who in 2015 responded to 16,400 search and  
4           rescue cases saving 3,500 lives, conducted 20,775  
5           waterborne patrols of critical maritime infrastruc-  
6           ture, escorted over 1,955 high-capacity passenger  
7           vessels, conducted nearly 8,600 security boardings in  
8           and around U.S. ports, removed \$4,900,000,000  
9           worth of illegal drugs, interdicted 6,000 undocu-  
10          mented migrants attempting to illegally enter the  
11          United States, and maintained 47,000 navigation  
12          aids that support \$3,200,000,000,000 in economic  
13          activity on the waterways of the United States;

14          (7) section 213 of the Coast Guard and Mari-  
15          time Transportation Act of 2004 (Public Law 108–  
16          293; 118 Stat. 1037) stated that the “Commandant  
17          may establish a National Coast Guard Museum, on  
18          lands which will be federally owned and administered  
19          by the Coast Guard, and are located in New Lon-  
20          don, Connecticut, at, or in close proximity to, the  
21          Coast Guard Academy”;

22          (8) the National Coast Guard Museum Associa-  
23          tion, a nonprofit association dedicated to improve  
24          public understanding of the history, service and mis-  
25          sions of the Coast Guard, is working with the

1 United States Coast Guard, the City of New Lon-  
 2 don, the State of Connecticut, and a range of local,  
 3 regional, and national stakeholders to develop, plan  
 4 and raise capital for the National Coast Guard Mu-  
 5 seum, to be located in New London, Connecticut;  
 6 and

7 (9) the United States Coast Guard is the only  
 8 military service without a national museum through  
 9 which to share its history and legacy with the Amer-  
 10 ican public.

11 **SEC. 3. COIN SPECIFICATIONS.**

12 (a) DENOMINATIONS.—The Secretary of the Treas-  
 13 ury (hereafter in this Act referred to as the “Secretary”)  
 14 shall mint and issue the following coins:

15 (1) \$5 GOLD COINS.—Not more than 100,000  
 16 \$5 coins, which shall—

17 (A) weigh 8.359 grams;

18 (B) have a diameter of 0.850 inches; and

19 (C) contain 90 percent gold and 10 percent  
 20 alloy.

21 (2) \$1 SILVER COINS.—Not more than 500,000  
 22 \$1 coins, which shall—

23 (A) weigh 26.73 grams;

24 (B) have a diameter of 1.500 inches; and

25 (C) contain at least 90 percent silver.

1           (3) HALF DOLLAR CLAD COINS.—Not more  
2           than 750,000 half dollar coins, which shall—

3                   (A) weigh 11.34 grams;

4                   (B) have a diameter of 1.205 inches; and

5                   (C) be minted to the specifications for half  
6           dollar coins, contained in section 5112(b) of  
7           title 31, United States Code.

8           (b) LEGAL TENDER.—The coins minted under this  
9           Act shall be legal tender, as provided in section 5103 of  
10          title 31, United States Code.

11          (c) NUMISMATIC ITEMS.—For purposes of sections  
12          5134 and 5136 of title 31, United States Code, all coins  
13          minted under this Act shall be considered to be numis-  
14          matic items.

15   **SEC. 4. DESIGN OF COIN.**

16          (a) DESIGN REQUIREMENTS.—

17               (1) IN GENERAL.—The design of the coins  
18               minted under this Act shall be emblematic of the  
19               traditions, history, and heritage of the United States  
20               Coast Guard, and the role of the United States  
21               Coast Guard in securing the United States since  
22               1790.

23               (2) DESIGNATIONS AND INSCRIPTIONS.—On  
24               each coin minted under this Act, there shall be—

25                   (A) a designation of the value of the coin;

1 (B) an inscription of the year “2020”; and  
2 (C) inscriptions of the words “Liberty”,  
3 “In God We Trust”, “United States of Amer-  
4 ica”, “E Pluribus Unum”, and “Semper  
5 Paratus”.

6 (b) SELECTION.—The design for the coins minted  
7 under this Act shall—

8 (1) contain motifs that specifically honor the  
9 United States Coastguardsman of both today and  
10 yesterday, in wartime and in peace, such designs to  
11 be consistent with the traditions and heritage of the  
12 United States Coast Guard, the mission and goals of  
13 the National Coast Guard Museum, and the mis-  
14 sions and goals of the National Coast Guard Mu-  
15 seum Association;

16 (2) be selected by the Secretary, after consulta-  
17 tion with the Secretary of Homeland Security, the  
18 National Coast Guard Museum Association, and the  
19 Commission of Fine Arts; and

20 (3) be reviewed by the Citizens Coinage Advi-  
21 sory Committee.

22 **SEC. 5. ISSUANCE OF COINS.**

23 (a) QUALITY OF COINS.—Coins minted under this  
24 Act shall be issued in uncirculated and proof qualities.

1 (b) MINT FACILITIES.—For each of the 3 coins mint-  
 2 ed under this Act, at least 1 facility of the United States  
 3 Mint shall be used to strike proof quality coins, while at  
 4 least 1 other such facility shall be used to strike the uncir-  
 5 culated quality coins.

6 (c) PERIOD FOR ISSUANCE.—The Secretary may  
 7 issue coins minted under this Act only during the 1-year  
 8 period beginning on January 1, 2020.

9 **SEC. 6. SALE OF COINS.**

10 (a) SALE PRICE.—The coins issued under this Act  
 11 shall be sold by the Secretary at a price equal to the sum  
 12 of—

13 (1) the face value of the coins;

14 (2) the surcharge provided in section 7(a) with  
 15 respect to such coins; and

16 (3) the cost of designing and issuing the coins  
 17 (including labor, materials, dies, use of machinery,  
 18 overhead expenses, marketing, and shipping).

19 (b) BULK SALES.—The Secretary shall make bulk  
 20 sales of the coins issued under this Act at a reasonable  
 21 discount.

22 (c) PREPAID ORDERS.—

23 (1) IN GENERAL.—The Secretary shall accept  
 24 prepaid orders for the coins minted under this Act  
 25 before the issuance of such coins.

1           (2) DISCOUNT.—Sale prices with respect to pre-  
2       paid orders under paragraph (1) shall be at a rea-  
3       sonable discount.

4   **SEC. 7. SURCHARGES.**

5       (a) IN GENERAL.—All sales of coins minted under  
6   this Act shall include a surcharge as follows:

7           (1) A surcharge of \$35 per coin for the \$5 coin.

8           (2) A surcharge of \$10 per coin for the \$1 coin.

9           (3) A surcharge of \$5 per coin for the half dol-  
10   lar coin.

11       (b) DISTRIBUTION.—Subject to section 5134(f) of  
12   title 31, United States Code, all surcharges received by  
13   the Secretary from the sale of coins issued under this Act  
14   shall be promptly paid by the Secretary to the National  
15   Coast Guard Museum Association to help finance the de-  
16   sign, construction, operations, and maintenance of the Na-  
17   tional Coast Guard Museum.

18       (c) AUDITS.—The National Coast Guard Museum  
19   Association shall be subject to the audit requirements of  
20   section 5134(f)(2) of title 31, United States Code, with  
21   regard to the amounts received under subsection (b).

22       (d) LIMITATION.—Notwithstanding subsection (a),  
23   no surcharge may be included with respect to the issuance  
24   under this Act of any coin during a calendar year if, as  
25   of the time of such issuance, the issuance of such coin



1 would result in the number of commemorative coin pro-  
2 grams issued during such year to exceed the annual 2  
3 commemorative coin program issuance limitation under  
4 section 5112(m)(1) of title 31, United States Code. The  
5 Secretary may issue guidance to carry out this subsection.

6 **SEC. 8. FINANCIAL ASSURANCES.**

7 The Secretary shall take such actions as may be nec-  
8 essary to ensure that—

9 (1) minting and issuing coins under this Act  
10 will not result in any net cost to the United States  
11 Government; and

12 (2) no funds, including applicable surcharges,  
13 shall be disbursed to any recipient designated in sec-  
14 tion 7 until the total cost of designing and issuing  
15 all of the coins authorized by this Act (including  
16 labor, materials, dies, use of machinery, overhead ex-  
17 penses, marketing, and shipping) is recovered by the  
18 United States Treasury, consistent with sections  
19 5112(m) and 5134(f) of title 31, United States  
20 Code.
