## A BILL

To prohibit the obligation or expenditure of Federal funds for certain agreements relating to the 46th G7 Summit, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Trump's Heist Under-
- 5 mines the G7 Act" or the "THUG Act".
- 6 SEC. 2. TRANSMITTAL OF DOCUMENTS.
- 7 (a) Transmission Required.—Not later than 30
- 8 days after the date of the enactment of this Act, the Presi-

- 1 dent shall transmit to the Comptroller General of the
- 2 United States and to the committees listed in subsection
- 3 (b) copies of each document, record, memo, correspond-
- 4 ence, or other communication that relates to the decision
- 5 to host the 46th G7 Summit at the Trump National Doral
- 6 Miami.
- 7 (b) Committees Listed in
- 8 this subsection are the following:
- 9 (1) The Committee on the Judiciary, the Com-
- mittee on Oversight and Reform, the Committee on
- Homeland Security, the Committee on Foreign Af-
- fairs, and the Committee on Appropriations of the
- House of Representatives.
- 14 (2) The Committee on the Judiciary, the Com-
- mittee on Homeland Security and Governmental Af-
- fairs, the Committee on Foreign Relations, and the
- 17 Committee on Appropriations of the Senate.
- 18 SEC. 3. PROHIBITION ON THE USE OF FUNDS FOR HOSTING
- 19 THE G7 SUMMIT AT THE TRUMP NATIONAL
- 20 **DORAL MIAMI.**
- 21 (a) Prohibition.—No Federal funds may be obli-
- 22 gated or expended to enter into any new contract, grant,
- 23 or cooperative agreement for any purpose relating to the
- 24 46th G7 Summit with the Trump National Doral Miami,
- 25 Miami, Florida.

- 1 (b) Waiver.—The prohibition under subsection (a)
- 2 may be waived if the Director of the Secret Service cer-
- 3 tifies to the committees listed in section 2(b) that an obli-
- 4 gation or expenditure is necessary to carry out the duties
- 5 of the Director under section 3056 of title 18, United
- 6 States Code, or any other duty under law (including Presi-
- 7 dential memorandum) to provide protection to a person.
- 8 (c) G7 Defined.—In this Act, the term "G7" means
- 9 the organization of leading economies commonly known as
- 10 the "G7" that includes Canada, France, Germany, Italy,
- 11 Japan, the United Kingdom, and the United States as
- 12 members, with the European Union as an observer.
