12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.2, as  
14 last amended by Section 1, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
15 2019, Section 1135.2), is amended to read as follows:

16 Section 1135.2 A. The Oklahoma Tax Commission is hereby  
17 authorized to design and issue appropriate official special license  
18 plates to persons in recognition of their service or awards as  
19 provided by this section.

20 Special license plates shall not be transferred to any other  
21 person but shall be removed from the vehicle upon transfer of  
22 ownership and retained. The special license plate may then be used  
23 on another vehicle but only after such other vehicle has been  
24 registered for the current year.

1 Special license plates shall be renewed each year by the Tax  
2 Commission or a motor license agent. The Tax Commission shall  
3 annually notify by mail all persons issued special license plates.  
4 Personalized license plates shall be scheduled to be renewed on the  
5 same month as any regular license plate that may belong to the same  
6 vehicle. The notice shall contain all necessary information and  
7 shall contain instructions for the renewal procedure upon  
8 presentation to a motor license agent or the Tax Commission. The  
9 license plates shall be issued on a staggered system except for  
10 legislative plates and amateur radio operator license plates.

11 The Tax Commission is hereby directed to develop and implement a  
12 system whereby motor license agents are permitted to accept  
13 applications for special license plates authorized under this  
14 section. The motor license agent shall confirm the applicant's  
15 eligibility, if applicable, collect and deposit any amount  
16 specifically authorized by law, accept and process the necessary  
17 information directly into such system and generate a receipt  
18 accordingly. For performance of these duties, motor license agents  
19 shall retain the fee provided in Section 1141.1 of this title for  
20 registration of a motor vehicle. The motor license agent fees for  
21 acceptance of applications and renewals shall be paid out of the  
22 Oklahoma Tax Commission Reimbursement Fund.

23 B. The special license plates provided by this section are as  
24 follows:

1        1. Prisoner of War License Plates - such plates shall be  
2 designed for honorably discharged or present members of the United  
3 States Armed Forces and civilians who were former prisoners of war  
4 held by a foreign country and who can provide proper certification  
5 of that status. Such persons may apply for a prisoner of war  
6 license plate for no more than two vehicles with each vehicle having  
7 a rated carrying capacity of one (1) ton or less. The surviving  
8 spouse of any deceased former prisoner of war, if the spouse has not  
9 since remarried, or if remarried, the remarriage is terminated by  
10 death, divorce, or annulment, may apply for a prisoner of war  
11 license plate for one vehicle with a rated carrying capacity of one  
12 (1) ton or less. The fee provided by this section for the special  
13 license plate authorized by this paragraph shall be in addition to  
14 all other registration fees provided by law, except the registration  
15 fees levied by Section 1132 of this title;

16        2. National Guard License Plates - such plates shall be  
17 designed for active or retired members of the Oklahoma National  
18 Guard. Retirees who are eligible for such plates shall provide  
19 proof of eligibility upon initial application, but shall not be  
20 required to provide proof of eligibility annually;

21        3. Air National Guard License Plates - such plates shall be  
22 designed for active or retired members of the Oklahoma Air National  
23 Guard. Retirees who are eligible for such plates shall provide  
24

1 proof of eligibility upon initial application, but shall not be  
2 required to provide proof of eligibility annually;

3 4. United States Armed Forces License Plates - such plates  
4 shall be designed for active, retired, former or reserve members of  
5 the United States Armed Forces, and shall identify which branch of  
6 service, and carry the emblem and name of either the Army, Navy, Air  
7 Force, Marines or Coast Guard, according to the branch of service to  
8 which the member belongs or did belong. Former members who have  
9 been dishonorably discharged shall not be eligible for such plates.  
10 Persons applying for such license plate must show proof of present  
11 or past military service by presenting a valid Uniformed Services  
12 Identity Card or the United States Department of Defense Form  
13 (DD)214. Retired or former members who are eligible for such plates  
14 shall provide proof of eligibility upon initial application, but  
15 shall not be required to provide proof of eligibility annually;

16 5. Congressional Medal of Honor Recipient License Plates - such  
17 plates shall be designed for any resident of this state who has been  
18 awarded the Congressional Medal of Honor. Such persons may apply  
19 for a Congressional Medal of Honor recipient license plate for each  
20 vehicle with a rated carrying capacity of one (1) ton or less.  
21 There shall be no registration fee for the issuance of this plate;

22 6. Missing In Action License Plates - such plates shall be  
23 designed to honor members of the United States Armed Forces who are  
24 missing in action. The spouse of such missing person, if the spouse

1 has not since remarried, or if remarried, the remarriage is  
2 terminated by death, divorce, or annulment, and each parent of the  
3 missing person may apply for a missing in action license plate upon  
4 presenting proper certification that the person is missing in action  
5 and that the person making the application is the qualifying spouse  
6 or the parent of the missing person. The qualifying spouse and each  
7 parent of the missing person may each apply for the missing in  
8 action license plate for each vehicle with a rated carrying capacity  
9 of one (1) ton or less;

10 7. Purple Heart Recipient License Plates - such plates shall be  
11 designed for any resident of this state presenting proper  
12 certification from the United States Department of Veterans Affairs  
13 or the Armed Forces of the United States certifying that such  
14 resident has been awarded the Purple Heart military decoration.  
15 Such persons may apply for a Purple Heart recipient license plate  
16 for vehicles having a rated carrying capacity of one (1) ton or  
17 less. The surviving spouse of any deceased veteran who has been  
18 awarded the Purple Heart military decoration, if such spouse has not  
19 since remarried, or if remarried, the remarriage has been terminated  
20 by death, divorce or annulment, may apply for such plate for one  
21 vehicle with a rated carrying capacity of one (1) ton or less. The  
22 license plate created by this paragraph shall be exempt from the fee  
23 provided by this section for special license plates;

1        8. Pearl Harbor Survivor License Plates - such plates shall be  
2 designed for any resident of this state who can be verified by the  
3 United States Department of Veterans Affairs or the Armed Forces of  
4 the United States as being:

5            a. a member of the United States Armed Forces on December  
6                7, 1941,

7            b. stationed on December 7, 1941, during the hours of  
8                7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,  
9                the island of Oahu, or offshore at a distance not to  
10               exceed three (3) miles, and

11           c. a recipient of an honorable discharge from the United  
12               States Armed Forces.

13        Such person may apply for a Pearl Harbor Survivor license plate  
14 for each vehicle with a rated carrying capacity of one (1) ton or  
15 less;

16        9. Iwo Jima License Plates - such plates shall be designed for  
17 any resident of this state who can be verified by the United States  
18 Department of Veterans Affairs or the Armed Forces of the United  
19 States as being:

20           a. a member of the United States Armed Forces in February  
21                of 1945,

22           b. stationed in February of 1945 on or in the immediate  
23                vicinity of the island of Iwo Jima, and  
24

1           c.    a recipient of an honorable discharge from the United  
2               States Armed Forces.

3           Such person may apply for an Iwo Jima license plate for each  
4 vehicle with a rated carrying capacity of one (1) ton or less.

5           Such license plate shall have the legend "Oklahoma OK" and shall  
6 contain three letters and three numbers. Between the letters and  
7 numbers shall be a logo of the flag-raising at Iwo Jima. Below the  
8 letters, logo and numbers, the plate shall contain the words "FEB."  
9 at the left, "Iwo Jima" in the center and "1945" at the right. Such  
10 plates shall not be subject to the design requirements of any other  
11 license plates prescribed by law other than the space for the  
12 placement of the yearly decals for each succeeding year of  
13 registration after the initial issue;

14          10. D-Day Survivor License Plates - such plates shall be  
15 designed for any resident of this state who can be verified by the  
16 United States Department of Veterans Affairs or the Armed Forces of  
17 the United States as being:

18           a.    a member of the United States Armed Forces on June 6,  
19               1944,

20           b.    a participant in the Allied invasion of the coast of  
21               Normandy on June 6, 1944; provided, if such  
22               participation cannot be verified by the United States  
23               Department of Veterans Affairs or the Armed Forces of  
24               the United States, the Tax Commission may, in its

discretion, accept evidence of such participation from the person applying for the license plate, and

c. a recipient of an honorable discharge from the United States Armed Forces.

Such person may apply for a D-Day Survivor license plate for each vehicle with a rated carrying capacity of one (1) ton or less;

11. Killed in Action License Plates - such plates shall be designed to honor members of the United States Armed Forces who were killed in action. The spouse of the deceased person, if the spouse has not remarried, or if remarried, the remarriage is terminated by death, divorce, or annulment, may apply for a killed in action license plate upon presenting proper certification that the person was killed in action and that the person making the application is the qualifying spouse of the deceased person. The qualifying spouse may apply for a killed in action license plate for no more than two vehicles with each vehicle with a rated carrying capacity of one (1) ton or less. The fee provided by this section for the special license plate authorized by this paragraph shall be in addition to all other registration fees provided by law, except the registration fees levied by Section 1132 of this title;

12. Gold Star Parents License Plates - such plates shall be designed to honor members of the United States Armed Forces who were killed during a war. The parents of the deceased person may apply for a gold star license plate upon presenting proper certification



1 that the person was killed during a war and that the person making  
2 the application is the parent of the deceased person. The parent  
3 may apply for a gold star parent license plate for no more than two  
4 vehicles with each vehicle having a rated carrying capacity of one  
5 (1) ton or less. The fee provided by this section for the special  
6 license plate authorized by this paragraph shall be in addition to  
7 all other registration fees provided by law, except the registration  
8 fees levied by Section 1132 of this title;

9 13. Military Decoration License Plates - such plates shall be  
10 designed for any resident of this state who has been awarded the  
11 Distinguished Service Medal, the Distinguished Service Cross, the  
12 Distinguished Flying Cross, the Bronze Star military decoration or  
13 the Silver Star military decoration. Such persons may apply for a  
14 military decoration license plate for each vehicle with a rated  
15 carrying capacity of one (1) ton or less;

16 14. Vietnam Veteran License Plates - such plates shall be  
17 designed for honorably discharged or present members of the United  
18 States Armed Forces who served in the Vietnam Conflict. Such  
19 persons may apply for a Vietnam veteran license plate for each  
20 vehicle with a rated carrying capacity of one (1) ton or less;

21 15. Police Officer License Plates - such plates shall be  
22 designed for any currently employed, reserve or retired municipal  
23 police officer or full-time, reserve or retired university police  
24 officer certified by the Council on Law Enforcement Education and

1 Training or common education police officer certified by the Council  
2 on Law Enforcement Education and Training. Police officers may  
3 apply for police officer license plates for vehicles with a rated  
4 capacity of one (1) ton or less or for a motorcycle upon proof of  
5 employment by or retirement from a municipal, university or common  
6 education police department by either an identification card or  
7 letter from the chief of the police department or the Oklahoma  
8 Police Pension and Retirement Board. Retirees who are eligible for  
9 such plates shall provide proof of eligibility upon initial  
10 application, but shall not be required to provide proof of  
11 eligibility annually. The license plates shall be designed in  
12 consultation with municipal police departments of this state;  
13 provided, the license plate for motorcycles may be of similar design  
14 to the license plate for motor vehicles or may be a new design in  
15 order to meet space requirements for a motorcycle license plate;

16 16. World War II Veteran License Plates - such plates shall be  
17 designed to honor honorably discharged former members of the United  
18 States Armed Forces who are residents of this state and who can be  
19 verified by the Oklahoma Military Department, the Department of  
20 Veterans Affairs or the Armed Forces of the United States as having  
21 served on federal active duty anytime during the period from  
22 September 16, 1940, to December 7, 1945. The former members may  
23 apply for a World War II Veteran license plate for vehicles with a  
24 rated carrying capacity of one (1) ton or less.

1       The license plate shall have the legend "Oklahoma" and shall  
2 contain, in the center of the plate, either the Thunderbird Insignia  
3 of the 45th Infantry Division in the prescribed red and gold  
4 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,  
5 Marines or Coast Guard according to the branch of service to which  
6 the member belonged. For the purpose of license plate  
7 identification, the plate shall contain four digits, two digits at  
8 the left and two digits at the right of the insignia or emblem.  
9 Centered on the bottom of the license plate shall be the words  
10 "WORLD WAR II";

11       17. Korean War Veteran License Plates - such plates shall be  
12 designed to honor honorably discharged former members of the United  
13 States Armed Forces who are residents of this state and who can be  
14 verified by the Oklahoma Military Department, the Department of  
15 Veterans Affairs or the Armed Forces of the United States as having  
16 served on federal active duty anytime during the period from June  
17 27, 1950, to January 31, 1955, both dates inclusive. The former  
18 members may apply for a Korean War Veteran license plate for  
19 vehicles with a rated carrying capacity of one (1) ton or less.

20       The license plate shall have the legend "OKLAHOMA" and shall  
21 contain, in the center of the plate, either the Thunderbird Insignia  
22 of the 45th Infantry Division in the prescribed red and gold  
23 coloring or the emblem of the Army, Navy, Air Force, Marines or  
24 Coast Guard according to the branch of service to which the member

1 belonged. For the purpose of license plate identification, the  
2 plate shall contain four digits, two digits at the left and two  
3 digits at the right of the insignia or emblem. Centered on the  
4 bottom of the license plate shall be the word "KOREA";

5 18. Municipal Official License Plates - such plates shall be  
6 designed for persons elected to a municipal office in this state and  
7 shall designate the name of the municipality and the district or  
8 ward in which the municipal official serves. The plates shall only  
9 be produced upon application;

10 19. Red Cross Volunteer License Plates - such plates shall be  
11 designed to honor American Red Cross volunteers and staff who are  
12 residents of this state. Such persons must present an  
13 identification card issued by the American Red Cross and bearing a  
14 photograph of the person. The license plate shall be designed with  
15 the assistance of the American Red Cross and shall have the legend  
16 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the  
17 symbol of the American Red Cross and no more than three letters and  
18 three numbers shall be in the color Pantone 186C Red. Below the  
19 symbol and letters and numbers shall be the words "American Red  
20 Cross" in black. The plates shall not be subject to the design  
21 requirements of any other license plates prescribed by law other  
22 than the space for the placement of the yearly decals for each  
23 succeeding year of registration after the initial issue;

1        20. Desert Storm License Plates - such plates shall be designed  
2 and issued to any honorably discharged or present member of the  
3 United States Armed Forces who served in the Persian Gulf Crisis and  
4 the Desert Storm operation. Such persons may apply for a Desert  
5 Storm license plate for each vehicle with a rated carrying capacity  
6 of one (1) ton or less;

7        21. Military Reserve Unit License Plates - such plates shall be  
8 designed and issued to any honorably discharged or present member of  
9 a reserve unit of the United States Armed Forces. Such persons may  
10 apply for a Military Reserve Unit license plate for each vehicle  
11 with a rated carrying capacity of one (1) ton or less;

12        22. Oklahoma City Bombing Victims and Survivors License Plates  
13 - such plates shall be designed and issued to any victim or survivor  
14 of the bombing attack on the Alfred P. Murrah Federal Building in  
15 downtown Oklahoma City on April 19, 1995;

16        23. Civil Air Patrol License Plates - such plates shall be  
17 designed and issued to any person who is a member of the Civil Air  
18 Patrol. Such persons may apply for a Civil Air Patrol license plate  
19 for each vehicle with a rated carrying capacity of one (1) ton or  
20 less upon proof of membership in the Civil Air Patrol. The license  
21 plate shall be designed in consultation with the Civil Air Patrol;

22        24. Ninety-Nines License Plates - such plates shall be designed  
23 and issued to members of the Ninety-Nines. Persons applying for  
24 such license plate must show proof of membership in the Ninety-

1 Nines. The license plates shall be designed in consultation with  
2 the Ninety-Nines;

3 25. Combat Infantryman Badge License Plates - such plates shall  
4 be designed to honor recipients of the Combat Infantryman Badge.  
5 The plate shall have the legend "Oklahoma OK". Below the legend  
6 shall be the Combat Infantryman Badge and three numbers. Below the  
7 badge and the numbers shall be the words "Combat Infantryman Badge".  
8 Such persons may apply for a Combat Infantryman Badge license plate  
9 for each vehicle with a rated carrying capacity of one (1) ton or  
10 less;

11 26. Somalia Combat Veterans License Plates - such plates shall  
12 be designed and issued to any honorably discharged or present member  
13 of the United States Armed Forces who saw combat in the United  
14 Nations relief effort. Such persons may apply for a Somalia Combat  
15 Veteran license plate for each vehicle with a rated carrying  
16 capacity of one (1) ton or less;

17 27. Police Chaplain License Plates - such plates shall be  
18 designed and issued to members of the International Conference of  
19 Police Chaplains (ICPC) who have completed the ICPC requirements for  
20 basic certification as a police chaplain. The license plates shall  
21 be designed in consultation with the ICPC;

22 28. Joint Service Commendation Medal License Plates - such  
23 plates shall be designed and issued to any resident of this state  
24

1 who has been awarded the Joint Service Commendation Medal by the  
2 United States Secretary of Defense;

3 29. Merchant Marine License Plates - such plates shall be  
4 designed, subject to criteria to be presented to the Tax Commission  
5 by the Oklahoma Department of Veterans Affairs, and issued to any  
6 person who during combat was a member of the Merchant Marines as  
7 certified by the Oklahoma Department of Veterans Affairs. Such  
8 license plate may be issued for each vehicle with a rated carrying  
9 capacity of one (1) ton or less;

10 30. Legislative License Plates - such plates shall be designed  
11 for persons elected to the Oklahoma Legislature and shall designate  
12 the house of the Legislature in which the legislator serves and the  
13 district number;

14 31. Disabled Veterans License Plates - such plates shall be  
15 designed for persons presenting proper certification from the United  
16 States Department of Veterans Affairs or the Armed Forces of the  
17 United States certifying such veteran has a service-connected  
18 disability rating of fifty percent (50%) or more, regardless which  
19 agency pays the disability benefits, or that such veteran has been  
20 awarded a vehicle by the United States government or receives a  
21 grant from the United States Department of Veterans Affairs for the  
22 purchase of an automobile due to a service-connected disability  
23 rating or due to the loss of use of a limb or an eye. Such persons  
24 may apply to the Tax Commission for a disabled veterans license

1 plate or to a motor license agent for a regular license plate for no  
2 more than two vehicles with each vehicle having a rated carrying  
3 capacity of one (1) ton or less. The surviving spouse of any  
4 deceased disabled veteran, if the spouse has not since remarried, or  
5 if remarried, the remarriage is terminated by death, divorce, or  
6 annulment, or a surviving spouse in receipt of Dependency and  
7 Indemnity Compensation from the United States Department of Veterans  
8 Affairs, may apply for a disabled veterans license plate for one  
9 vehicle with a rated carrying capacity of one (1) ton or less. The  
10 fee provided by this section for the special license plate  
11 authorized by this paragraph shall be in addition to all other  
12 registration fees provided by law, except the registration fees  
13 levied by Section 1132 of this title. The total expense of this  
14 license plate shall not exceed Five Dollars (\$5.00).

15 If the person qualifies for a disabled veterans license plate  
16 and is also eligible for a physically disabled placard under the  
17 provisions of Section 15-112 of this title, the person shall be  
18 eligible to receive a disabled veterans license plate that also  
19 displays the international accessibility symbol, which is a stylized  
20 human figure in a wheelchair. Upon the death of the disabled  
21 veteran with a disabled veterans license plate with the  
22 international accessibility symbol, the plate shall be returned to  
23 the Tax Commission;



1        32. United States Air Force Association License Plates - such  
2 plates shall be designed for members of the United States Air Force  
3 Association. Persons applying for such license plate must show  
4 proof of membership in the Association. The license plates shall be  
5 designed in consultation with the Association;

6        33. Oklahoma Military Academy Alumni License Plates - such  
7 plates shall be designed and issued to any resident of this state  
8 who is an alumnus of the Oklahoma Military Academy. Such persons  
9 may apply for an Oklahoma Military Academy Alumnus license plate for  
10 each vehicle with a rated carrying capacity of one (1) ton or less.  
11 The license plates shall be designed in consultation with the  
12 Oklahoma Military Academy and shall contain the shield of the  
13 Academy;

14        34. Amateur Radio Operator License Plates - such plates shall  
15 be designed and issued to any person, holding a valid operator's  
16 license, technician class or better, issued by the Federal  
17 Communications Commission, and who is also the owner of a motor  
18 vehicle currently registered in Oklahoma, in which has been  
19 installed amateur mobile transmitting and receiving equipment.  
20 Eligible persons shall be entitled to two special vehicle  
21 identification plates as herein provided. Application for such  
22 identification plates shall be on a form prescribed by the Tax  
23 Commission and the plates issued to such applicant shall have  
24 stamped thereon the word "Oklahoma" and bear the official call

1 letters of the radio station assigned by the Federal Communications  
2 Commission to the individual amateur operator thereof. All  
3 applications for such plates must be made to the Tax Commission on  
4 or before the first day of October of any year for such plates for  
5 the following calendar year and must be accompanied by the fee  
6 required in this section together with a certificate, or such other  
7 evidence as the Tax Commission may require, of proof that applicant  
8 has a valid technician class or better amateur operator's license  
9 and proof of applicant's ownership of a vehicle in which radio  
10 receiving and transmitting equipment is installed. Applicants shall  
11 only be entitled to one set of special identification plates in any  
12 one (1) year, and such calendar year shall be stamped thereon. The  
13 right to such special identification plates herein provided for  
14 shall continue until the amateur radio operator's license of the  
15 person to whom such plates are issued expires or is revoked;

16 35. American Legion License Plates - such plates shall be  
17 designed for members of the American Legion. Persons applying for  
18 such license plate must show proof of membership. The license  
19 plates shall be designed in consultation with the American Legion of  
20 Oklahoma;

21 36. Deputy Sheriff License Plates - such plates shall be  
22 designed for any currently employed or retired county sheriff or  
23 deputy sheriff. County sheriffs or deputy sheriffs may apply for  
24 such plates for vehicles with a rated capacity of one (1) ton or

1 less upon proof of employment by or retirement from a county  
2 sheriff's office by either an identification card or letter from the  
3 county sheriff or a government-sponsored retirement board from which  
4 the county sheriff or deputy sheriff may be receiving a pension.  
5 Retirees who are eligible for such plates shall provide proof of  
6 eligibility upon initial application, but shall not be required to  
7 provide proof of eligibility annually. The license plates shall be  
8 designed in consultation with the county sheriff offices of this  
9 state;

10 37. Gold Star Surviving Spouse License Plates - such plates  
11 shall be designed to honor the surviving spouses and children of  
12 qualified veterans. As used in this paragraph, "qualified veteran"  
13 shall mean:

- 14 a. any person honorably discharged from any branch of the  
15 United States Armed Forces or as a member of the  
16 Oklahoma National Guard, who died as a direct result  
17 of the performance of duties for any branch of the  
18 United States Armed Forces or Oklahoma National Guard  
19 while on active military duty, or
- 20 b. any person honorably discharged from any branch of the  
21 United States Armed Forces or as a member of the  
22 Oklahoma National Guard, who died as a result of  
23 injury, illness or disease caused by the performance  
24 of such duties while on active duty, whether the death

1                   occurred while on active duty or after the honorable  
2                   discharge of such person.

3           The fee provided by this section for the special license plate  
4 authorized by this paragraph shall be in addition to all other  
5 registration fees provided by law, except the registration fees  
6 levied by Section 1132 of this title;

7           38. Korea Defense Service Medal License Plates - such plates  
8 shall be designed and issued to any resident of this state who has  
9 been awarded the Korea Defense Service Medal by the United States  
10 Secretary of Defense. Such persons may apply for a Korea Defense  
11 Service Medal license plate for each vehicle with a rated carrying  
12 capacity of one (1) ton or less;

13           39. 180th Infantry License Plates - such plates shall be  
14 designed for members and prior members of the 180th Infantry.  
15 Persons applying for such license plate must obtain and provide  
16 proof of their membership from the 180th Infantry Association. The  
17 license plates shall be designed in consultation with the 180th  
18 Infantry;

19           40. Operation Iraqi Freedom Veteran License Plates - such  
20 plates shall be designed and issued to any honorably discharged or  
21 present member of the United States Armed Forces who served in  
22 Operation Iraqi Freedom. Such person may apply for an Operation  
23 Iraqi Freedom Veteran license plate for each vehicle with a rated  
24 carrying capacity of one (1) ton or less, or for a motorcycle;

1 provided, the license plate for motorcycles may be of similar design  
2 to the license plate for motor vehicles or may be a new design in  
3 order to meet space requirements for a motorcycle license plate;

4 41. United States Air Force Academy Alumni License Plates -  
5 such plates shall be designed and issued to any resident of this  
6 state who is an alumnus of the United States Air Force Academy.

7 Such persons may apply for a United States Air Force Academy Alumnus  
8 license plate for each vehicle with a rated carrying capacity of one  
9 (1) ton or less;

10 42. Operation Enduring Freedom Veteran License Plate - such  
11 plates shall be designed and issued to any honorably discharged or  
12 present member of the United States Armed Forces who served in  
13 Operation Enduring Freedom on or after September 11, 2001. The  
14 license plate shall be designed in consultation with the Military  
15 Department of the State of Oklahoma. Such person may apply for an  
16 Operation Enduring Freedom Veteran license plate for each vehicle  
17 with a rated carrying capacity of one (1) ton or less, or for a  
18 motorcycle; provided, the license plate for motorcycles may be of  
19 similar design to the license plate for motor vehicles or may be a  
20 new design in order to meet space requirements for a motorcycle  
21 license plate;

22 43. Military Multi-Decoration License Plate - such plates shall  
23 be designed and issued to any honorably discharged or present member  
24 of the United States Armed Forces who qualifies for more than one

1 military decoration license plate pursuant to the provisions of this  
2 section. The Tax Commission shall develop and implement a system  
3 whereby the designs of the eligible license plates can be included  
4 together on a single license plate. Such person may apply for a  
5 Military Multi-Decoration license plate for each vehicle with a  
6 rated carrying capacity of one (1) ton or less;

7 44. Global War on Terror Expeditionary License Plate - such  
8 plates shall be designed and issued to any honorably discharged or  
9 present member of the United States Armed Forces who has earned a  
10 Global War on Terror Expeditionary decoration. The license plate  
11 shall be designed in consultation with the United States Institute  
12 of Heraldry and the Military Department of the State of Oklahoma.  
13 Such person may apply for a Global War on Terror Expeditionary  
14 license plate for each vehicle with a rated carrying capacity of one  
15 (1) ton or less;

16 45. Legion of Merit Medal Recipient License Plates - such  
17 plates shall be designed for any resident of this state presenting  
18 proper certification from the United States Department of Veterans  
19 Affairs or the Armed Forces of the United States certifying that  
20 such resident has been awarded the Legion of Merit military  
21 decoration. Such persons may apply for a Legion of Merit recipient  
22 license plate for vehicles having a rated carrying capacity of one  
23 (1) ton or less. The license plate shall be designed in  
24 consultation with the Military Department of the State of Oklahoma;

1        46. 1-179th License Plates - such plates shall be designed for  
2 members, prior members and members of the household of a member or  
3 former member of the 1-179th Infantry. Persons applying for such  
4 license plate must obtain and provide proof of their membership  
5 association with the 1-179th Infantry Association. The license  
6 plate shall be designed in consultation with the 1-179th Infantry;

7        47. 2-179th License Plates - such plates shall be designed for  
8 members, prior members and members of the household of a member or  
9 former member of the 2-179th Infantry. Persons applying for such  
10 license plate must obtain and provide proof of their membership  
11 association with the 2-179th Infantry Association. The license  
12 plate shall be designed in consultation with the 2-179th Infantry;

13        48. Combat Action Ribbon Recipient License Plates - such plates  
14 shall be designed to honor recipients of the Combat Action Ribbon  
15 who present proper certification from the United States Department  
16 of the Navy. The license plate shall include the Combat Action  
17 Ribbon earned by the recipient. Such persons may apply for a Combat  
18 Action Ribbon Recipient license plate for vehicles having a rated  
19 carrying capacity of one (1) ton or less;

20        49. Oklahoma Submarine Veterans License Plate - such plates  
21 shall be designed for any resident of this state who is a United  
22 States submarine veteran and presents either a Department of Defense  
23 form 214 or other documentation certifying such service. Such  
24 persons may apply for an Oklahoma Submarine Veterans license plate

1 for vehicles having a rated capacity of one (1) ton or less. The  
2 license plate design shall include both gold and silver dolphins to  
3 represent both officer and enlisted service members;

4 50. United States Navy Seabees and Civil Engineer Corps License  
5 Plate - such plates shall be designed and issued to any honorably  
6 discharged or present member of the United States Navy Seabees or  
7 Civil Engineer Corps. Such persons may apply for a United States  
8 Navy Seabees and Civil Engineer Corps license plate for vehicles  
9 having a rated carrying capacity of one (1) ton or less. The  
10 license plate shall be designed in consultation with the Military  
11 Department of the State of Oklahoma;

12 51. Combat Action Badge Recipient License Plate - such plates  
13 shall be designed to honor recipients of the Combat Action Badge who  
14 present proper certification from the United States Army. The  
15 license plate shall include the Combat Action Badge earned by the  
16 recipient. Such persons may apply for a Combat Action Badge  
17 Recipient license plate for vehicles having a rated carrying  
18 capacity of one (1) ton or less, or for a motorcycle; provided, the  
19 license plate for motorcycles may be of similar design to the  
20 license plate for motor vehicles or may be a new design in order to  
21 meet space requirements for a motorcycle license plate;

22 52. Iraq Combat Veteran License Plate - such plates shall be  
23 designed and issued to any honorably discharged or present member of  
24 the United States Armed Forces who saw combat in Operation Iraqi



1 Freedom. Such persons may apply for an Iraq Combat Veteran license  
2 plate for each vehicle with a rated carrying capacity of one (1) ton  
3 or less, or for a motorcycle; provided, the license plate for  
4 motorcycles may be of similar design to the license plate for motor  
5 vehicles or may be a new design in order to meet space requirements  
6 for a motorcycle license plate;

7 53. Afghanistan Combat Veteran License Plate - such plates  
8 shall be designed and issued to any honorably discharged or present  
9 member of the United States Armed Forces who saw combat in Operation  
10 Enduring Freedom. Such persons may apply for an Afghanistan Combat  
11 Veteran license plate for each vehicle with a rated carrying  
12 capacity of one (1) ton or less, or for a motorcycle; provided, the  
13 license plate for motorcycles may be of similar design to the  
14 license plate for motor vehicles or may be a new design in order to  
15 meet space requirements for a motorcycle license plate; and

16 54. Special Forces Association - such plates shall be designed  
17 and issued to any honorably discharged or present member of the Army  
18 Special Forces qualified and authorized to wear upon the person's  
19 United States military uniform the Army Special Forces Tab. Persons  
20 applying for the Special Forces Association license plate must  
21 provide a copy of the orders awarding the Special Forces Tab or  
22 authorizing its wear upon a United States military uniform. The  
23 license plate shall be designed in consultation with the Special  
24 Forces Association, Chapter 32-50. The Tax Commission shall produce

1 up to two distinct designs for the Special Forces Association  
2 license plate. Qualified persons may select one design at the time  
3 of application. The plates shall be issued to any qualified person  
4 in any combination of numbers and letters from one to a maximum of  
5 seven, as for personalized license plates.

6 C. Unless otherwise provided by this section, the fee for such  
7 plates shall be Eight Dollars (\$8.00) and shall be in addition to  
8 all other registration fees provided by the Oklahoma Vehicle License  
9 and Registration Act. Such fees shall be deposited in the Oklahoma  
10 Tax Commission Reimbursement Fund to be used for the administration  
11 of the Oklahoma Vehicle License and Registration Act.

12 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1135.3, as  
13 last amended by Section 2, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
14 2019, Section 1135.3), is amended to read as follows:

15 Section 1135.3 A. The Oklahoma Tax Commission is hereby  
16 authorized to design and issue appropriate official special license  
17 plates to persons wishing to demonstrate support, interest, or  
18 membership to or for an organization, occupation, cause or other  
19 subject as provided by this section.

20 Special license plates shall not be transferred to any other  
21 person but shall be removed from the vehicle upon transfer of  
22 ownership and retained. The special license plate may then be used  
23 on another vehicle but only after such other vehicle has been  
24 registered for the current year.

1 Special license plates shall be renewed each year by the Tax  
2 Commission or a motor license agent, unless authorized by the Tax  
3 Commission to be renewed for a period greater than one (1) year.  
4 The Tax Commission shall notify by mail all persons issued special  
5 license plates. Personalized license plates shall be scheduled to  
6 be renewed on the same month as any regular license plate that may  
7 belong to the same vehicle. The notice shall contain all necessary  
8 information and shall contain instructions for the renewal procedure  
9 upon presentation to a motor license agent or the Tax Commission.  
10 The license plates shall be issued on a staggered system.

11 The Tax Commission is hereby directed to develop and implement a  
12 system whereby motor license agents are permitted to accept  
13 applications for special license plates authorized under this  
14 section. The motor license agent shall confirm the applicant's  
15 eligibility, if applicable, collect and deposit any amount  
16 specifically authorized by law, accept and process the necessary  
17 information directly into such system and generate a receipt  
18 accordingly. For performance of these duties, motor license agents  
19 shall retain the fee provided in Section 1141.1 of this title for  
20 registration of a motor vehicle. The motor license agent fees for  
21 acceptance of applications and renewals shall be paid out of the  
22 Oklahoma Tax Commission Reimbursement Fund.

23 If fewer than one hundred of any type of special license plates  
24 authorized prior to January 1, 2004, are issued prior to January 1,

1 2006, the Tax Commission shall discontinue issuance and renewal of  
2 that type of special license plate. Any such authorized special  
3 license plate registrant shall be allowed to display the license  
4 plate upon the designated vehicle until the registration expiration  
5 date. After such time the expired special license plate shall be  
6 removed from the vehicle.

7 Except as otherwise provided in law, for special license plates  
8 authorized on or after July 1, 2004, no special license plates shall  
9 be developed or issued by the Tax Commission until the Commission  
10 receives one hundred (100) prepaid applications therefor. The  
11 prepaid applications must be received by the Tax Commission within  
12 one hundred eighty (180) days of the effective date of the  
13 authorization or the authority to issue shall be null and void. In  
14 the event one hundred (100) prepaid applications are not received by  
15 the Tax Commission within such prescribed time period any payment so  
16 received shall be refunded accordingly.

17 B. The special license plates provided by this section are as  
18 follows:

19 1. Round and Square Dance License Plate - such plates shall be  
20 designed and issued to any person wishing to demonstrate support for  
21 round and square dancing;

22 2. National Association for the Advancement of Colored People  
23 License Plate - such plates shall be designed, subject to the  
24

1 criteria to be presented to the Tax Commission by the NAACP, and  
2 issued to any person wishing to demonstrate support for the NAACP;

3 3. National Rifle Association License Plate - such plates shall  
4 be designed, subject to the criteria to be presented to the Tax  
5 Commission by the National Rifle Association, and issued to any  
6 person wishing to demonstrate support for the National Rifle  
7 Association;

8 4. Masonic Fraternity License Plate - such plates shall be  
9 designed and issued to any resident of this state who is a member of  
10 a Masonic Fraternity of Oklahoma. Such persons may apply for a  
11 Masonic Fraternity license plate for each vehicle with a rated  
12 carrying capacity of one (1) ton or less upon proof of a Masonic  
13 Fraternity membership or upon the presentment of an application for  
14 a Masonic Fraternity license plate authorized and approved by the  
15 Grand Lodge of Oklahoma. The license plates shall be designed in  
16 consultation with the Masonic Fraternities of Oklahoma and shall  
17 contain the Masonic emblem;

18 5. Shriner's Hospitals for Burned and Crippled Children License  
19 Plate - such plates shall be designed to demonstrate support for  
20 Shriner's Hospitals for Burned and Crippled Children and shall be  
21 issued to any resident of this state who is a member of a Shriner's  
22 Temple in Oklahoma. The license plate shall be designed in  
23 consultation with the Shriner's Temples in Oklahoma and shall  
24 contain the Shriner's emblem;

1       6. Balloonists License Plate - such plates shall be designed  
2 and issued to any person wishing to demonstrate support for hot air  
3 ballooning in this state;

4       7. Order of the Eastern Star License Plate - such plates shall  
5 be designed and issued to any resident of this state who is a member  
6 of an Order of the Eastern Star. Such persons may apply for an  
7 Order of the Eastern Star license plate for each vehicle with a  
8 rated carrying capacity of one (1) ton or less upon proof of an  
9 Order of the Eastern Star membership or upon the presentment of an  
10 application for an Order of the Eastern Star license plate  
11 authorized and approved by the organization. The license plate  
12 shall be designed in consultation with the Order of the Eastern Star  
13 and shall contain the Order of the Eastern Star emblem;

14       8. Knights of Columbus License Plate - such plates shall be  
15 designed and issued to any resident of this state who is a member of  
16 the Knights of Columbus. Such persons may apply for a Knights of  
17 Columbus license plate for each vehicle with a rated carrying  
18 capacity of one (1) ton or less upon proof of a Knights of Columbus  
19 membership or upon the presentment of an application for a Knights  
20 of Columbus license plate authorized and approved by the  
21 organization. The license plate shall be designed in consultation  
22 with the Knights of Columbus and shall contain the Knights of  
23 Columbus emblem;

1        9. Jaycees License Plate - such plates shall be designed and  
2 issued to members of the Jaycees. Persons applying for such license  
3 plate must show proof of membership in the Jaycees. The license  
4 plates shall be designed in consultation with the Jaycees;

5        10. Kiwanis International License Plate - such plates shall be  
6 designed and issued to members of Kiwanis International. Persons  
7 applying for such license plate must show proof of membership in  
8 Kiwanis International. The license plates shall be designed in  
9 consultation with Kiwanis International;

10       11. Certified Public Accountants License Plate - such plates  
11 shall be designed and issued to any resident of this state who is a  
12 Certified Public Accountant. Such persons may apply for a Certified  
13 Public Accountant license plate for each vehicle with a rated  
14 carrying capacity of one (1) ton or less upon proof of status as a  
15 Certified Public Accountant. The license plates shall be designed  
16 in consultation with the Oklahoma Society of Certified Public  
17 Accountants;

18       12. Civil Emergency Management License Plate - such plates  
19 shall be designed and issued to persons wishing to demonstrate  
20 support for the state civil emergency management system. Persons  
21 applying for such license plate must show proof of official  
22 affiliation by presenting a nonexpired proof of employment,  
23 affiliation or retirement in the form of an identification card or  
24

1 letter on official letterhead from a municipal, county or state  
2 emergency management department head;

3 13. Civilian Conservation Corps License Plate - such plates  
4 shall be designed, subject to criteria to be presented to the Tax  
5 Commission, by the Civilian Conservation Corps Association, and  
6 issued to any person wishing to demonstrate support of the Civilian  
7 Conservation Corps;

8 14. Rotarian License Plate - such plates shall be designed and  
9 issued to any resident of this state who is a member of a Rotarian  
10 Club of Oklahoma. Such persons may apply for a Rotarian license  
11 plate for each vehicle with a rated carrying capacity of one (1) ton  
12 or less upon proof of a Rotarian Club membership or upon the  
13 presentment of an application for a Rotarian license plate  
14 authorized and approved by a Rotarian Club of Oklahoma. The license  
15 plates shall be designed in consultation with the five Rotarian  
16 District Governors and shall contain the Rotarian emblem;

17 15. Benevolent Protective Order of Elks License Plate - such  
18 plates shall be designed, subject to criteria to be presented to the  
19 Tax Commission, by the Benevolent Protective Order of Elks, and  
20 issued to any resident of this state who is a member of the  
21 Benevolent Protective Order of Elks;

22 16. Humane Society License Plate - such plates shall be  
23 designed and issued to any person wishing to demonstrate support for  
24 the Humane Society of the United States. The plates shall be issued



1 to any person in any combination of numbers and letters from one to  
2 a maximum of seven, as for personalized license plates. The plate  
3 shall contain the official Humane Society logo;

4 17. Oklahoma Mustang Club License Plate - such plates shall be  
5 designed, subject to criteria to be presented to the Tax Commission,  
6 by the Oklahoma Mustang Club, and issued to any resident of this  
7 state who is a member of the Oklahoma Mustang Club. Such persons  
8 may apply for an Oklahoma Mustang Club license plate upon  
9 presentment of proof of membership in the Oklahoma Mustang Club.  
10 The plates shall be issued to any person in any combination of  
11 numbers and letters from one to a maximum of seven, as for  
12 personalized license plates;

13 18. American Business Clubs (AMBUCS) License Plate - such  
14 plates shall be designed and issued to members of American Business  
15 Clubs. Persons applying for such license plate must show proof of  
16 membership in AMBUCS. The license plates shall be designed in  
17 consultation with American Business Clubs;

18 19. West Point 200th Anniversary License Plate - such plates  
19 shall be designed and issued to any person wishing to commemorate  
20 the Two Hundredth Anniversary of the founding of the United States  
21 Military Academy at West Point, New York. The license plates shall  
22 be designed in consultation with the West Point Society of Central  
23 Oklahoma;

1        20. Oklahoma Aquarium License Plate - such plates shall be  
2 designed and issued to persons wishing to demonstrate support for  
3 the Oklahoma Aquarium. The license plates shall be designed in  
4 consultation with the Oklahoma Aquarium;

5        21. The Pride of Broken Arrow License Plate - such plates shall  
6 be designed and issued to any person wishing to demonstrate support

23 designed and issued to persons wishing to demonstrate support for  
24 Oklahoma's electric linemen. The license plates shall be designed

1 in consultation with the Oklahoma Electric Superintendent's  
2 Association;

3 26. Alpha Kappa Alpha License Plate - such plates shall be  
4 designed and issued to any person who is a member of Alpha Kappa  
5 Alpha Sorority. The license plates shall be designed in  
6 consultation with the Oklahoma Chapter of Alpha Kappa Alpha  
7 Sorority;

8 27. The National Pan-Hellenic Council Incorporated License  
9 Plate - such plates shall be designed and issued to any person  
10 wishing to demonstrate support to any of the nine sororities and  
11 fraternities recognized by the National Pan-Hellenic Council  
12 Incorporated. The license plates shall be designed in consultation  
13 with the Oklahoma Chapter of the National Pan-Hellenic Council  
14 Incorporated;

15 28. Organ, Eye and Tissue License Plate - such plates shall be  
16 designed and issued to persons wishing to demonstrate support and  
17 increase awareness for organ, eye and tissue donation. The license  
18 plates shall be designed in consultation with the State Department  
19 of Health;

20 29. Central Oklahoma Habitat for Humanity License Plate - such  
21 plates shall be designed and issued to persons wishing to  
22 demonstrate support and increase awareness for Habitat for Humanity.  
23 The license plate shall be designed in consultation with Central  
24 Oklahoma Habitat for Humanity;

1        30. Family Career and Community Leaders of America Incorporated  
2 License Plate - such plates shall be designed and issued to persons  
3 wishing to demonstrate support for Family Career and Community  
4 Leaders of America Incorporated. The license plates shall be  
5 designed in consultation with Family Career and Community Leaders of  
6 America Incorporated;

7        31. Delta Sigma Theta License Plate - such plates shall be  
8 designed and issued to any person who is a member of Delta Sigma

12 Subject to the provisions of subsection A of this section, the Sigma  
13 Gamma Rho License Plate is hereby reauthorized effective November 1,

15 37. Multiple Sclerosis License Plate - such plates shall be  
16 designed and issued to persons wishing to demonstrate support for  
17 and increase awareness of multiple sclerosis. The license plates  
18 shall be designed in consultation with the Oklahoma Chapter of the  
19 National Multiple Sclerosis Society;

20 38. Frederick Douglass High School License Plate - such plates  
21 shall be designed and issued to any person wishing to demonstrate  
22 support for Frederick Douglass High School located in Oklahoma City.  
23 The plates shall be designed in consultation with representatives of  
24 Frederick Douglass High School National Alumni Association;

1        39. United States Air Force Academy License Plate - such plates  
2 shall be designed and issued to any person wishing to demonstrate  
3 support for the United States Air Force Academy;

4        40. In God We Trust License Plate - such plates shall be  
5 designed to include the motto, "In God We Trust", and shall be  
6 issued to any person wishing to demonstrate support for the motto;

7        41. National Weather Center License Plate - such plates shall  
8 be designed and issued to any person wishing to demonstrate support  
9 for the National Weather Center in Norman. The plates shall be  
10 designed in consultation with representatives of the National

1        49. Northeast High School License Plate - such plates shall be  
2 designed and issued to any person wishing to demonstrate support for  
3 Northeast High School located in Oklahoma City. The plates shall be  
4 designed in consultation with representatives of the Northeast High  
5 School Alumni Association;

6        50. Oklahoma City Central High School License Plate - such  
7 plates shall be designed and issued to any person wishing to  
8 demonstrate support for the Oklahoma City Central High School Alumni  
9 Association. The plates shall be designed in consultation with  
10 representatives of the Oklahoma City Central High School Alumni  
11 Association;

12        51. Oklahoma Rifle Association License Plate - such plates  
13 shall be designed and issued to any person wishing to demonstrate  
14 support for the Oklahoma Rifle Association. The plates shall be  
15 designed in consultation with representatives of the Oklahoma Rifle  
16 Association;

17        52. Oklahoma City Thunder License Plate - such plates shall be  
18 designed and issued to any person wishing to demonstrate support for  
19 the Oklahoma City Thunder. The license plate shall be designed in  
20 consultation with the Oklahoma City Thunder organization;

21        53. Ovarian Cancer Awareness License Plate - such plates shall  
22 be designed and issued to any person wishing to increase awareness  
23 of ovarian cancer. The license plate shall be designed in  
24 consultation with the HOPE in Oklahoma organization;



1        54. BMW Car Club of America License Plate - such plates shall  
2 be designed and issued to any person wishing to demonstrate support  
3 for the BMW Car Club of America. The plates shall be issued to any  
4 person in any combination of numbers and letters from one to a  
5 maximum of seven, as for personalized license plates. The license  
6 plate shall be designed in consultation with the Sunbelt Chapter of  
7 the BMW Car Club of America. Subject to the provisions of  
8 subsection A of this section, the BMW Car Club of America License  
9 Plate is hereby reauthorized effective November 1, 2013;

10       55. Don't Tread On Me License Plate - such plates shall be  
11 designed to include the yellow background and rattlesnake emblem  
12 above the motto "DON'T TREAD ON ME" as found on the historic Gadsden  
13 flag, and shall be issued to any person wishing to demonstrate  
14 support for the freedom and liberty of the Republic;

15       56. Oklahomans for the Arts License Plate - such plates shall  
16 be designed and issued to any person wishing to demonstrate support  
17 for arts, culture and creative industries as well as arts education.  
18 The plates shall be designed in consultation with Oklahomans for the  
19 Arts;

20       57. Oklahoma City Barons License Plate - such plates shall be  
21 designed and issued to any person wishing to demonstrate support for  
22 the Oklahoma City Barons. The license plate shall be designed in  
23 consultation with the Oklahoma City Barons organization. The  
24

1 license plates shall be issued to any person in any combination of  
2 numbers and letters from one to a maximum of six;

3 58. Oklahoma City Redhawks License Plate - such plates shall be  
4 designed and issued to any person wishing to demonstrate support for  
5 the Oklahoma City Redhawks. The license plate shall be designed in  
6 consultation with the Oklahoma City Redhawks organization;

7 59. Tulsa Shock License Plate - such plates shall be designed  
8 and issued to any person wishing to demonstrate support for the  
9 Tulsa Shock. The license plate shall be designed in consultation  
10 with the Tulsa Shock organization;

11 60. Tulsa Oilers License Plate - such plates shall be designed  
12 and issued to any person wishing to demonstrate support for the  
13 Tulsa Oilers. The license plate shall be designed in consultation  
14 with the Tulsa Oilers organization;

15 61. Tulsa Drillers License Plate - such plates shall be  
16 designed and issued to any person wishing to demonstrate support for  
17 the Tulsa Drillers. The license plate shall be designed in  
18 consultation with the Tulsa Drillers organization;

19 62. Millwood School District License Plate - such plates shall  
20 be designed and issued to any person wishing to demonstrate support  
21 for the Millwood School District. The license plate shall be  
22 designed in consultation with representatives of the Millwood School  
23 District;

24

1       63. Booker T. Washington High School License Plate - such  
2 plates shall be issued to persons wishing to demonstrate support for  
3 Booker T. Washington High School and shall be designed in  
4 consultation with the Booker T. Washington High School National  
5 Alumni Association;

6       64. Oklahoma Current State Flag License Plate - such plates  
7 shall be designed to include the current Oklahoma state flag and  
8 issued to any person wishing to demonstrate support for the current  
9 Oklahoma state flag. The plates shall be designed in consultation  
10 with the Friends of the Oklahoma History Center;

11       65. Oklahoma Original State Flag License Plate - such plates  
12 shall be designed to include the original Oklahoma state flag and  
13 issued to any person wishing to demonstrate support for the original  
14 Oklahoma state flag. The plates shall be designed in consultation  
15 with the Friends of the Oklahoma History Center. The plates shall  
16 be issued to any person in any combination of numbers and letters  
17 from one to a maximum of seven, as for personalized plates. Subject  
18 to the provisions of subsection A of this section, the Oklahoma  
19 Original State Flag license plate is hereby reauthorized effective  
20 November 1, 2015;

21       66. Tulsa 66ers License Plate - such plates shall be designed  
22 and issued to any person wishing to demonstrate support for the  
23 Tulsa 66ers. The plates shall be designed in consultation with the  
24 Tulsa 66ers Organization;

1        67. Frederick Bombers License Plate - such plates shall be  
2 issued to persons wishing to demonstrate support for the Frederick  
3 School District and shall be designed in consultation with  
4 representatives of the Frederick School District;

5        68. 911 Dispatcher License Plate - such plates shall be issued  
6 to persons wishing to demonstrate support for 911 dispatchers.  
7 Persons applying for such license plate must show proof of current  
8 employment as a 911 dispatcher or sign an attestation that they are  
9 a currently employed or retired 911 dispatcher;

10       69. Oklahoma Fosters License Plate - such plates shall be  
11 issued to persons wishing to demonstrate support for the Oklahoma  
12 Fosters Initiative and shall be designed in consultation with the  
13 Oklahoma Fosters Initiative;

14       70. Red Dirt Jeeps License Plate - such plates shall be  
15 designed and issued to any person wishing to demonstrate support for  
16 Red Dirt Jeeps and such plates shall be designed in consultation  
17 with Red Dirt Jeeps, L.L.C.;

18       71. Sons of the American Revolution License Plate - such plates  
19 shall be issued to persons wishing to demonstrate support for the  
20 Sons of the American Revolution for a vehicle or motorcycle in any  
21 combination of numbers and letters from one to a maximum of seven,  
22 as for personalized plates. Such plates shall be designed in  
23 consultation with the Oklahoma Society of the Sons of the American  
24 Revolution. The license plate for a motorcycle may be of similar

1 design as space permits or a new design in order to meet the space  
2 requirements of a motorcycle license plate;

3 72. Daughters of the American Revolution License Plate - such  
4 plates shall be issued to persons wishing to demonstrate support for  
5 the Daughters of the American Revolution for a vehicle or motorcycle  
6 in any combination of numbers and letters from one to a maximum of  
7 seven, as for personalized plates. Such plates shall be designed in  
8 consultation with the Oklahoma Society of the Daughters of the  
9 American Revolution. The license plate for a motorcycle may be of  
10 similar design as space permits or a new design in order to meet the  
11 space requirements of a motorcycle license plate;

12 73. Air Medal License Plate - such plates shall be designed and  
13 issued to Air Medal recipients. An individual requesting the plate  
14 is required, at the time of application, to show proof he or she is  
15 a recipient of the Air Medal or sign an attestation stating that he  
16 or she is a medal recipient. The plates shall be designed to  
17 include the Air Medal emblem and shall include the words "Air Medal"  
18 on the plate;

19 74. Oklahoma Institute for Child Advocacy License Plate - such  
20 plates shall be designed and issued to any person wishing to  
21 demonstrate support for the Oklahoma Institute for Child Advocacy.  
22 The plates shall be issued to any person in any combination of  
23 numbers and letters from one to a maximum of seven, as for  
24

1 personalized license plates. The plates shall contain the official  
2 Oklahoma Institute for Child Advocacy logo;

3 75. The Pride of Oklahoma Marching Band License Plate - such  
4 plates shall be designed and issued to any person wishing to  
5 demonstrate support for the Pride of Oklahoma marching band. The  
6 plates shall be designed in consultation with the University of  
7 Oklahoma;

8 76. The Spirit of Oklahoma State Marching Band License Plate -  
9 such plates shall be designed and issued to any person wishing to  
10 demonstrate support for the Spirit of Oklahoma State marching band.  
11 The plates shall be designed in consultation with Oklahoma State  
12 University;

13 77. Southeast Spartans License Plate - such plates shall be  
14 designed and issued to any person wishing to demonstrate support for  
15 Southeast High School Spartans and such plates shall be designed in  
16 consultation with the Southeast High School Alumni Association;

17 78. Catoosa High School License Plate - such plates shall be  
18 designed and issued to any person wishing to demonstrate support for  
19 Catoosa High School located in Catoosa. The plates shall bear the  
20 image of the Catoosa High School mascot and be designed in  
21 consultation with representatives of Catoosa High School;

22 79. Toastmasters International License Plate - such plates  
23 shall be issued to persons wishing to demonstrate support for  
24

1 Toastmasters International and shall be designed in consultation  
2 with District 16 of Toastmasters International;

3 80. Millwood High School Alumni License Plate - such plates  
4 shall be designed and issued to any person wishing to demonstrate  
5 support for Millwood High School Alumni. The license plate shall be  
6 designed in consultation with representatives of the Millwood High  
7 School Alumni Association;

8 81. Patriot Guard Riders License Plate - such plates shall be  
9 issued to persons wishing to demonstrate support for Patriot Guard  
10 Riders and shall be designed in consultation with the Patriot Guard  
11 Riders of Oklahoma; and

12 82. Bixby School District License Plate - such plates shall be  
13 designed and issued to any person wishing to demonstrate support for  
14 the Bixby School District. The license plate shall be designed in  
15 consultation with representatives of the Bixby School District.

16 C. The fee for such plates shall be Fifteen Dollars (\$15.00)  
17 per year of renewal and shall be in addition to all other  
18 registration fees provided by the Oklahoma Vehicle License and  
19 Registration Act. Unless otherwise provided in this section, the  
20 fee shall be apportioned as follows: Eight Dollars (\$8.00) per year  
21 of renewal of the special license plate fee shall be deposited in  
22 the Oklahoma Tax Commission Reimbursement Fund to be used for the  
23 administration of the Oklahoma Vehicle License and Registration Act  
24 and the remaining Seven Dollars (\$7.00) per year of renewal of the

1 special license plate fee shall be apportioned as provided in  
2 Section 1104 of this title.

3 SECTION 3. AMENDATORY 47 O.S. 2011, Section 1135.4, as  
4 amended by Section 3, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2019,  
5 Section 1135.4), is amended to read as follows:

6 Section 1135.4 A. The Oklahoma Tax Commission is hereby  
7 authorized to design and issue personalized license plates. The  
8 personalized license plates shall be issued on a staggered system  
9 except for vintage decals.

10 Personalized special license plates shall not be transferred to  
11 any other person but shall be removed from the vehicle upon transfer  
12 of ownership and retained. The personalized special license plate  
13 may then be used on another vehicle but only after such other  
14 vehicle has been registered for the current year.

15 Personalized special license plates shall be renewed each year  
16 by the Tax Commission or a motor license agent, unless authorized by  
17 the Tax Commission to be renewed for a period greater than one (1)  
18 year. The Tax Commission shall notify by mail all persons issued  
19 special license plates. Personalized license plates shall be  
20 scheduled to be renewed on the same month as any regular license  
21 plate that may belong to the same vehicle. The notice shall contain

22 all necessary information and shall contain instructions for the  
23 renewal procedure upon presentation to a motor license agent or the  
24



1 Tax Commission. The motor license agent fees for renewals shall be  
2 paid out of the Oklahoma Tax Commission Reimbursement Fund.

3 B. Such plates shall be designed and issued for the following:

4 1. Any person in any combination of numbers or letters from one  
5 to a maximum of seven;

6 2. Persons eligible for two or more of the military decoration  
7 special license plates provided for in this title. Such plates may  
8 be issued in any combination of emblems. However, such plates shall  
9 only display up to three emblems and shall also display any  
10 combination of letters or numbers from one to a maximum of three;

11 3. Motorcycles in any combination of numbers or letters from  
12 one to a maximum of six;

13 4. Persons eligible for Korean War Veteran license plates  
14 provided for in this title. Such plates may display any combination  
15 of letters or numbers up to three on each side of the insignia or  
16 emblem;

17 5. Persons eligible for World War II Veteran license plates  
18 provided for in this title. Such plates may display any combination  
19 of letters or numbers up to three on each side of the insignia or  
20 emblem; and

21 6. Persons owning vehicles which are twenty-one (21) years and  
22 older are qualified to submit for approval by the Tax Commission or  
23 a motor license agent a vintage but expired official Oklahoma  
24 license plate which is twenty-one (21) years and older. Upon

1 approval of such personalized plate, the owner shall be issued the  
2 annual registration decal which the Tax Commission or agent shall  
3 direct to be affixed.

4 C. The fee for such plates shall be Twenty Dollars (\$20.00) per  
5 year of renewal and shall be in addition to all other registration  
6 fees provided by the Oklahoma Vehicle License and Registration Act.  
7 Eight Dollars (\$8.00) per year of renewal of the personalized tag  
8 fee shall be deposited in the Oklahoma Tax Commission Reimbursement  
9 Fund to be used for the administration of the Oklahoma Vehicle  
10 License and Registration Act. Twelve Dollars (\$12.00) per year of  
11 renewal of the personalized tag fee shall be apportioned as provided  
12 in Section 1104 of this title.

13 SECTION 4. AMENDATORY 47 O.S. 2011, Section 1135.5, as  
14 last amended by Section 3, Chapter 434, O.S.L. 2019 (47 O.S. Supp.  
15 2019, Section 1135.5), is amended to read as follows:

16 Section 1135.5 A. The Oklahoma Tax Commission is hereby  
17 authorized to design and issue appropriate official special license  
18 plates to persons wishing to demonstrate support and provide  
19 financial assistance as provided by this section.

20 Special license plates shall not be transferred to any other  
21 person but shall be removed from the vehicle upon transfer of  
22 ownership and retained. The special license plate may then be used  
23 on another vehicle but only after such other vehicle has been  
24 registered for the current year with a motor license agent.

1 Special license plates shall be renewed each year by the Tax  
2 Commission or a motor license agent, unless authorized by the Tax  
3 Commission to be renewed for a period greater than one (1) year.  
4 The Tax Commission shall notify by mail all persons issued special  
5 license plates. Personalized license plates shall be scheduled to  
6 be renewed on the same month as any regular license plate that may  
7 belong to the same vehicle. The notice shall contain all necessary  
8 information and shall contain instructions for the renewal procedure  
9 upon presentation to a motor license agent or the Tax Commission.  
10 The license plates shall be issued on a staggered system.

11 The Tax Commission is hereby directed to develop and implement a  
12 system whereby motor license agents are permitted to accept  
13 applications for special license plates authorized under this  
14 section. The motor license agent shall confirm the applicant's  
15 eligibility, if applicable, collect and deposit any amount  
16 specifically authorized by law, accept and process the necessary  
17 information directly into such system and generate a receipt  
18 accordingly. For performance of these duties, motor license agents  
19 shall retain the fee provided in Section 1141.1 of this title for  
20 registration of a motor vehicle. The motor license agent fees for  
21 acceptance of applications and renewals shall be paid out of the  
22 Oklahoma Tax Commission Reimbursement Fund.

23 If fewer than one hundred of any type of special license plates  
24 authorized prior to January 1, 2004, are issued prior to January 1,

1 2006, the Tax Commission shall discontinue issuance and renewal of  
2 that type of special license plate. Any such authorized special  
3 license plate registrant shall be allowed to display the license  
4 plate upon the designated vehicle until the registration expiration  
5 date. After such time the expired special license plate shall be  
6 removed from the vehicle.

7 For special license plates authorized on or after July 1, 2004,  
8 no special license plates shall be developed or issued by the Tax  
9 Commission until the Commission receives one hundred prepaid  
10 applications therefor. The prepaid applications must be received by  
11 the Tax Commission within one hundred eighty (180) days of the  
12 effective date of the authorization or the authority to issue shall  
13 be null and void. In the event one hundred prepaid applications are  
14 not received by the Tax Commission within such prescribed time  
15 period any payment so received shall be refunded accordingly.

16 B. The special license plates provided by this section are as  
17 follows:

18 1. University or College Supporter License Plate - such plates  
19 shall be designed and issued to any person wishing to demonstrate  
20 support to any state-supported or private university or college. As  
21 provided in this section, an amount of the fee collected shall be  
22 apportioned as provided in Section 1104.1 of this title;

23 2. Environmental Awareness License Plate - such plates shall be  
24 designed, subject to the criteria to be presented to the Tax

1 Commission by the Department of Environmental Quality in  
2 consultation with the Oklahoma Arts Council, and issued to any  
3 person wishing to demonstrate support to implement the statewide  
4 general public environmental education program created pursuant to  
5 the provisions of the Oklahoma Environmental Quality Code. Such  
6 plates shall be designed and issued to any person in any combination  
7 of numbers and letters from one to a maximum of seven, as for  
8 personalized license plates. A dealer's license plate issued  
9 pursuant to Section 1116.1 or 1128 of this title may be designated  
10 an Environmental Awareness License Plate upon payment of the fee  
11 imposed by this section and any other registration fees required by  
12 the Oklahoma Vehicle License and Registration Act. As provided in  
13 this section, an amount of the fee collected shall be apportioned  
14 pursuant to Section 1104.2 of this title;

15 3. Firefighter License Plate - such plates shall be designed  
16 for any career or retired firefighter, volunteer or paid.  
17 Firefighters may apply for firefighter plates for up to four  
18 vehicles with a rated capacity of one (1) ton or less or for a  
19 motorcycle upon proof of a fire department membership by either an  
20 identification card or letter from the chief of the fire department.  
21 Retirees who are eligible for such plates shall provide proof of  
22 eligibility upon initial application, but shall not be required to  
23 provide proof of eligibility annually. The surviving spouse of any  
24 deceased firefighter, if the spouse has not since remarried, may

1 apply for a firefighter license plate for one vehicle with a rated  
2 carrying capacity of one (1) ton or less or for a motorcycle upon  
3 proof that the deceased firefighter was a member of a fire  
4 department by either an identification card or letter from the chief  
5 of the fire department. The license plate shall be designed in  
6 consultation with the Oklahoma Firefighters Association.

7 As provided in this section, an amount of the fee collected  
8 shall be deposited to the Oklahoma State Firemen's Museum Building &  
9 Memorial Fund for support of the Oklahoma Firefighters Museum and  
10 the Oklahoma Fallen and Living Firefighters Memorial;

11 4. Wildlife Conservation License Plate - such plates shall be  
12 designed, subject to the criteria to be presented to the Tax  
13 Commission by the Oklahoma Department of Wildlife Conservation in  
14 consultation with the Oklahoma Arts Council, and issued to any  
15 person wishing to demonstrate support for wildlife conservation in  
16 this state through the Wildlife Diversity Fund, provided for in  
17 Section 3-310 of Title 29 of the Oklahoma Statutes. Such plates may  
18 be designed and issued to any person as for personalized license  
19 plates.

20 As provided in this section, an amount of the fee collected  
21 shall be apportioned pursuant to subsection D of Section 3-310 of  
22 Title 29 of the Oklahoma Statutes;

23 5. Child Abuse Prevention License Plate - such plates shall be  
24 designed, subject to the criteria to be presented to the Tax

1 Commission by the Office of Child Abuse Prevention in the State  
2 Department of Health and the Oklahoma Committee to Prevent Child  
3 Abuse, and issued to any person wishing to demonstrate support for  
4 the prevention of child abuse.

5 As provided in this section, an amount of the fee collected  
6 shall be deposited in the Child Abuse Prevention Fund;

7 6. United States Olympic Committee Supporter License Plate -  
8 such plates shall be designed and issued to any person wishing to  
9 demonstrate support for the United States Olympic Committee. The  
10 plates shall be issued to any person in any combination of numbers  
11 and letters from one to a maximum of seven, as for personalized  
12 license plates. The plate shall contain the official United States  
13 Olympic Committee logo. The Tax Commission shall be authorized, if  
14 necessary, to enter into a licensing agreement with the United  
15 States Olympic Committee for any licensing fees which may be  
16 required in order to use the United States Olympic Committee logo or  
17 design. The licensing agreement shall provide for a payment of not  
18 more than Twenty-five Dollars (\$25.00) for each license plate  
19 issued;

20 7. Oklahoma History License Plate - such plates shall be  
21 designed and issued to any person wishing to demonstrate interest in  
22 Oklahoma history. As provided in this section, an amount of the fee  
23 collected shall be deposited to the Oklahoma Historical Society  
24 Revolving Fund to be used for educational purposes;

1       8. Historic Route 66 License Plate - such:

2           a. vehicle plates shall be designed to honor historic  
3           Route 66, also known as the "Mother Road". As  
4           provided in this section, an amount of the fee  
5           collected for each vehicle license plate shall be  
6           apportioned to the Oklahoma Historical Society  
7           Revolving Fund to be distributed to the Route 66  
8           Museum located in Clinton, Oklahoma, and

9           b. motorcycle plates shall be designed in consultation  
10          with the Oklahoma Route 66 Association, Inc. The  
11          Oklahoma Tax Commission shall be authorized to enter  
12          into a licensing agreement with the Oklahoma Route 66  
13          Association, Inc., for any licensing fees which may be  
14          required in order to use the Oklahoma Route 66  
15          Association, Inc., logo or design. The licensing  
16          agreement shall provide for a payment to the Oklahoma  
17          Route 66 Association, Inc., of not more than Twenty  
18          Dollars (\$20.00) for each motorcycle license plate  
19          issued;

20       9. Heart of the Heartland License Plate - such plates shall be  
21       designed and issued to any person wishing to honor the victims of  
22       the terrorist bombing attack on the Alfred P. Murrah Federal  
23       Building in downtown Oklahoma City on April 19, 1995. As provided  
24       in this section, an amount of the fee collected shall be deposited



1 in the Heart of the Heartland Scholarship Fund, as established in  
2 Section 2282 of Title 70 of the Oklahoma Statutes;

3 10. Emergency Medical Technician License Plate - such plates  
4 shall be designed and issued to any person who is an emergency  
5 medical technician. Such persons may apply for an emergency medical  
6 technician license plate for each vehicle with a rated carrying  
7 capacity of one (1) ton or less upon proof of an emergency medical  
8 technician's license. The license plate shall be designed in  
9 consultation with the state association of emergency medical  
10 technicians. As provided in this section, an amount of the fee  
11 collected shall be apportioned to the Emergency Medical Personnel  
12 Death Benefit Revolving Fund created in Section 1-2505.2 of Title 63  
13 of the Oklahoma Statutes;

14 11. Fight Breast Cancer License Plate - such plates shall be  
15 designed to demonstrate support for the prevention and treatment of  
16 breast cancer in this state. As provided in this section, an amount  
17 of the fee collected shall be apportioned to the Breast Cancer Act  
18 Revolving Fund;

19 12. Crime Victims Awareness License Plate - such plates shall  
20 be designed and issued to any person wishing to demonstrate  
21 awareness of and support for victims of crimes. The license plates  
22 shall be designed in consultation with the Oklahoma Crime Victims  
23 Centre. As provided in this section, an amount of the fee collected  
24 shall be apportioned to the Attorney General's Revolving Fund for

1 the Office of the Attorney General, which is hereby directed to use  
2 such funds to contract with a statewide nonprofit organization to  
3 provide services to crime victims;

4 13. Oklahoma Safe Kids Association License Plate - such plates  
5 shall be designed and issued to any person wishing to demonstrate  
6 support and awareness of the Oklahoma Safe Kids Association. The  
7 license plate shall be designed in consultation with the Oklahoma  
8 Safe Kids Association. As provided in this section, an amount of  
9 the fee collected shall be deposited in the Children's Hospital -  
10 Oklahoma Safe Kids Association Revolving Fund to be distributed to  
11 the Oklahoma Safe Kids Association program;

12 14. Four-H Club License Plate - such plates shall be designed,  
13 subject to criteria to be presented to the Tax Commission by the  
14 Four-H Foundation, and issued to any person wishing to demonstrate  
15 support of the Four-H Club. Such plates may be designed and issued  
16 to any person as for personalized license plates. As provided in

20 15. Agricultural Awareness License Plate - such plates shall be  
21 designed, subject to criteria to be presented to the Tax Commission,  
22 by the Oklahoma Department of Agriculture, Food, and Forestry in  
23 consultation with the Oklahoma Arts Council, and issued to any  
24 person wishing to demonstrate support of the Department's Ag in the

1 Classroom Education Program. As provided in this section, an amount  
2 of the fee collected shall be apportioned as provided in Section  
3 1104.3 of this title;

4 16. Oklahoma Statehood Centennial License Plate - such plates  
5 shall be designed and issued to any person wishing to commemorate  
6 the centennial of Oklahoma's admission to statehood in 1907. The  
7 license plates shall be designed in consultation with the Oklahoma  
8 Capitol Complex and Centennial Commemoration Commission. As  
9 provided in this section, an amount of the fee collected shall be  
10 deposited in the Oklahoma Capitol Complex and Centennial  
11 Commemoration Commission Revolving Fund created in Section 98.5 of  
12 Title 73 of the Oklahoma Statutes;

13 17. Support Education License Plate - such plates shall be  
14 designed, subject to criteria to be presented to the Tax Commission  
15 by the State Department of Education in consultation with the  
16 Oklahoma Arts Council, and issued to any person wishing to  
17 demonstrate support for education in this state. All motor license  
18 agents shall display a sample of the Support Education License plate  
19 in the area of the business accessed by the public. Twenty-three  
20 Dollars (\$23.00) of the fee collected shall be apportioned as  
21 follows:

- 22 a. five percent (5%) shall be deposited to the Education

13 shall contain the official Boy Scouts of America logo. The Tax  
14 Commission shall be authorized, if necessary, to enter into a  
15 licensing agreement with the Boy Scouts of America for any licensing  
16 fees which may be required in order to use the Boy Scouts of America  
17 logo or design. The licensing agreement shall provide for a payment  
18 to the Boy Scouts of America of not more than Twenty Dollars  
19 (\$20.00) for each license plate issued;

20 20. Urban Forestry and Beautification License Plate - such  
21 plates shall be designed, subject to criteria to be presented to the  
22 Tax Commission, by the Oklahoma Department of Agriculture, Food, and

1 beautification, and issued to any person wishing to demonstrate  
2 support of such programs. As provided in this section, an amount of  
3 the fee collected shall be apportioned as provided in Section 1104.5  
4 of this title;

5 21. Oklahoma State Parks Supporter License Plate - such plates  
6 shall be designed, subject to criteria to be presented to the Tax  
7 Commission by the Oklahoma Tourism and Recreation Department, and  
8 issued to any person wishing to demonstrate support for the Oklahoma  
9 state parks system. Twenty-three Dollars (\$23.00) of the fee  
10 collected shall be deposited in the Oklahoma Tourism and Recreation  
11 Department Revolving Fund. Such money shall be designated for and  
12 may only be expended for the support of Oklahoma state parks;

13 22. Adoption Creates Families License Plate - such plates shall  
14 be issued to any person wishing to demonstrate support of pregnant  
15 women who are committed to placing their children for adoption and  
16 wishing to provide assistance to guardians, adoptive parents and

18 children in permanent, safe homes. The license plates shall be  
19 designed and final terminology delivered in consultation with the  
20 Oklahoma Adoption Coalition and the Department of Human Services.  
21 Twenty-five Dollars (\$25.00) of the fee collected shall be deposited  
22 in a revolving fund established in the State Treasury for and to be  
23 used by the Department of Human Services for the implementation of

3 23. Choose Life License Plate - such plates shall be designed,  
4 subject to criteria presented to the Tax Commission, by Choose Life,

7 with unplanned pregnancies. As provided in this section, an amount  
8 of the fee collected shall be deposited in the Choose Life  
9 Assistance Program Revolving Fund established in Section 1104.6 of  
10 this title;

11 24. Future Farmers of America License Plate - such plates shall  
12 be designed and issued to persons wishing to demonstrate support for  
13 the Oklahoma FFA (formerly known as Future Farmers of America). The  
14 license plates shall be designed in consultation with the Oklahoma  
15 FFA Foundation Board of Directors. As provided in this section, an  
16 amount of the fee collected shall be apportioned as provided in  
17 Section 1104.7 of this title;

18 25. Lions Club License Plate - such plates shall be designed  
19 and issued to persons wishing to demonstrate support for the Lions  
20 Club of Oklahoma. The plates shall be issued to any person in any  
21 combination of numbers and letters from one to a maximum of seven,  
22 as for personalized license plates. The license plates shall be  
23 designed in consultation with the Oklahoma Lions Service Foundation  
24 and shall contain the official logo of the International Association

1 of Lions Clubs. The Tax Commission shall be authorized to enter  
2 into a licensing agreement with the Oklahoma Lions Service  
3 Foundation. The licensing agreement shall provide for a payment to  
4 the Oklahoma Lions Service Foundation of not more than Ten Dollars  
5 (\$10.00) for each license plate issued;

6 26. Color Oklahoma License Plate - such plates shall be  
7 designed, subject to criteria to be presented to the Tax Commission  
8 by the Oklahoma Native Plant Society, and issued to any person  
9 wishing to demonstrate support for preserving and planting  
10 wildflowers and native plants in Oklahoma and to promote Oklahoma's  
11 wildflower heritage through education. As provided in this section,  
12 an amount of the fee collected shall be apportioned as provided in  
13 Section 1104.8 of this title;

14 27. Girl Scouts of the United States of America Supporter  
15 License Plate - such plates shall be designed and issued to any  
16 person wishing to demonstrate support for the Girl Scouts of the  
17 United States of America. The plates shall be issued to any person  
18 in any combination of numbers and letters from one to a maximum of  
19 seven, as for personalized license plates. The plate shall contain  
20 the official Girl Scouts of the United States of America logo. The  
21 Tax Commission shall be authorized, if necessary, to enter into a  
22 licensing agreement with the Girl Scouts of the United States of  
23 America for any licensing fees which may be required in order to use  
24 the Girl Scouts of the United States of America logo or design. The



1 licensing agreement shall provide for a payment to the Girl Scouts

3 deposited in the Oklahoma Quarter Horse Revolving Fund created in

5 36. Oklahoma Association for the Deaf License Plate - such  
6 plates shall be designed in consultation with the Oklahoma  
7 Association for the Deaf and issued to any person wishing to  
8 demonstrate support for Oklahoma residents who are deaf. The plates  
9 shall be issued to any person in any combination of numbers and  
10 letters from one to a maximum of seven, as for personalized license  
11 plates. As provided in this section, a portion of the fee collected  
12 shall be deposited in the Oklahoma Association for the Deaf License  
13 Plate Revolving Fund created in Section 1104.15 of this title;

14 37. Oklahoma City Zoo License Plate - such plates shall be  
15 issued to any person wishing to demonstrate support for the Oklahoma  
16 City Zoo. The license plates shall be designed in consultation with  
17 the Oklahoma Zoological Society, Inc. As provided in this section,  
18 an amount of the fee collected shall be deposited in the Oklahoma  
19 Zoological Society Revolving Fund created in Section 1104.13 of this  
20 title;

21 38. March of Dimes License Plate - such plates shall be issued  
22 to persons wishing to demonstrate support for the March of Dimes  
23 mission to improve the health of babies by preventing birth defects,  
24 premature birth and infant mortality. The license plates shall be

1 designed in consultation with the Oklahoma Chapter March of Dimes.  
2 As provided in this section, an amount of the fee collected shall be  
3 deposited in the Oklahoma Prevent Birth Defects, Premature Birth and  
4 Infant Mortality Fund established in Section 1104.14 of this title;

5 39. Support Our Troops Supporter License Plate - such plates  
6 shall be designed and issued to any person wishing to demonstrate  
7 support for Support Our Troops Incorporated. The plates shall be  
8 issued to any person in any combination of numbers and letters from  
9 one to a maximum of six. The plate shall contain the official  
10 Support Our Troops Incorporated logo which includes the mark  
11 "Support Our Troops" across the bottom of the plate. The Tax  
12 Commission, if necessary, may enter into a licensing agreement with  
13 Support Our Troops Incorporated for any licensing fees which may be  
14 required in order to use the Support Our Troops Incorporated logo or  
15 design. The licensing agreement shall provide for a payment to  
16 Support Our Troops Incorporated of Twenty-five Dollars (\$25.00) for  
17 each license plate issued;

18 40. Folds of Honor Supporter License Plate - such plates shall  
19 be authorized to be designed and issued to any person wishing to  
20 demonstrate support for the Oklahoma City Chapter of Folds of Honor  
21 Incorporated, a nonprofit charitable organization exempt from  
22 taxation pursuant to the provisions of the Internal Revenue Code, 26  
23 U.S.C., Section 501(c)(3), providing educational scholarships to  
24 spouses and children of America's fallen and disabled military

1 service members. The plates shall be issued to any person in any  
2 combination of numbers and letters from one to a maximum of six.  
3 Such person may apply for a Folds of Honor Supporter license plate  
4 for a motorcycle; provided, the license plate for motorcycles may be

5 Foundation. The Tax Commission shall be authorized to enter into a  
6 licensing agreement with the Veterans of Foreign Wars Foundation for  
7 any licensing fees which may be required in order to use the  
8 foundation's logo or design. The licensing agreement shall provide  
9 for a payment to the Veterans of Foreign Wars Foundation of not more  
10 than Twenty Dollars (\$20.00) for each license plate issued;

11       95. Oklahoma Women Veterans Organization License Plate - such  
12 plates shall be designed and issued to any female veteran of any  
13 branch of the United States Armed Forces wishing to demonstrate  
14 support for the Oklahoma Women Veterans Organization. The license  
15 plates shall be designed in consultation with the Oklahoma Women  
16 Veterans Organization. The Tax Commission shall be authorized to  
17 enter into a licensing agreement with the Oklahoma Women Veterans  
18 Organization for any licensing fees which may be required in order  
19 to use the organization's logo or design. The licensing agreement  
20 shall provide for a payment to the Oklahoma Women Veterans  
21 Organization of not more than Twenty Dollars (\$20.00) for each  
22 license plate issued;

23       96. FIRST (For Inspiration and Recognition of Science and  
24 Technology) License Plate - such plates shall be issued to any

1 person wishing to demonstrate support for FIRST Robotics Programs.  
2 The license plates shall be designed in consultation with the  
3 administration of FIRST. The Oklahoma Tax Commission shall be  
4 authorized to enter into a licensing agreement with FIRST for any  
5 licensing fees which may be required in order to use the FIRST logo  
6 or design. The licensing agreement shall provide for a payment to  
7 FIRST of not more than Twenty Dollars (\$20.00) for each license  
8 plate issued;

9 97. Pittsburg State University License Plate - such plates  
10 shall be designed and issued to any person wishing to demonstrate  
11 support for the Pittsburg State University. The license plates  
12 shall be designed in consultation with Pittsburg State University.  
13 The Tax Commission shall be authorized to enter into a licensing  
14 agreement with Pittsburg State University for any licensing fees  
15 which may be required in order to use the school foundation's logo  
16 or design. The licensing agreement shall provide for a payment to  
17 the Pittsburg State University of not more than Twenty Dollars  
18 (\$20.00) for each license plate issued; and

19 98. Historic Greenwood District License Plate - such plates  
20 shall be issued to persons wishing to demonstrate support for the  
21 Historic Greenwood District Juneteenth Festival held in the Historic  
22 Greenwood District in Tulsa, Oklahoma. The plates shall be issued  
23 to any person in any combination of numbers and letters from one to  
24 a maximum of seven, as for personalized license plates. The license

1 plates shall be designed in consultation with the Black Wall Street  
2 Chamber of Commerce. Twenty-five Dollars (\$25.00) of the fee  
3 collected shall be deposited in the Historic Greenwood  
4 District/Juneteenth Festival Revolving Fund established in Section 5  
5 ~~of this act~~ 2368.32 of Title 68 of the Oklahoma Statutes. Two  
6 Dollars (\$2.00) of the fee collected shall be deposited in the  
7 Public School Classroom Support Revolving Fund, for expenditure as  
8 provided in Section 1-123 of Title 70 of the Oklahoma Statutes.

9 C. The fee for such plates shall be Thirty-five Dollars  
10 (\$35.00) per year of renewal and shall be in addition to all other  
11 registration fees provided by the Oklahoma Vehicle License and  
12 Registration Act. The fee shall be apportioned as follows:

13 1. Twenty Dollars (\$20.00) per year of renewal or any other  
14 amount as provided in this title of the fee shall be apportioned as  
15 provided or deposited in a fund as specified within the paragraph  
16 authorizing the special license plate;

17 2. Eight Dollars (\$8.00) per year of renewal of the fee shall  
18 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be  
19 used for the administration of the Oklahoma Vehicle License and  
20 Registration Act; and

21 3. Any remaining amounts of the fee shall be apportioned as  
22 provided in Section 1104 of this title.

23 SECTION 5. AMENDATORY 47 O.S. 2011, Section 1135.6, is  
24 amended to read as follows:



1       Section 1135.6   The Oklahoma Tax Commission is hereby authorized  
2 to design and issue National Association for Stock Car Auto Racing  
3 Driver ("NASCAR") Theme License Plates.   Such plates shall be  
4 designed and issued to any person wishing to demonstrate interest in  
5 NASCAR auto racing.   The plates shall be of such design as the  
6 supplier of the license plates in consultation with the Oklahoma Tax  
7 Commission may prescribe.   The fee for such plate shall be Forty  
8 Dollars (\$40.00) and shall be in addition to all other registration  
9 fees required by the Oklahoma Vehicle License and Registration Act.  
10 The Tax Commission shall be authorized to enter into a licensing  
11 agreement with the supplier of such NASCAR Driver license plates or  
12 other entity for any required licensing fees.   The licensing  
13 agreement shall provide for a payment of not more than Twenty-five  
14 percent (25%) of the fee authorized for each license plate issued.  
15 Five Dollars (\$5.00) of the forty-dollar fee shall be apportioned to  
16 the General Revenue Fund.   The remaining amount of such fee shall be  
17 deposited in the Oklahoma Tax Commission Reimbursement Fund.

18       For license plates numbered zero (0) through one hundred (100)  
19 displaying a particular NASCAR Driver theme, the Oklahoma Tax  
20 Commission may establish an auction or similar procedure for the  
21 purpose of determining the order in which such distinctive license  
22 plates are sold and the amount of the additional fee for the  
23 distinctive license plates.   This amount shall be due at the time  
24 the original application is submitted to the Tax Commission and

Forty Dollars (\$40.00) thereafter annually at the time of renewal registration. NASCAR Driver license plates shall be scheduled to be renewed on the same month as any regular license plate that may belong to the same vehicle.

SECTION 6. AMENDATORY 47 O.S. 2011, Section 1135.7, as amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2019, Section 1135.7), is amended to read as follows:

Section 1135.7 A. The Oklahoma Tax Commission or private vendor with whom the Commission has contracted is authorized to design and issue special license plates to any person that applies to the Tax Commission or private vendor for the creation of a special license plate and meets the minimum standards and qualifications specified in this section.

B. If the following standards and guidelines are satisfied, the Tax Commission shall authorize the issuance of a special license plate to the person making application for the special license plate:

1. The license plate is to:

a. show membership in or affiliation with an organization, or

b. demonstrate support for an organization, group or cause;

2. The license plate does not advertise or endorse a product, brand, or service that is provided for sale;

1        3. The license plate does not promote any philosophy based on  
2 prejudice or that is contrary to state civil rights laws; and

3        4. Two hundred prepaid applications for the special license  
4 plate are received by the Tax Commission or private vendor.

5        C. The fee for special license plates shall be determined in  
6 accordance with Section ~~4~~ 1135.9 of this ~~act~~ title. If the special  
7 license plate does not provide financial assistance the fee shall be  
8 no less than Fifteen Dollars (\$15.00) per year of renewal and shall  
9 be in addition to all other registration fees provided by the  
10 Oklahoma Vehicle License and Registration Act. Unless otherwise  
11 provided in this section, Fifteen Dollars (\$15.00) of the fee shall  
12 be apportioned as follows: Eight Dollars (\$8.00) of the special  
13 license plate fee shall be deposited in the Oklahoma Tax Commission  
14 Reimbursement Fund to be used for the administration of the Oklahoma  
15 Vehicle License and Registration Act and the remaining amounts of  
16 the special license plate fee shall be apportioned as provided in  
17 Section 1104 of this title.

18        D. The fee for special license plates that provide financial  
19 assistance shall be determined in accordance with Section ~~4~~ 1135.9  
20 of this ~~act~~ title. Provided, the fee shall be no less than Thirty-  
21 five Dollars (\$35.00) and shall be in addition to all other  
22 registration fees provided by the Oklahoma Vehicle License and  
23 Registration Act. Thirty-five Dollars (\$35.00) per year of renewal  
24 of the fee shall be apportioned as follows:

1        1. Twenty Dollars (\$20.00) of the fee shall be apportioned to  
2 the License Plate Special Program Assistance Revolving Fund created  
3 in Section 1135.8 of this title to be used in the manner detailed in  
4 the application for the special license plate;

5        2. Eight Dollars (\$8.00) of the fee shall be deposited in the  
6 Oklahoma Tax Commission Reimbursement Fund to be used for the  
7 administration of the Oklahoma Vehicle License and Registration Act;  
8 and

9        3. Any remaining amounts of the fee shall be apportioned as  
10 provided in Section 1104 of this title.

11        E. If a person applies for a special license plate that  
12 provides financial assistance, the application shall designate a  
13 state agency to be responsible for expending the funds generated by  
14 the special license plate and the application shall designate a  
15 specific public purpose for which the funds are to be used. The  
16 application shall include an acknowledgment from the designated  
17 state agency of their agreement with acceptance of the designated  
18 funds.

19        F. Special license plates shall not be transferred to any other  
20 person but shall be removed from the vehicle upon transfer of  
21 ownership and retained. The special license plate may then be used  
22 on another vehicle but only after such other vehicle has been  
23 registered for the current year.

1 Special license plates shall be renewed each year by the Tax  
2 Commission or a motor license agent, unless authorized by the Tax  
3 Commission to be renewed for a period greater than one (1) year.  
4 The Tax Commission shall notify all persons issued special license  
5 plates of the renewal procedures prior to the expiration of the  
6 special license plate. Special license plates shall be scheduled to  
7 be renewed on the same month as any regular license plate that may  
8 belong to the same vehicle. The notice shall contain all necessary  
9 information and shall contain instructions for the renewal procedure  
10 upon presentation to a motor license agent or the Tax Commission.  
11 The license plates shall be issued on a staggered system.

12 The Tax Commission is hereby directed to develop and implement a  
13 system whereby motor license agents are permitted to accept  
14 applications for special license plates authorized under this  
15 section. The motor license agent shall confirm the applicant's  
16 eligibility, if applicable, collect and deposit any amount  
17 specifically authorized by law, accept and process the necessary  
18 information directly into such system and generate a receipt  
19 accordingly. For performance of these duties, motor license agents  
20 shall retain the fee provided in Section 1141.1 of this title for  
21 registration of a motor vehicle. The motor license agent fees for  
22 acceptance of applications and renewals shall be paid out of the  
23 Oklahoma Tax Commission Reimbursement Fund.

1 G. All special plates issued by the Tax Commission prior to the  
2 effective date of this act shall not be subject to the requirements  
3 and qualifications outlined in this section.

4 H. As used in this section, "person" includes an individual,  
5 group, organization or not-for-profit corporation that is recognized  
6 as such by the Internal Revenue Service.

7 SECTION 7. This act shall become effective November 1, 2020.
