A BILL

To amend title 49, United States Code, to expand the priorities of the Administrator of the Federal Aviation Administration in developing plans and policy for the use of the navigable airspace.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Fairness in Airspace
- 5 Includes Residents Act" or the "F-AIR Act".

SEC. 2. SOVEREIGNTY AND USE OF AIRSPACE.

- 2 (a) In General.—Section 40103(b)(1) of title 49,
- 3 United States Code, is amended to read as follows:
- 4 "(1)(A) The Administrator of the Federal Aviation
- 5 Administration shall develop plans and policy for the use
- 6 of the navigable airspace and assign by regulation or order
- 7 the use of the airspace necessary to ensure—
- 8 "(i) as a primary priority, the safety of aircraft;
- 9 and
- 10 "(ii) as secondary co-equal priorities—
- 11 "(I) the efficient use of airspace; and
- 12 "(II) the minimization of the impact of
- aviation noise, and other health impacts, on
- residents and communities, and other impacts
- of the use of airspace on the environment.
- 16 "(B) The Administrator may modify or revoke an as-
- 17 signment when required in the public interest.".
- 18 (b) Updates to FAA Priorities.—Not later than
- 19 12 months after the date of enactment of this Act, the
- 20 Administrator of the Federal Aviation Administration
- 21 shall—
- 22 (1) review the regulations, policies, procedures,
- and processes of the Administration and modify
- them as necessary to reflect the priorities in clauses
- 25 (i) and (ii) of section 40103(b)(1)(A) of title 49,
- 26 United States Code, as added by subsection (a); and

- 1 (2) update the mission statement of the Admin-
- 2 istration to reflect such priorities.
