A BILL

To permit the Secretary of Veterans Affairs to establish a grant program to conduct cemetery research and produce educational materials for the Veterans Legacy Program.

Be it enacted by the Senate and House of Representa-
tives of the United States of America in Congress assembled,
SECTION 1. GRANTS FOR CEMETERY RESEARCH AND THE
PRODUCTION OF EDUCATIONAL MATERIALS.
(a) Grants Authorized.—
(1) IN GENERAL.—The Secretary of Veterans Af-
fairs may establish a grant program to conduct ceme-
tery research and produce educational materials for
the Veterans Legacy Program.
(2) ELIGIBLE RECIPIENTS.—The Secretary may
award a grant under this section to any of the fol-
lowing entities:
(A) An institution of higher learning.
(B) A local education agency.
(C) A non-profit entity that the Secretary
determines has a demonstrated history of com-
munity engagement.
(D) Another recipient the Secretary deter-
mines to be appropriate.
(3) Use of funds.—A recipient of a grant
under this section may use the grant amount to—
(A) conduct research related to national,
State, or Tribal veterans' cemeteries;
