BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows: Article - State Government 4–114. (A) INTHIS SECTION. "DASHBOARD" MEANS THE **PROCUREMENT DASHBOARD** DEVELOPED AND MAINTAINED BY THE COMPTROLLER. TRANSPARENCY DATA DASHBOARD REQUIRED TO BE PUBLISHED ON THE BOARD OF PUBLIC WORKS' WEBSITE IN ACCORDANCE WITH THIS SECTION.
