Compensation for Individuals Erroneously Convicted - Alterations

- 3 FOR the purpose of altering certain benefits that a certain individual who has been 4 erroneously convicted of a crime is entitled to receive; requiring the State to notify a 5 certain individual of certain information in writing under certain circumstances 6 when the State intends to reduce or prevent an award of compensation to the individual; altering circumstances under which an individual may receive 7 8 compensation; repealing obsolete provisions of law relating to the filing of a certain 9 petition for compensation; and generally relating to compensation for individuals 10 who have been erroneously convicted of committing crimes.

- 16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

- (a) (1) On receipt of an order by an administrative law judge granting a petition under subsection (b) of this section, the Board of Public Works shall compensate an individual erroneously convicted, sentenced, and confined under State law for a crime the individual did not commit in an amount equal to the product of the total number of days that the individual was wrongfully confined after the erroneous conviction multiplied by a
- 25 daily rate of the State's most recent annual median household income as published in the



- 1 American Community Survey of the U.S. Census Bureau in the year the order of eligibility
- 2 is issued under subsection (b) of this section and divided by 365 days to the nearest whole
- 3 cent.



- 4 (2) In addition to the compensation awarded under paragraph (1) of this 5 subsection, the administrative law judge issuing an order under subsection (b) of this 6 section may direct the appropriate State agency or service provider to provide to the 7 individual free of charge any of the following benefits:
- 8 (i) a State identification card and any other document necessary for 9 the individual's health or welfare on the individual's release from confinement;
- 10 (ii) housing accommodations [available on the individual's release 11 from confinement] for a period not exceeding 5 years AFTER THE DATE THE ORDER OF 12 ELIGIBILITY IS ISSUED UNDER SUBSECTION (B) OF THIS SECTION:
