FOR the purpose of authorizing a county board of education to decrease the length of the
school year for each school day affected by a declared state of emergency for certain
public schools without approval of the State Board of Education; repealing a
provision of law authorizing the State Board to open schools on holidays in the case
of emergency; making conforming changes; and generally relating to the length of
the school year.
