## A BILL ENTITLED

1 AN ACT concerning

## 2 Environment – On–Site Sewage Disposal Systems – Nonprofit Campgrounds

FOR the purpose of requiring the Department of the Environment to authorize a certain nonprofit campground to use certain on-site sewage disposal systems under certain circumstances; prohibiting the Department from applying certain criteria to a nonprofit campground; providing that certain requirements for using the best available technology for nitrogen removal do not apply to a nonprofit campground; defining certain terms; and generally relating to the use of on-site sewage disposal systems at nonprofit campgrounds.

- 19(A)(1)IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS20INDICATED.
- 21 (2) "CAMPSITE" MEANS A PORTION OF A NONPROFIT CAMPGROUND 22 WITH CONNECTIONS TO WATER SUPPLY, ELECTRICAL SERVICE, AND ON-SITE 23 SEWAGE DISPOSAL SYSTEMS.
