A BILL

To reauthorize the Great Lakes Fish and Wildlife
Restoration Act of 1990, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Great Lakes Fish and*
5 *Wildlife Restoration Reauthorization Act of 2021”.*

6 **SEC. 2. REAUTHORIZATION OF THE GREAT LAKES FISH AND**
7 **WILDLIFE RESTORATION ACT OF 1990.**

8 *(a) REPORTS.—Section 1008 of the Great Lakes Fish*
9 *and Wildlife Restoration Act of 1990 (16 U.S.C. 941f) is*
10 *amended—*

11 *(1) in subsection (a), in the matter preceding*
12 *paragraph (1)—*

13 *(A) by inserting “and not later than De-*
14 *cember 31, 2027,” after “2021,”;*

15 *(B) by striking “Committee on Resources”*
16 *and inserting “Committee on Natural Re-*
17 *sources”; and*

18 *(C) by inserting “, with respect to the pe-*
19 *riod covered by the report” after “describes”; and*

20 *(2) in subsection (b), in the matter preceding*
21 *paragraph (1), by striking “2016 through 2020” and*
22 *inserting “2022 through 2027”.*

23 *(b) REAUTHORIZATION.—Section 1009(a) of the Great*
24 *Lakes Fish and Wildlife Restoration Act of 1990 (16 U.S.C.*
25 *941g(a)) is amended, in the matter preceding paragraph*

1 (1), by striking “2016 through 2021” and inserting “2022
2 through 2027”.

3 (c) *ADMINISTRATIVE COSTS.*—Section 1009(a)(1)(B)
4 of the *Great Lakes Fish and Wildlife Restoration Act of*
5 *1990 (16 U.S.C. 941g(a)(1)(B))* is amended by striking “5”
6 and inserting “3”.
