1 In this subtitle the following words have the meanings indicated. (a) (N-1) "HYBRID GAME OF CHANCE" MEANS A GAMBLING GAME IN WHICH A 2 3 COMBINATION OF THE ELEMENTS OF CHANCE AND THE SKILL OF THE PLAYER MAY AFFECT THE OUTCOME OF THE GAME. 4 5 "Video lottery terminal" means any machine or other device that, on (1) 6 insertion of a bill, coin, token, voucher, ticket, coupon, or similar item, or on payment of any 7 consideration: 8 (i) is available to play or simulate the play of: 9 1. any game of chance in which the results, including the 10 options available to the player, are randomly determined by the machine or other device; 11 OR 12 2. ANY HYBRID GAME OF CHANCE IN WHICH THE 13 OPTIONS AVAILABLE TO THE PLAYER ARE RANDOMLY DETERMINED BY THE 14 MACHINE OR OTHER DEVICE; and 15 (ii) by the element of chance OR A COMBINATION OF THE ELEMENTS OF CHANCE AND THE SKILL OF THE PLAYER, may deliver or entitle the 16 player who operates the machine or device to receive cash, premiums, merchandise, tokens, 17 18 or anything of value, whether the payout is made automatically from the device or in any other manner. 19 20 (2)"Video lottery terminal" includes a machine or device: 21that does not directly dispense money, tokens, or anything of (i) 22value to winning players; and 23 described under paragraph (1) of this subsection that uses an electronic credit system making the deposit of bills, coins, or tokens unnecessary. 2425"Video lottery terminal" does not include an authorized slot machine (3)26operated by an eligible organization under Title 12, Subtitle 3 of the Criminal Law Article. 27 SECTION 2.
