## RESOLUTION

Directing the Secretary of Homeland Security to transmit certain documents to the House of Representatives relating to Department of Homeland Security policies and activities relating to businesses owned or controlled by President Donald J. Trump.

1       *Resolved*, That, not later than 14 days after the date  
2 of the adoption of this resolution, the Secretary of Home-  
3 land Security is directed to transmit to the House of Rep-  
4 resentatives, to the extent that such information is in the  
5 possession of the Secretary, copies of any document,  
6 record, memo, correspondence, or other communication of

1 the Department of Homeland Security or any portion of  
2 any such communication, that refers or relates to the fol-  
3 lowing:

4 (1) Any documentation of a payment that, on  
5 its face, refers to a business owned or controlled by  
6 Donald J. Trump, the Trump Organization or any  
7 of its subsidiaries, or any member of the Trump  
8 family in the past three years.

9 (2) Any documentation of an expenditure by the  
10 Department that, on its face, is identified as being  
11 made for services or goods from a business owned or  
12 controlled by Donald J. Trump, the Trump Organi-  
13 zation or any of its subsidiaries, or any member of  
14 the Trump family.

15 (3) Any documentation of costs to the Depart-  
16 ment associated with the protection of Donald J.  
17 Trump, Melania Trump, Donald J. Trump, Jr.,  
18 Ivanka Trump, Jared Kushner, Eric Trump, or any  
19 other member of the Trump family or Trump Orga-  
20 nization while on international travel that has not  
21 been documented by the Secretary as in furtherance  
22 of the United States Government.

23 (4) Any documentation of costs to the Depart-  
24 ment associated with Eric Trump's trip to Uruguay  
25 in January 2017.

1           (5) Any documentation of costs to the Depart-  
2           ment associated with Eric Trump's trip to the Do-  
3           minican Republic in February 2017.

4           (6) Any documentation of costs to the Depart-  
5           ment associated with Donald Trump, Jr., and Eric  
6           Trump's trip to the United Arab Emirates in Feb-  
7           ruary 2017.

8           (7) Any documentation of costs to the Depart-  
9           ment associated with Donald Trump, Jr.'s and Eric  
10          Trump's trip to Canada in February 2017.

11          (8) Any documentation of costs to the Depart-  
12          ment associated with Eric Trump's trip to the  
13          United Kingdom and the Republic of Ireland in  
14          April 2017.

15          (9) Any documentation referencing guidance,  
16          directive, or analysis of any expenditure described in  
17          paragraph (1).
