## A BILL

To amend the Animal Welfare Act to provide for the humane treatment of dogs, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Puppy Protection Act
- 5 of 2017".
- 6 SEC. 2. ADDITIONAL REQUIREMENTS FOR DOGS IN DEALER
- 7 FACILITIES.
- 8 (a) Humane Treatment of Dogs in Dealer Fa-
- 9 CILITIES.—Section 13(a) of The Animal Welfare Act (7

1	U.S.C. 2143(a)) is amended by adding at the end the fol-
2	lowing new paragraph:
3	"(9) In addition to the requirements under paragraph
4	(2), the standards described in paragraph (1) shall, with
5	respect to dogs in a dealer facility, include requirements—
6	"(A) that such dealer facility provide adequate
7	housing for dogs that includes—
8	"(i) completely solid flooring;
9	"(ii) sufficient indoor space to allow the
10	tallest dog in an enclosure to stand on his or
11	her hind legs without touching the roof of the
12	enclosure;
13	"(iii) with respect to dogs over 8 weeks in
14	age, primary enclosures that, with the length of
15	the dog measured from the tip of the nose to
16	the base of the tail, provide at least—
17	"(I) 12 square feet of indoor floor
18	space per each dog up to 25 inches long
19	"(II) 20 square feet of indoor floor
20	space per each dog between 25 and 35
21	inches long; and
22	"(III) 30 square feet of indoor floor
23	space per each dog 35 inches and longer

1	"(iv) enclosures that are not stacked or
2	otherwise placed on top of or below another en-
3	closure; and
4	"(v) temperature control that—
5	"(I) is appropriate for the age, breed,
6	and condition of the dogs in the enclosure;
7	and
8	"(II) is between 45 and 85 degrees
9	Fahrenheit, when dogs are present in the
10	enclosure;
11	"(B) that appropriate and nutritious food be
12	fed at least twice per day, in an amount sufficient
13	to maintain the good health and physical condition
14	of each dog;
15	"(C) for continuous access to potable water
16	that is not frozen and is free of feces, algae, and
17	other contaminants be available;
18	"(D) for adequate exercise, including—
19	"(i) for dogs over the age of 12 weeks, un-
20	fettered access from their primary enclosures
21	during daylight hours to an outdoor exercise
22	area that is—
23	"(I) at ground-level;
24	"(II) a solid surface;

1	"(III) enclosed (by a fence or other
2	structure);
3	"(IV) properly controlled for the safe-
4	ty of the dogs; and
5	"(V) at least two times the space re-
6	quired for a dog under subparagraph
7	(A)(iii); or
8	"(ii) if the dealer obtains a certification
9	from the attending veterinarian stating that the
10	dog should not have unfettered access to an
11	outdoor exercise area for a specific medical rea-
12	son, an alternative and appropriate exercise
13	plan prescribed by the veterinarian for the dog
14	that meets the requirements under section 3.8a
15	of title 9, Code of Federal Regulations;
16	"(E) for at least 30 minutes each day of mean-
17	ingful socialization with humans and compatible
18	dogs that—
19	"(i) includes positive interaction with a
20	human such as petting, stroking, grooming,
21	feeding, playing with, exercising, or other
22	touching of the dog that is beneficial to the
23	well-being of the dog; and
24	"(ii) does not include time spent in veteri-
25	nary care;

1	"(F) that each dog receive adequate veterinary
2	care, including—
3	"(i) a hands-on examination by a licensed
4	veterinarian at least once each year;
5	"(ii) core vaccinations recommended by the
6	current version of the American Animal Hos-
7	pital Association Canine Vaccination Guidelines;
8	and
9	"(iii) medications to prevent intestinal
10	parasites, heartworm disease, fleas, and ticks
11	that are approved by a licensed veterinarian for
12	canine use;
13	"(G) for safe breeding practices, including—
14	"(i) a screening program for known preva-
15	lent inheritable diseases that may be disabling
16	or likely to significantly affect the lifespan or
17	quality of life of the offspring;
18	"(ii) prohibiting breeding, unless each dog
19	bred is free from health conditions that may be
20	disabling to, or likely to significantly affect the
21	lifespan or quality of life of, the offspring (as
22	documented by a licensed veterinarian upon ex-
23	amination);
24	"(iii) prohibiting the breeding of a female
25	$\operatorname{dog}$ —

1	"(I) to produce more than two litters
2	in any 18-month period; or
3	"(II) more than 6 litters in that dog's
4	lifetime;
5	"(iv) that female dogs of small breeds
6	(weighing less than 40 pounds when fully ma-
7	ture) not be bred—
8	"(I) before reaching the age of 18
9	months; or
10	"(II) after reaching the age of 9
11	years;
12	"(v) that female dogs of large breeds
13	(weighing 40 pounds or more when fully ma-
14	ture) not be bred—
15	"(I) before reaching the age of 2
16	years; or
17	"(II) after reaching the age of 7
18	years; and
19	"(vi) that any canine caesarian section be
20	performed by a licensed veterinarian; and
21	"(H) to make all reasonable efforts to find hu-
22	mane placement for retired breeding dogs (such as
23	with an adoptive family, rescue organization, or
24	other appropriate owner for that dog, and not in-
25	cluding selling at auction or otherwise placing a re-

- 1 tired breeding dog with another breeder for breeding
- 2 purposes).".
- 3 (b) DEALER FACILITY DEFINED.—Section 2 of the
- 4 Animal Welfare Act (7 U.S.C. 2132) is amended by add-
- 5 ing at the end the following new subsection:
- 6 "(p) The term 'dealer facility' means any facility used
- 7 by a dealer in commerce to, for compensation or profit,
- 8 deliver for transportation, transport (except as a carrier),
- 9 buy, sell, or negotiate the purchase or sale of, any dog.".
- 10 (c) Conforming Amendment.—Section
- 11 13(a)(2)(B) of the Animal Welfare Act (7 U.S.C.
- 12 2143(a)(2)(B)) is amended by inserting "subject to para-
- 13 graph (9)," before "for exercise of dogs".
- 14 SEC. 3. REGULATIONS.
- Not later than 18 months after the date of the enact-
- 16 ment of this Act, the Secretary shall issue final regulations
- 17 establishing the standards for the care of dogs in dealer
- 18 facilities, as required by this Act.
