## A BILL ENTITLED

1 AN ACT concerning

2 **Protective Orders – Relief Eligibility – Rape and Sexual Offenses**

3 FOR the purpose of removing rape and certain sexual offenses from the list of offenses  
4 alleged to have been committed by a certain respondent against a certain victim for  
5 which a peace order petition may be filed under certain circumstances; altering the  
6 definition of “person eligible for relief” for purposes of certain provisions of law  
7 relating to domestic violence protective orders to include an individual who alleges  
8 the commission of certain acts against the individual by a certain respondent; and  
9 generally relating to peace orders and protective orders.

25 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
26 That the Laws of Maryland read as follows:

**Article – Courts and Judicial Proceedings**

3–1503.

(a) (1) A petitioner may seek relief under this subtitle by filing with the court, or with a commissioner under the circumstances specified in § 3–1503.1(a) of this subtitle, a petition that alleges the commission of any of the following acts against the petitioner by the respondent, if the act occurred within 30 days before the filing of the petition:

(i) An act that causes serious bodily harm;

(ii) An act that places the petitioner in fear of imminent serious bodily harm;

(iii) Assault in any degree;

[(iv) Rape or sexual offense under § 3–303, § 3–304, § 3–307, or § 3–308 of the Criminal Law Article or attempted rape or sexual offense in any degree;]

[(v)] (IV) False imprisonment;

[(vi)] (V) Harassment under § 3–803 of the Criminal Law Article;

[(vii)] (VI) Stalking under § 3–802 of the Criminal Law Article;

[(viii)] (VII) Trespass under Title 6, Subtitle 4 of the Criminal Law Article;

[(ix)] (VIII) Malicious destruction of property under § 6–301 of the Criminal Law Article;

[(x)] (IX) Misuse of telephone facilities and equipment under § 3–804 of the Criminal Law Article;

[(xi)] (X) Misuse of electronic communication or interactive computer service under § 3–805 of the Criminal Law Article;

[(xii)] (XI) Revenge porn under § 3–809 of the Criminal Law Article;

[(xiii)] (XII) Visual surveillance under § 3–901, § 3–902, or § 3–903 of the Criminal Law Article.

(2) A petition may be filed under this subtitle if:

(i) The act described in paragraph (1) of this subsection is alleged to

1 have occurred in the State; or

2 (ii) The petitioner is a resident of the State, regardless of whether  
3 the act described in paragraph (1) of this subsection is alleged to have occurred in the State.

6 (a) In this subtitle the following words have the meanings indicated.

7 (m) “Person eligible for relief” includes:

8 (1) the current or former spouse of the respondent;

9 (2) a cohabitant of the respondent;

10 (3) a person related to the respondent by blood, marriage, or adoption;

11 (4) a parent, stepparent, child, or stepchild of the respondent or the person  
12 eligible for relief who resides or resided with the respondent or person eligible for relief for  
13 at least 90 days within 1 year before the filing of the petition;

14 (5) a vulnerable adult;

15 (6) an individual who has a child in common with the respondent; [or]

16 (7) an individual who has had a sexual relationship with the respondent  
17 within 1 year before the filing of the petition; **OR**

18 **(8) AN INDIVIDUAL WHO ALLEGES THAT THE RESPONDENT**  
19 **COMMITTED, WITHIN 1 YEAR BEFORE THE FILING OF THE PETITION, ANY OF THE**  
20 **FOLLOWING ACTS AGAINST THE INDIVIDUAL:**

21 **(I) RAPE OR A SEXUAL OFFENSE UNDER § 3–303, § 3–304, §**  
22 **3–307, OR § 3–308 OF THE CRIMINAL LAW ARTICLE; OR**

23 **(II) ATTEMPTED RAPE OR SEXUAL OFFENSE IN ANY DEGREE.**

24 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect**  
25 **October 1, 2020.**
