3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "Intelligence Commu-
- 5 nity Workforce Agility Protection Act of 2021".

1 SEC. 2. EXPANSION OF TREATMENT OF MOVING EXPENSES.

(a) PURPOSE.—The purpose of this section is to facilitate the movement of members of the intelligence community to meet mission critical needs and to reduce unintended tax burdens imposed on public servants in relocating duty stations.

7 (b) DEDUCTION.—Section 217(k) of the Internal Revenue Code of 1986 is amended by inserting "or an em-8 9 ployee or new appointee of the intelligence community (as defined in section 3 of the National Security Act of 1947 10 (50 U.S.C. 3003)) (other than a member of the Armed 11 Forces of the United States) who moves pursuant to a 12 change in assignment that requires relocation" after "to 13 14 whom subsection (g) applies".

15 (c) EXCLUSION FOR QUALIFIED MOVING EXPENSE REIMBURSEMENTS.—Section 132(g)(2) of the Internal 16 Revenue Code of 1986 is amended by inserting "or an em-17 ployee or new appointee of the intelligence community (as 18 19 defined in section 3 of the National Security Act of 1947 20(50 U.S.C. 3003)) (other than a member of the Armed 21 Forces of the United States) who moves pursuant to a change in assignment that requires relocation" after 22 "change of station". 23

(d) EFFECTIVE DATE.—The amendments made by
this section shall apply to taxable years beginning after
December 31, 2017.
