Mr. VARGAS (for himself and Ms. WATERS) introduced the following bill; which was referred to the Committee on Appropriations

A BILL

To provide homelessness and supportive services assistance for Native Americans to respond to the COVID-19 pandemic, and for other purposes.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Emergency Tribal5 Housing Assistance Act of 2021".

6 SEC. 2. HOMELESSNESS ASSISTANCE AND SUPPORTIVE 7 SERVICES PROGRAMS FOR NATIVE AMERI-8 CANS.

9 (a) APPROPRIATION.—In addition to amounts other-10 wise made available, out of any money in the Treasury

not otherwise appropriated, there are appropriated for fis-1 2 cal year 2021, \$750,000,000, to remain available until 3 September 30, 2025, to prevent, prepare for, and respond 4 to coronavirus, for activities and assistance authorized 5 under title I of the Native American Housing Assistance 6 and Self-Determination Act of 1996 (NAHASDA) (25 7 U.S.C. 4111 et seq.), under title VIII of NAHASDA (25 8 U.S.C. 4221 et seq.), and under title I of the Housing 9 and Community Development Act of 1974 with respect to Indian tribes (42 U.S.C. 5301 et seq.), which amounts 10 11 shall be made available as follows:

(1) HOUSING BLOCK GRANTS.—\$455,000,000
shall be available for the Native American Housing
Block Grants and Native Hawaiian Housing Block
Grant programs, as authorized under titles I and
VIII of NAHASDA, subject to the following terms
and conditions:

18 (A) FORMULA.—Of the amounts made
19 available under this paragraph, \$450,000,000
20 shall be for grants under title I of NAHASDA
21 and shall be distributed according to the same
22 funding formula used in fiscal year 2021.

23 (B) NATIVE HAWAHANS.—Of the amounts
24 made available under this paragraph,

\$5,000,000 shall be for grants under title VIII of NAHASDA.

(C) USE.—Amounts made available under 3 4 this paragraph shall be used by recipients to 5 prepare for, and respond prevent, to 6 coronavirus, including to maintain normal oper-7 ations and fund eligible affordable housing ac-8 tivities under NAHASDA during the period 9 that the program is impacted by coronavirus. In 10 addition, amounts made available under sub-11 paragraph (B) shall be used to provide rental 12 assistance to eligible Native Hawaiian families 13 both on and off the Hawaiian Home Lands.

14 (D) TIMING OF OBLIGATIONS.—Amounts 15 made available under this paragraph shall be 16 used, as necessary, to cover or reimburse allow-17 able costs to prevent, prepare for, and respond 18 to coronavirus that are incurred by a recipient, 19 including for costs incurred as of January 21, 20 2020.

(E) WAIVERS.—Any provision of statute or
regulation used to administer amounts made
available under this paragraph (except for requirements related to fair housing, nondiscrimination, labor standards, and the envi-

1 ronment), shall be waived upon a finding that 2 any such waivers or alternative requirements 3 are necessary to expedite or facilitate the use of 4 amounts made available under this paragraph. UNOBLIGATED AMOUNTS.—Amounts 5 (\mathbf{F}) 6 made available under this paragraph which are 7 not accepted, are voluntarily returned, or other-8 wise recaptured for any reason shall be used to 9 fund grants under paragraph (2). 10 (2) Indian community development block 11 GRANTS.—\$280,000,000 shall be available for grants 12 under title I of the Housing and Community Devel-13 opment Act of 1974, subject to the following terms 14 and conditions: 15 (A) USE.—Amounts made available under 16 this paragraph shall be used, without competi-17 tion, for emergencies that constitute imminent 18 threats to health and safety and are designed to 19 for, prevent, prepare and respond to 20 coronavirus. 21 (B) PLANNING.—Not to exceed 20 percent 22 of any grant made with funds made available 23 under this paragraph shall be expended for 24 planning and management development and ad-

1 (C) TIMING OF OBLIGATIONS.—Amounts 2 made available under this paragraph shall be 3 used, as necessary, to cover or reimburse allow-4 able costs to prevent, prepare for, and respond to coronavirus incurred by a recipient, including 5 6 for costs incurred as of January 21, 2020. 7 (D) INAPPLICABILITY OF PUBLIC SERVICES 8 CAP.—Notwithstanding section 105(a)(8) of the 9 Housing and Community Development Act of 10 1974 (42 U.S.C. 5305(a)(8)), there shall be no 11 per centum limitation for the use of funds made 12 available under this paragraph for public serv-13 ices activities to prevent, prepare for, and re-14 spond to coronavirus. 15 (E) WAIVERS.—Any provision of any stat-16 ute or regulation used to administer amounts 17 made available under this paragraph (except for 18 requirements related to fair housing, non-

discrimination, labor standards, and the envi-

ronment), shall be waived upon a finding that
