1	A RESOLUTION declaring March 10, 2020, to be Alzheimer's Awareness and
2	Advocacy Day.
3	WHEREAS, every 65 seconds someone in the United States develops Alzheimer's
4	or another dementia; and
5	WHEREAS, 5.8 million Americans are currently living with Alzheimer's and that
6	number is expected to reach to 14 million by the year 2050; and
7	WHEREAS, 73,000 Kentuckians are currently living with Alzheimer's or another
8	form of dementia and that number is projected to grow to more than 86,000 by 2025; and
9	WHEREAS, a quarter of a million family caregivers in Kentucky have provided
10	more than 300 hours of unpaid care, valued at \$3.9 million, to loved ones diagnosed with
11	Alzheimer's or another dementia; and
12	WHEREAS, Alzheimer's is the sixth leading cause of death in the United States and
13	is the only one of the top 10 causes of death that cannot be prevented, cured, or slowed;
14	and
15	WHEREAS, one in three seniors dies with Alzheimer's or another dementia, more
16	than breast cancer and prostate cancer, combined; and
17	WHEREAS, in 2019 Alzheimer's and other dementias cost the United States \$290
18	billion; and
19	WHEREAS, the costs associated with Alzheimer's in the United States could
20	increase to as much as \$1.1 trillion per year by 2050; and
21	WHEREAS, early and accurate diagnosis could save up to \$7.9 trillion in medical
22	care and costs; and
23	WHEREAS, as the population of older adults in Kentucky continues to grow, there
24	will be an increased demand for residential, home-based, and community-based services
25	that will in turn mean an increased demand for direct care workers, including home health
26	aides, certified nursing assistants, and personal care aides; and
27	WHEREAS, the United States is experiencing a well-documented health care

workforce shortage that could jeopardize care for individuals living with Alzheimer's or
