3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "TSA Reaching Across
- 5 Nationalities, Societies, and Languages to Advance Trav-
- 6 eler Education Act" or the "TRANSLATE Act".

1 SEC. 2. PLAN.

2 (a) IN GENERAL.—Not later than 180 days after the 3 date of the enactment of this Act, the Administrator of the Transportation Security Administration (TSA) shall 4 5 submit to the Committee on Homeland Security of the House of Representatives and the Committee on Com-6 7 merce, Science, and Transportation of the Senate a plan 8 to ensure that TSA material disseminated in major air-9 ports can be better understood by more people accessing 10 such airports.

(b) CONTENTS.—The plan required under subsection(a) shall include the following:

(1) An identification of the most common languages other than English that are the primary languages of individuals that travel through or work in
each major airport.

18 (A) TSA materials to communicate infor19 mation in languages identified pursuant to
20 paragraph (1); and

(B) the communication of TSA material to
individuals with vision or hearing impairments
or other possible barriers to understanding such
material.

25 (c) CONSIDERATIONS.—In developing the plan re26 quired under subsection (a), the Administrator of the

TSA, acting through the Office of Civil Rights and Lib erties, Ombudsman and Traveler Engagement of the TSA,
 shall take into consideration data regarding the following:

(1) International enplanement.

5 (2) Local populations surrounding major air-6 ports.

7 (d) IMPLEMENTATION.—Not later than 180 days
8 after the submission of the plan required under subsection
9 (a), the Administrator of the TSA shall implement such
10 plan.

(e) GAO REVIEW.—Not later than one year after the
implementation pursuant to subsection (d) of the plan required under subsection (a), the Comptroller General of
the United States shall submit to the Committee on
Homeland Security of the House of Representatives and
the Committee on Commerce, Science, and Transportation
of the Senate a review of such implementation.

18 (f) DEFINITIONS.—In this section:

(1) AIRPORT.—The term "airport" has the
meaning given such term in section 40102 of title
49, United States Code.

(2) MAJOR AIRPORTS.—The term "major airports" means Category X and Category I airports.
(3) TSA MATERIAL.—The term "TSA material" means signs, videos, audio messages, websites,

press releases, social media postings, and other com munications published and disseminated by the Ad ministrator of the TSA in Category X and Category
 I airports.
