Ms. Ros-Lehtinen (for herself, Mr. Serrano, Mr. Curbelo of Florida, Ms. Michelle Lujan Grisham of New Mexico, Mr. Cárdenas, Mrs. Torres, Mr. Hurd, Mr. King of New York, and Mr. Newhouse) introduced the following bill; which was referred to the Committee on House Administration, and in addition to the Committees on Natural Resources, and Transportation and Infrastructure, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To establish within the Smithsonian Institution the National Museum of the American Latino, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "National Museum of
- 5 the American Latino Act".
- 6 SEC. 2. FINDINGS.
- 7 Congress finds the following:

- (1) The United States is a symbol of democracy, freedom, and economic opportunity around the world, and the legacy of Latinos is deeply rooted in the very fabric of the history, democracy, freedom, and economic opportunity of the United States.
 - (2) There exists no national museum within the Smithsonian Institution that is devoted to the documentation and explication of Latino life, art, history, and culture.
 - (3) The establishment of the National Museum of the American Latino will be consistent with the purposes of the Smithsonian Institution, created by Congress in 1846, "for the increase and diffusion of knowledge".
 - (4) The National Museum of the American Latino—
 - (A) will be the keystone for people in the United States and other Smithsonian Institution visitors to learn about Latino contributions to life, art, history, and culture in the United States at its signature location on the National Mall; and
 - (B) will serve as a gateway for visitors to view other Latino exhibitions, collections, and programming at other Smithsonian Institution

- facilities and museums throughout the United States and the territories of the United States.
- 3 (5) The National Museum of the American
 4 Latino will be unique among the museums of the
 5 Smithsonian Institution in that a significant number
 6 of the museum's staff will have joint positions
 7 throughout the various other museums and research
 8 centers of the Smithsonian Institution—
 - (A) resulting in a decreased need for resources for the National Museum of the American Latino on the National Mall; and
 - (B) contributing to an integrated approach in telling the story of the United States in exhibits and collections throughout the Smithsonian Institution.
 - (6) By sharing resources (including funding and staff) that are provided by direct appropriation to the National Museum of the American Latino and resources that are provided to other units of the Smithsonian Institution, the National Museum of the American Latino will serve as a key agent in stimulating and increasing Smithsonian Institution activities dedicated to the collection, preservation, research, and exhibition of Latino historical and cultural material reflecting the breadth and depth of

- the experiences of Latino history and culture throughout the Smithsonian Institution.
- 3 SEC. 3. DEFINITIONS.
- 4 In this Act:
- 5 (1) BOARD OF REGENTS.—The term "Board of
- 6 Regents" means the Board of Regents of the Smith-
- 7 sonian Institution.
- 8 (2) Board of Trustees.—The term "Board
- 9 of Trustees' means the Board of Trustees of the
- 10 National Museum of the American Latino as estab-
- lished by section 5.
- 12 (3) DIRECTOR.—The term "Director" means
- the Director of the National Museum of the Amer-
- ican Latino.
- 15 (4) Museum.—The term "Museum" means the
- 16 National Museum of the American Latino estab-
- lished by section 4.
- 18 (5) Secretary.—The term "Secretary" means
- the Secretary of the Smithsonian Institution.
- 20 SEC. 4. ESTABLISHMENT OF MUSEUM.
- 21 (a) Establishment.—There is established within
- 22 the Smithsonian Institution a museum to be known as the
- 23 "National Museum of the American Latino".
- (b) Purposes.—The purposes of the Museum are—

1	(1) to illuminate the story of the United States
2	for the benefit of all by featuring Latino contribu-
3	tions; and
4	(2) to provide for—
5	(A) the collection, study, research, publica-
6	tion, and establishment of exhibitions and pro-
7	grams relating to Latino life, art, history, and
8	culture that encompass—
9	(i) Latino contributions to the early
10	history of what now encompasses the
11	United States of America and its terri-
12	tories;
13	(ii) Latino contributions in the armed
14	services from the earliest days of the
15	American Revolution to current military
16	activities in defense of our freedoms;
17	(iii) Latino contributions to the free-
18	dom, well-being, and economic prosperity
19	of all people in the United States through
20	historical movements;
21	(iv) entrepreneurial and charitable ac-
22	tivities of Latinos; and
23	(v) contributions by Latinos to—
24	(I) the social, natural, and phys-
25	ical sciences; and

1	(II) art, history, and culture, in-
2	cluding food, music, dance, film, the-
3	ater, sports, and other forms of pop-
4	ular culture in the United States; and
5	(B) collaboration between the Museum,
6	other museums and research centers of the
7	Smithsonian Institution, and other museums
8	and educational institutions throughout the
9	United States and abroad, to promote the study
10	and appreciation of Latino life, art, history, cul-
11	ture, and its impact on society in the United
12	States, including collaboration concerning joint
13	research projects, programs, exhibitions, collec-
14	tion management, and training of museum
15	staff.
16	SEC. 5. BOARD OF TRUSTEES.
17	(a) Establishment.—There is established within
18	the Smithsonian Institution a Board of Trustees of the
19	Museum with the duties, powers, and authority specified
20	in this section.
21	(b) Duties.—
22	(1) In General.—The Board of Trustees—
23	(A) shall—
24	(i) make recommendations to the
25	Board of Regents concerning the location,

1	planning, design, and construction of the
2	Museum;
3	(ii) recommend annual operating
4	budgets for the Museum to the Board of
5	Regents;
6	(iii) adopt bylaws for the Board of
7	Trustees;
8	(iv) report annually to the Board of
9	Regents on the acquisition, disposition,
10	and display of Latino collections, objects
11	and artifacts, and on other appropriate
12	matters; and
13	(v) advise and assist the Board of Re-
14	gents on all matters relating to the admin-
15	istration, operation, maintenance, and
16	preservation of the Museum; and
17	(B) may delegate the duties described in
18	clauses (i) through (iv) of subparagraph (A) to
19	the Director.
20	(2) Principal responsibilities.—Subject to
21	the general policies of the Board of Regents, the
22	Board of Trustees shall have the sole authority to—
23	(A) purchase, accept, borrow, or otherwise
24	acquire artifacts and other objects for addition
25	to the collections of the Museum;

1	(B) loan, exchange, sell, or otherwise dis-
2	pose of any part of the collections of the Mu-
3	seum, with the proceeds of such transactions to
4	be used for additions to the collections of the
5	Museum; and
6	(C) specify criteria with respect to the use
7	of the collections and resources of the Museum,
8	including policies on programming, education,
9	exhibitions, and research with respect to—
10	(i) the life, art, history, culture, and
11	other aspects of Latinos in the United
12	States and the territories of the United
13	States;
14	(ii) the role of Latinos in the history
15	of the United States from the arrival of
16	the first explorers to the Americas to the
17	present;
18	(iii) the contributions of Latinos to
19	society and culture in the United States,
20	and exploring what it means to be an
21	American; and
22	(iv) sharing how values in the United
23	States such as resiliency, optimism, and
24	spirituality are reflected in Latino history
25	and culture.

1	(3) Other responsibilities.—Subject to the
2	general policies of the Board of Regents, the Board
3	of Trustees shall have authority to—
4	(A) provide for preservation, restoration
5	and maintenance of the collections of the Mu-
6	seum; and
7	(B) solicit, accept, use, and dispose of
8	gifts, bequests, and devises of personal and real
9	property for the purpose of aiding and facili-
10	tating the work of the Museum.
11	(e) Composition and Appointment.—
12	(1) In general.—The Board of Trustees shall
13	be composed of not more than 19 voting members
14	as provided under paragraph (2).
15	(2) VOTING MEMBERS.—The Board of Trustees
16	shall include the following voting members:
17	(A) The Secretary of the Smithsonian In-
18	stitution.
19	(B) The Under Secretary of Museums and
20	Research of the Smithsonian Institution.
21	(C) One member of the Board of Regents
22	appointed by the Board of Regents.
23	(D) Two Members of Congress, one from
24	each political party, designated by the Congres-

1	sional Hispanic Caucus and the Congressional
2	Hispanic Conference.
3	(E) Fourteen individuals who shall be ap-
4	pointed by the Board of Regents after taking
5	into consideration—
6	(i) efforts to have a politically and
7	geographically diverse representation on
8	the Board of Trustees reflecting States
9	and territories with significant Latino pop-
10	ulations;
11	(ii) individuals recommended by mem-
12	bers of the Board of Trustees; and
13	(iii) individuals recommended by orga-
14	nizations and entities that are committed
15	to the advancement of knowledge of Latino
16	life, art, history, and culture.
17	(3) Initial appointments.—The Board of
18	Regents shall make initial appointments to the
19	Board of Trustees under paragraph (2) not later
20	than 180 days after the date of enactment of this
21	Act.
22	(d) Terms of Service.—
23	(1) In general.—Except as provided in this
24	subsection, each appointed member of the Board of
25	Trustees shall be appointed for a term of 3 years.

1	(2) Initial appointees.—As designated by
2	the Board of Regents at the time of appointment, of
3	the voting members first appointed under subpara-
4	graph (E) of subsection (c)(2)—
5	(A) five members shall be appointed for a
6	term of 1 year;
7	(B) five members shall be appointed for a
8	term of 2 years; and
9	(C) four members shall be appointed for a
10	term of 3 years.
11	(3) REAPPOINTMENT.—A member of the Board
12	of Trustees may be reappointed, except that no indi-
13	vidual may serve on the Board of Trustees for a
14	total of more than 2 full terms. For purposes of this
15	paragraph, the number of terms an individual serves
16	on the Board of Trustees shall not include any por-
17	tion of a term for which an individual is appointed
18	to fill a vacancy under paragraph (4)(B).
19	(4) Vacancies.—
20	(A) IN GENERAL.—A vacancy on the
21	Board of Trustees—
22	(i) shall not affect the powers of the
23	Board of Trustees; and
24	(ii) shall be filled in the same manner
25	as the original appointment was made.

(B) TERM.—Any member of the Board of 1 2 Trustees appointed to fill a vacancy occurring 3 before the expiration of the term for which the 4 member's predecessor was appointed shall be appointed for the remainder of that term. 6 (e) Compensation.— 7 (1) In General.—Except as provided in para-8 graph (2), a member of the Board of Trustees shall 9 serve without pay. 10 Travel expenses.—A member of the 11 Board of Trustees shall be allowed travel expenses, 12 including per diem in lieu of subsistence, at rates 13 authorized for an employee of an agency under sub-14 chapter I of chapter 57 of title 5, United States 15 Code, while away from the home or regular place of 16 business of the member in the performance of the 17 duties of the Board of Trustees. 18 (f) CHAIRPERSON.—By a majority vote of its voting 19 members, the Board of Trustees shall elect a chairperson 20 from its members. 21 (g) Meetings.— 22 (1) IN GENERAL.—The Board of Trustees shall

meet at the call of the chairperson or on the written

request of a majority of the voting members of the

- Board of Trustees, but not fewer than twice each year.
- 3 (2) MEETING FORMAT.—Regularly scheduled 4 meetings and special meetings may be conducted in-5 person, telephonically, electronically, or by any 6 means appropriate as determined by the chairperson.
- 7 (h) QUORUM.—A majority of the voting members of
- 8 the Board of Trustees holding office shall constitute a
- 9 quorum for the purpose of conducting business, but a less-
- 10 er number may receive information on behalf of the Board
- 11 of Trustees.

12 SEC. 6. DIRECTOR AND STAFF OF MUSEUM.

- 13 (a) Director.—
- 14 (1) IN GENERAL.—The Museum shall have a
 15 Director who shall be appointed by the Secretary in
 16 consultation with the Board of Trustees. The Sec17 retary may appoint an interim Director to oversee
 18 the initial activity of establishing the Museum until
 19 a permanent Director is selected.
- 20 (2) DUTIES.—The Director shall manage the 21 Museum subject to the policies of the Board of Re-22 gents and the Board of Trustees.
- 23 (b) STAFF.—The Secretary may appoint 2 additional 24 employees to serve under the Director, except that such 25 additional employees may be appointed without regard to

1	the provisions of title 5, United States Code, governing
2	appointments in the competitive service.
3	(c) PAY.—The employees appointed by the Secretary
4	under subsection (b) may be paid without regard to the
5	provisions of chapter 51 and subchapter III of chapter 53
6	of title 5, United States Code, relating to classification
7	of positions and General Schedule pay rates.
8	SEC. 7. EDUCATIONAL AND LIAISON PROGRAMS.
9	(a) In General.—
10	(1) Programs authorized.—The Director of
11	the Museum may carry out educational and liaison
12	programs in support of the goals of the Museum.
13	(2) Specific activities.—In carrying out this
14	section, the Director shall—
15	(A) carry out educational programs relat-
16	ing to Latino life, art, history, and culture, in-
17	cluding—
18	(i) programs using digital, electronic,
19	and interactive technologies; and
20	(ii) programs carried out in collabora-
21	tion with elementary schools, secondary
22	schools, and postsecondary schools; and
23	(B) consult with the Director of the Insti-
24	tute of Museum and Library Services con-

1	cerning the grant programs carried out under
2	subsection (b).
3	(b) Grant Programs.—Notwithstanding any other
4	provision of law, the Director of the Institute of Museum
5	and Library Services, in consultation with the Museum
6	Director, is authorized to use funds from the appropria-
7	tions account appropriated under the heading "OFFICE OF
8	MUSEUM AND LIBRARY SERVICES: GRANTS AND ADMINIS-
9	TRATION" under the heading "Institute of Museum
10	AND LIBRARY SERVICES" to award grants in accordance
11	with the purposes described in section 4(b).
12	SEC. 8. NATIONAL MUSEUM OF THE AMERICAN LATINO

22	identified by the Board of Trustees or

24	(C) Transfer to smithsonian institu-

2	designated for the Museum is in an area that
3	is under the administrative jurisdiction of an-
4	other Federal entity, as soon as practicable
5	after the date on which the designation is made,
6	the head of the Federal entity shall transfer to
7	the Smithsonian Institution administrative ju-
8	risdiction over the area selected for the site of
9	the Museum.

21	cies is authorized to prepare plans, design, and con-
