Mr. LAHOOD (for himself, Mr. LARSEN of Washington, Mr. BACON, and Ms. CASTOR of Florida) introduced the following bill; which was referred to the Committee on Financial Services

A BILL

- To require the Secretary of the Treasury to mint coins in commemoration of the FIFA World Cup 2026, and for other purposes.
 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

- 4 This Act may be cited as the "FIFA World Cup 2026
- 5 Commemorative Coin Act".

6 SEC. 2. FINDINGS.

- 7 Congress finds the following:
- 8 (1) The FIFA World Cup 2026—

1	(A) will be held in the United States, Mex-
2	ico, and Canada;
3	(B) will be the first time the Men's World
4	Cup has been held in the United States in 32
5	years; and
6	(C) will be the second Men's World Cup
7	hosted by the United States and the largest and
8	most inclusive World Cup ever hosted, with 48
9	teams in 16 cities across 3 countries.
10	(2) Host cities and locations in the United
11	States will include Atlanta, Boston, Dallas, Houston,
12	Kansas City, Los Angeles, Miami, the New York/
13	New Jersey area, the San Francisco Bay area, and
14	Seattle.
15	(3) The FIFA World Cup 2026 will be orga-
16	nized under a FIFA-led operating model, which was
17	introduced in the FIFA Women's World Cup in Aus-
18	tralia and New Zealand in 2023.
19	(4) Through the FIFA-led operating model, the
20	FIFA World Cup 2026 is being planned and exe-
21	cuted by FWC2026 US, Inc., an organization ex-
22	empt from taxation pursuant to section $501(c)(4)$ of
23	the Internal Revenue Code of 1986, headquartered
24	in Miami.

1	(5) The FIFA-led operating model includes a
2	guaranteed framework for providing a legacy fund to
3	each participating host member: the United States
4	Soccer Federation, Canada Soccer, and the Mexican
5	Football Federation.
6	(6) A FIFA World Cup 2026 commemorative
7	coin program has the opportunity to shape a lasting
8	legacy for the sport of soccer in the United States,
9	support underserved communities, and celebrate a
10	unifying global event.
11	SEC. 3. COIN SPECIFICATIONS.
12	(a) DENOMINATIONS.—The Secretary of the Treas-
13	ury shall mint and issue the following coins in commemo-
14	ration of the FIFA World Cup 2026:
15	(1) $\&5$ COLD COING Not more than 100,000

1 HALF-DOLLAR CLAD COINS.—Not more (3)2 than 750,000 half-dollar coins, each of which shall— 3 (A) weigh 11.34 grams; 4 (B) have a diameter of 1.205 inches; and 5 (C) be minted to the specifications for half-6 dollar coins contained in section 5112(b) of title 7 31. United States Code. 8 (b) LEGAL TENDER.—The coins minted under this 9 Act shall be legal tender, as provided in section 5103 of 10 title 31, United States Code. 11 (c) NUMISMATIC ITEMS.—For purposes of sections 12 5134 and 5136 of title 31, United States Code, all coins minted under this Act shall be considered to be numis-13 14 matic items. 15 (d) MINTAGE LIMIT EXCEPTION.—If the Secretary determines, based on independent, market-based research 16 conducted by FWC2026 US, Inc., that the mintage levels 17 18 described in this section are not adequate to meet public 19 demand, the Secretary may increase the mintage levels as 20 the Secretary determines is necessary to meet public de-21 mand.

22 SEC. 4. DESIGN OF COINS.

23 (a) DESIGN REQUIREMENTS.—

1	(1) IN GENERAL.—The designs of the coins
2	minted under this Act shall be emblematic of the
3	sport of soccer and the FIFA World Cup.
4	(2) Designation and inscriptions.—On
5	each coin minted under this Act, there shall be—
6	(A) a designation of the value of the coin;
7	(B) an inscription of the year "2026"; and
8	(C) inscriptions of the words "Liberty",
9	"In God We Trust", "United States of Amer-
10	ica", and "E Pluribus Unum".
11	(3) SELECTION.—The designs for the coins
12	minted under this Act shall be—
13	(A) selected by the Secretary after con-
14	sultation with—
15	(i) FWC2026 US, Inc.; and
16	(ii) the Commission of Fine Arts; and
17	(B) reviewed by the Citizens Coinage Advi-
18	sory Committee.
19	SEC. 5. ISSUANCE OF COINS.
20	(a) QUALITY OF COINS.—The Secretary may issue
21	coins minted under this Act in uncirculated and proof
22	qualities.
23	(b) PERIOD OF ISSUANCE.—The Secretary may issue
24	coins under this Act only during the calendar year begin-
25	ning on January 1, 2026.

1 SEC. 6. SALE OF COINS.

2 (a) SALE PRICE.—The coins issued under this Act
3 shall be sold by the Secretary at a price equal to the sum
4 of—

- 5 (1) the face value of the coins;
- 6 (2) the surcharge provided in section 7(a) with
 7 respect to such coins; and

8 (3) the cost of designing and issuing the coins
9 (including labor, materials, dies, use of machinery,
10 overhead expenses, marketing, and shipping).

(b) BULK SALES.—The Secretary shall make bulksales of the coins issued under this Act at a reasonablediscount.

14 (c) Prepaid Orders.—

(1) IN GENERAL.—The Secretary shall accept
prepaid orders for the coins minted under this Act
before the issuance of such coins.

18 (2) DISCOUNT.—Sale prices with respect to pre19 paid orders under paragraph (1) shall be at a rea20 sonable discount.

21 SEC. 7. SURCHARGES.

(a) IN GENERAL.—All sales of coins issued under this
Act shall include a surcharge of—

- 24 (1) \$35 per coin for the \$5 coin;
- (2) \$10 per coin for the \$1 coin; and
- 26 (3) \$5 per coin for the half-dollar coin.

1 (b) DISTRIBUTION.—Subject to section 5134(f) of 2 title 31, United States Code, all surcharges received by 3 the Secretary from the sale of coins issued under this Act 4 shall be paid to FWC2026 US, Inc., for the purpose of 5 aiding or executing United States-based soccer programs 6 and activities, including the promotion of—

7 (1) FIFA's legacy programs in the United8 States; and

9 (2) efforts to grow the sport of soccer through10 out the United States, with a focus on youth, inner
11 cities, and underserved communities.

(c) AUDITS.—FWC2026 US, Inc., shall be subject to
the audit requirements of section 5134(f)(2) of title 31,
United States Code, with regard to the amounts received
under subsection (b).

16 (d) LIMITATION.—Notwithstanding subsection (a), 17 no surcharge may be included with respect to the issuance under this Act of any coin during a calendar year if, as 18 19 of the time of such issuance, the issuance of such coin 20 would result in the number of commemorative coin pro-21 grams issued during such year to exceed the annual 2 22 commemorative coin program issuance limitation under 23 section 5112(m)(1) of title 31, United States Code (as in 24 effect on the date of the enactment of this Act). The Sec-25 retary may issue guidance to carry out this subsection.

1 SEC. 8. FINANCIAL ASSURANCES.

2 The Secretary shall take such actions as may be nec-3 essary to ensure that—

4 (1) minting and issuing coins under this Act
5 will not result in any net cost to the United States
6 Government; and

7 (2) no funds, including applicable surcharges, 8 are disbursed to any recipient designated in section 9 7(b) until the total cost of designing and issuing all 10 of the coins authorized by this Act (including labor, 11 materials, dies, use of machinery, winning design 12 compensation, overhead expenses, and shipping) is 13 recovered by the United States Treasury, consistent 14 with sections 5112(m) and 5134(f) of title 31, 15 United States Code.

16 SEC. 9. DEFINITIONS.

17 In this Act:

18 (1) FIFA.—The term "FIFA" means the
19 Fédération Internationale de Football Association.

20 (2) FIFA WORLD CUP 2026.—The term "FIFA
21 World Cup 2026" means the FIFA Men's World
22 Cup held in 2026.

23 (3) FWC2026 US, INC.—The term "FWC2026
24 US, Inc." means the FIFA subsidiary incorporated

- 1 in the United States for the purpose of operating the
- 2 FIFA World Cup 2026 and related programs.
