## 1 AN ACT concerning

#### 2 Commercial Law – Consumer Protection – Nontransferable Ticketing Systems

3 FOR the purpose of prohibiting a ticket issuer from using a nontransferable ticketing system except under certain circumstances; prohibiting a purchaser or a seller of a 4  $\mathbf{5}$ ticket from being penalized, discriminated against, or denied access to an event 6 under certain circumstances; authorizing a ticket issuer, an operator of a venue, or 7 an agent of the operator to maintain and enforce certain policies, establish certain 8 limits, revoke or restrict certain tickets, and opt not to sell tickets in a certain form 9 under certain circumstances; defining certain terms; and generally relating to nontransferable ticketing systems, ticket transfers, and ticket sales. 10

6 A person may not intentionally sell or use software to circumvent a security measure, 7 an access control system, or any other control or measure on a ticket seller's Web site that 8 is used to ensure an equitable ticket buying process.

10 A violation of this subtitle is:

11 (1) An unfair or deceptive trade practice within the meaning of Title 13 of 12 this article; and

13 (2) Subject to the enforcement and penalty provisions contained in Title 1314 of this article.

15 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 16 October 1, 2017.
