3	SECTION 1. DESIGNATION OF THE KOL ISRAEL FOUNDA-				
4	TION HOLOCAUST MEMORIAL AS A NATIONAL				
5	MEMORIAL.				
6	(a) Congressional Recognition.—Congress—				
7	(1) recognizes the significance of the Kol Israel				
8	Foundation Holocaust Memorial in preserving the				
9	memory of the 6,000,000 Jews murdered by the				
10	Nazi regime and allies and collaborators of the Naz				
11	regime; and				
12	(2) honors the life and legacy of the Holocaust				
13	survivors who erected the Kol Israel Foundation				
14	Holocaust Memorial.				
15	(b) Designation.—				
16	(1) In general.—The Kol Israel Foundation				
17	Holocaust Memorial located in Bedford Heights,				
18	Ohio, is designated as a national memorial.				
19	(2) Effect of Designation.—				
20	(A) In general.—The national memorial				
21	designated by paragraph (1) is not a unit of the				
22	National Park System.				
23	(B) USE OF FEDERAL FUNDS.— The des-				
24	ignation of the national memorial by paragraph				
25	(1) shall not require or permit Federal funds to
