- 3 FOR the purpose of requiring the Comptroller, beginning in a certain fiscal year, to 4 distribute a certain amount of abandoned property funds to the Tax Clinics for 5 Low-Income Marylanders Fund; requiring the Governor to include a certain amount 6 of funding in the annual budget for the CASH Campaign of Maryland to award 7 grants for providing certain tax assistance through certain on-demand and mobile 8 tax clinics; requiring certain grant recipients tax clinics to interact with the CASH 9 Campaign in a certain manner for a certain purpose; and generally relating to tax 10 assistance for low-income Marylanders.

- 17 (a) For fiscal years 2021 through 2023, the Governor shall include in the annual State budget an appropriation of \$200,000 for the CASH Campaign of Maryland to promote the financial capability of low–income individuals and families by providing outreach, education, and free tax preparation services.
- 21 (b) For fiscal [year 2024 and each fiscal year thereafter] **YEARS 2024 AND 2025**, the Governor shall include in the annual budget bill an appropriation of \$500,000 for the 23 CASH Campaign.
- (C) (1) FOR FISCAL YEAR 2026 AND EACH FISCAL YEAR THEREAFTER, THE GOVERNOR SHALL INCLUDE IN THE ANNUAL BUDGET BILL AN APPROPRIATION OF \$800,000 FOR THE CASH CAMPAIGN.


