4	(a) IN GENERAL.—Section 529(c) of the Internal
5	Revenue Code of 1986 is amended by adding at the end
6	the following:
7	"(8) TREATMENT OF TECHNICAL TRAINING
8	CERTIFICATE PROGRAMS AND APPRENTICESHIP PRO-
9	GRAMS.—
10	"(A) IN GENERAL.—Any reference in this
11	subsection to the term 'qualified higher edu-
12	cation expense' shall include a reference to ex-
13	penses described in paragraph (3) in connection
14	with—
15	"(i) enrollment or attendance in a
16	program leading to a recognized postsec-
17	ondary credential (as defined in section 3
18	of the Workforce Innovation and Oppor-
19	tunity Act (29 U.S.C. 3102), and
20	"(ii) an apprenticeship registered
21	under the Act of August 16, 1937 (com-
22	monly known as the 'National Apprentice-
23	ship Act'; 50 Stat. 664, chapter 663; 29
24	U.S.C. 50 et seq.).
25	"(B) TOOLS AND EQUIPMENT.—For pur-
26	poses of subparagraph (A), expenses includes

expenses for tools and equipment required for
enrollment or attendance in a program described in subparagraph (A)(i) or participation
in an apprenticeship described in subparagraph
(A)(ii).".

6 (b) EFFECTIVE DATE.—The amendment made by
7 this section shall apply to expenses paid or incurred after
8 the date of the enactment of this Act for programs begin9 ning after the date of the enactment of this Act.
