# **A BILL**

To amend the Homeland Security Act of 2002 to establish a school security coordinating council, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
 2       *tives of the United States of America in Congress assembled,*

3       **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Coordinating and*  
 5       *Leveraging Activities for School Security Act” or the*  
 6       *“CLASS Act of 2019”.*

7       **SEC. 2. SCHOOL SECURITY COORDINATING COUNCIL.**

8       *(a) IN GENERAL.—Title VII of the Homeland Security*  
 9       *Act of 2002 (6 U.S.C. 341 et seq.) is amended by adding*  
 10       *at the end the following new section:*

11       **“SEC. 711. SCHOOL SECURITY COORDINATING COUNCIL.**

12       *“(a) ESTABLISHMENT.—There is established in the De-*  
 13       *partment a coordinating council to ensure that, to the max-*  
 14       *imum extent practicable, activities, plans, and policies to*  
 15       *enhance the security of an early childhood education pro-*  
 16       *gram, elementary school, high school, or secondary schools*  
 17       *against an act of terrorism are coordinated.*

18       *“(b) COMPOSITION.—The members of the council estab-*  
 19       *lished pursuant to subsection (a) shall include the following:*

20               *“(1) The Under Secretary for Strategy, Policy,*  
 21               *and Plans.*

22               *“(2) The Director of the Cybersecurity and In-*  
 23               *frastructure Security.*

24               *“(3) The Administrator of the Federal Emer-*  
 25               *gency Management Agency.*

1           “(4) *The Director of the Secret Service.*

2           “(5) *The Executive Director of the Office of Aca-*  
3           *demic Engagement.*

4           “(6) *The Assistant Secretary for Public Affairs.*

5           “(7) *Any other official of the Department the*  
6           *Secretary determines appropriate.*

7           “(c) *LEADERSHIP.—The Secretary shall designate a*  
8           *member of the council to serve as chair of the council.*

9           “(d) *REPORTS.—Not later than January 30, 2021,*  
10           *and annually thereafter, the Secretary shall submit to the*  
11           *Committee on Homeland Security of the House of Rep-*  
12           *resentatives and the Committee on Homeland Security and*  
13           *Governmental Affairs of the Senate a report regarding the*  
14           *council’s activities during the preceding year, including in-*  
15           *formation on any metrics regarding the efficacy of such ac-*  
16           *tivities and any engagement with stakeholders outside of the*  
17           *Federal Government.*

18           “(e) *DEFINITIONS.—In this section, the terms ‘early*  
19           *childhood education program’, ‘elementary school’, ‘high*  
20           *school’, and ‘secondary school’ have the meanings given such*  
21           *terms in section 8101 of the Elementary and Secondary*  
22           *Education Act of 1965 (20 U.S.C. 7801).’.*

23           “(b) *CLERICAL AMENDMENT.—The table of contents in*  
24           *section 1(b) of the Homeland Security Act of 2002 is*

- 1 *amended by inserting after the item relating to section 710*
- 2 *the following new item:*

*“Sec. 711. School security coordinating council.”.*
