A BILL

To amend title 54, United States Code, to establish within
the National Park Service the African American Civil
Rights Network, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “African American Civil*
5 *Rights Network Act of 2017”.*

6 **SEC. 2. PURPOSES.**

7 *The purposes of this Act are—*

8 (1) *to recognize—*

9 (A) *the importance of the African American*
10 *civil rights movement; and*

11 (B) *the sacrifices made by the people who*
12 *fought against discrimination and segregation;*
13 *and*

14 (2) *to authorize the National Park Service to co-*
15 *ordinate and facilitate Federal and non-Federal ac-*
16 *tivities to commemorate, honor, and interpret—*

17 (A) *the history of the African American*
18 *civil rights movement;*

19 (B) *the significance of the civil rights move-*
20 *ment as a crucial element in the evolution of the*
21 *Civil Rights Act of 1964 (42 U.S.C. 2000a et*
22 *seq.); and*

23 (C) *the relevance of the African American*
24 *civil rights movement in fostering the spirit of*
25 *social justice and national reconciliation.*

1 **SEC. 3. U.S. CIVIL RIGHTS NETWORK PROGRAM.**

2 (a) *IN GENERAL.*—Subdivision 1 of Division B of sub-
3 title III of title 54, United States Code, is amended by in-
4 serting after chapter 3083 the following:

5 **“CHAPTER 3084—U.S. CIVIL RIGHTS**
6 **NETWORK**

“308401. *Definition of network.*

“308402. *U.S. Civil Rights Network.*

“308403. *Cooperative agreements and memoranda of understanding.*

7 **“§ 308401. Definition of network**

8 *“In this chapter, the term ‘Network’ means the African*
9 *American Civil Rights Network established under section*
10 *308402(a).*

11 **“§ 308402. U.S. Civil Rights Network**

12 *“(a) IN GENERAL.—The Secretary shall establish,*
13 *within the Service, a program to be known as the ‘U.S.*
14 *Civil Rights Network’.*

15 *“(b) DUTIES OF SECRETARY.—In carrying out the*
16 *Network, the Secretary shall—*

17 *“(1) review studies and reports to complement*
18 *and not duplicate studies of the historical importance*
19 *of the African American civil rights movement that*
20 *may be underway or completed, such as the Civil*
21 *Rights Framework Study;*

22 *“(2) produce and disseminate appropriate edu-*
23 *cational materials relating to the African American*

1 *civil rights movement, such as handbooks, maps, in-*
2 *terpretive guides, or electronic information;*

3 “(3) *enter into appropriate cooperative agree-*
4 *ments and memoranda of understanding to provide*
5 *technical assistance under subsection (c); and*

6 “(4)(A) *create and adopt an official, uniform*
7 *symbol or device for the Network; and*

8 “(B) *issue regulations for the use of the symbol*
9 *or device adopted under subparagraph (A).*

10 “(c) *ELEMENTS.—The Network shall encompass the*
11 *following elements:*

12 “(1) *All units and programs of the Service that*
13 *are determined by the Secretary to relate to the Afri-*
14 *can American civil rights movement during the pe-*
15 *riod from 1939 through 1968.*

16 “(2) *With the consent of the property owner,*
17 *other Federal, State, local, and privately owned prop-*
18 *erties that—*

19 “(A) *relate to the African American civil*
20 *rights movement;*

21 “(B) *have a verifiable connection to the Af-*
22 *rican American civil rights movement; and*

23 “(C) *are included in, or determined by the*
24 *Secretary to be eligible for inclusion in, the Na-*
25 *tional Register of Historic Places.*

1 “(3) *Other governmental and nongovernmental*
 2 *facilities and programs of an educational, research, or*
 3 *interpretive nature that are directly related to the Af-*
 4 *rican American civil rights movement.*

5 “**§ 308403. Cooperative agreements and memoranda of**
 6 ***understanding***”

7 “*To achieve the purposes of this chapter and to ensure*
 8 *effective coordination of the Federal and non-Federal ele-*
 9 *ments of the Network described in section 308402(c) with*
 10 *System units and programs of the Service, the Secretary*
 11 *may enter into cooperative agreements and memoranda of*
 12 *understanding with, and provide technical assistance to the*
 13 *heads of other Federal agencies, States, units of local gov-*
 14 *ernment, regional governmental bodies, and private enti-*
 15 *ties.*”

16 (b) *CLERICAL AMENDMENT.*—*The table of chapters for*
 17 *title 54, United States Code, is amended by inserting after*
 18 *the item relating to chapter 3083 the following:*
