A BILL

To amend title 38, United States Code, to improve the enrollment of veterans in certain courses of education, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- This Act may be cited as the "Veterans Education
- 5 Priority Enrollment Act of 2017".

1 SEC. 2. PRIORITY ENROLLMENT FOR VETERANS IN CER-

- 2 TAIN COURSES OF EDUCATION.
- 3 (a) IN GENERAL.—Chapter 36 of title 38, United
- 4 States Code, is amended by inserting after section 3680A
- 5 the following new section:

6 "§ 3680B. Priority enrollment in certain courses

- 7 "(a) In General.—With respect to an educational
- 8 assistance program provided for in chapter 30, 31, 32, 33,
- 9 or 35 of this title or chapter 1606 or 1607 of title 10,
- 10 if an educational institution administers a priority enroll-
- 11 ment system that allows certain students to enroll in
- 12 courses earlier than other students, the Secretary or a
- 13 State approving agency may not approve a program of
- 14 education offered by such institution unless such institu-
- 15 tion allows a covered individual to enroll in courses at the
- 16 earliest possible time pursuant to such priority enrollment
- 17 system.
- 18 "(b) Covered Individual Defined.—In this sec-
- 19 tion, the term 'covered individual' means an individual
- 20 using educational assistance under chapter 30, 31, 32, 33,
- 21 or 35 of this title or chapter 1606 or 1607 of title 10,
- 22 including—
- 23 "(1) a veteran;
- 24 "(2) a member of the Armed Forces serving on
- active duty or a member of a reserve component (in-
- 26 cluding the National Guard);

- 1 "(3) a dependent to whom such assistance has 2 been transferred pursuant to section 3319 of this 3 title; and
- 4 "(4) any other individual using such assist-
- 5 ance.".
- 6 (b) CLERICAL AMENDMENT.—The table of sections
- 7 at the beginning of such chapter is amended by inserting
- 8 after the item relating to section 3680A the following new
- 9 item:

"3680B. Priority enrollment in certain courses.".
