## A BILL

To amend title 18, United States Code, to prohibit the  
unlawful disposal of fetal remains, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Protecting the Dignity  
5 of Unborn Children Act of 2019”.

1 **SEC. 2. PROHIBITING UNLAWFUL DISPOSAL OF FETAL RE-**  
 2 **MAINS.**

3 Part I of title 18, United States Code, is amended  
 4 by adding at the end the following:

5 **“CHAPTER 125—UNLAWFUL DISPOSAL OF**  
 6 **FETAL REMAINS**

7 **“SEC. 2741. UNLAWFUL DISPOSAL OF FETAL REMAINS.**

8 “(a) IN GENERAL.—Whoever recklessly disposes of  
 9 or abandons fetal remains in a landfill or in any of the  
 10 navigable waters of the United States shall be imprisoned  
 11 not more than 3 years or fined under this title, or both.

12 “(b) RULE OF CONSTRUCTION.—Nothing in this sec-  
 13 tion shall be construed to authorize the prosecution of any  
 14 woman for the disposal of the remains of her unborn child.

15 “(c) DEFINITIONS.—In this section:

16 “(1) FETAL REMAINS.—The term ‘fetal re-  
 17 mains’ means any part of a human fetus that is de-  
 18 ceased by reason of an abortion, but does not in-  
 19 clude any such part that has been cremated.

20 “(2) LANDFILL.—The term ‘landfill’ means a  
 21 sanitary landfill, as such term is defined in section  
 22 1004(26) of the Solid Waste Disposal Act.

23 “(3) NAVIGABLE WATERS.—The term ‘navi-  
 24 gable waters’ has the meaning given such term in

1       section 502(7) of the Federal Water Pollution Con-  
2       trol Act.”.
